### General Business, Board Reports

- Board Members shared information regarding their recent site visits, committee reports and other community related activities.

### Personnel

- The Board approved:
  - Certificated and Classified employment reports
  - Payment of stipends
  - Proposed new job descriptions: Principal, Preschool (formerly Preschool Coordinator); and Independent Study Teacher
- The AB 1200 disclosure was reviewed for the base salary increases to all MEA & CSEA bargaining unit members; confidential employees; certificated and classified management employees; Assistant Superintendents; and Superintendent along with the sources of funding for the proposed payments. The Disclosure of Collective Bargaining Unit Agreement was submitted to the Ventura County Office of Education for the required ten-day review and has been accepted.
- The Board approved the tentative agreement between the District and the California School Employees Association, Chapter 498 for the 2024-2025 school year, including an on-schedule increase of 2% to the classified salary schedule, retroactive March 1, 2025 and classified salary schedule adjustments
- The Board approved the tentative agreement between the District and the Moorpark Educators Association, including an on-schedule increase of 2% to the certificated and counselor salary schedules, including anniversary increments, retroactive to March 1, 2025 and modifications to Article 5 (Working Hours & Calendar); Article 8 (Safety); Article 10 (Evaluations); and Article 13 (Leaves)
- The Board approved an on-schedule increase of 2% to the confidential salary schedule, retroactive to March 1, 2025.
- The Board approved an on-schedule increase of 2% to the classified and certificated management salary schedules, retroactive to March 1, 2025.
- The Board approved the Fourth Amendment to the Assistant Superintendents Employment Contracts for: Dr. M. Cathrine Lasure and Dr. Jane Wagmeister and the First Amendment to the Assistant Superintendent Employment Contract for Juan Pablo Herrera
- The Board approved the Sixth Amendment to the employment agreement with Kelli J. Hays, Ed.D.
- The Board approved the proposed revisions to the following Salary Schedules, effective July 1, 2025:
