#### NATURE AND SCOPE OF JOB:

The Technology Integration Program Supervisor provides technical support in the implementation and evaluation of all activities related to Accountability, under the direction of the Chief Accountability Officer. The Technology Integration Program Supervisor shall assist with coordinating the development, integration, and implementation of the various systems and processes critical to the success of the new Principal and Teacher Evaluation System. This position works collaboratively with the administrative and instructional staff and communicates effectively with parents, members of the community, and colleagues.

### **QUALIFICATIONS:**

The Technology Integration Program Supervisor shall:

- 1. Have a minimum of ten (10) years of experience in program planning of mandated educational programs.
- 2. Have at least eight (8) years of experience in PC based software/hardware and system integration.
- 3. Have knowledge of RTTT3, EE4NJ and new Principal/Teacher Evaluation Systems that integrate student achievement.
- 4. Be able to train district administrators in the use of teacher observation system inclusive of IPAD use and/or other mobile device with internet access.
- 5. Be able to utilize online data collection tools to produce reports, store data for future use, and aggregate data as needed.
- 6. Have knowledge of principal/teacher evaluation issues, processes, and tools.
- 7. Have knowledge of assessment-related statistical concepts, including percentiles, SGP, NCE, median, and student growth data etc.
- 8. Have the ability to retrieve information from employee system, student information system, assessment software, and integrate for reporting purposes.
- 9. Demonstrate mastery of Microsoft Excel with ability to create advanced conditional look-up formulas.
- 10. Demonstrate excellent problem-solving, analytical, organizational, and human relations skill, as well as the ability to motivate others.
- 11. Demonstrate the ability to implement and coordinate long term projects.

- 12. Demonstrate the ability to use computers for word processing, data management, information retrieval, visual and audio presentations, and telecommunications.
- 13. Protect confidentiality of records and information gained as part of exercising professional duties and use discretion in sharing such information within legal confines.
- 14. Hold other such credentials or alternatives to the above found to be acceptable equivalents.
- 15. Have excellent organizational, interpersonal, and communication skills.
- 16. Have ability to handle and prioritize multiple tasks.
- 17. Have ability to analyze problems, as well as recommend and implement workable solutions.
- 18. Demonstrate excellent verbal and written communication skills, including the ability to make presentations.

- 20. Perform such other job responsibilities as may be assigned by the Chief Accountability Officer.
- 21. Provide proof of U.S. citizenship or legal resident alien status by completing Federal Form I-9 in compliance with the Immigration Reform and Control Act of 1986.
- 22. Provide evidence that a criminal record history check has been conducted and clearance has been given by the Department of Education. During the initial six-month period, provide a sworn statement that there have not been any convictions of a crime or a disorderly person's offense in accordance with 18A:6-7.1.
- 23. Provide evidence that health is adequate to fulfill the job functions and responsibilities with reasonable accommodation pursuant to 42 U.S.C. 12101 and in accordance with N.J.A.C. 6:3-4A.4.
- 24. Pass the state required Mantoux Intradermal Tuberculin Test as required by N.J.A.C. 6:3-4A.4.
- 25. Meet such alternates to the above qualifications as the Superintendent may deem appropriate, acceptable and legal.

- 2. Serve as a technical resource to administrators and staff for the purpose of providing information and/or advice regarding teacher observation system and web-based software/tools.
- 3. Facilitate training and professional development for district staff as needed for the purpose of assisting in the proper, efficient, and effective use of teacher observation software.
- 4. Retrieve information from NJSMART, the employee system, student information system, assessment software, and integrate for reporting purposes.
- 5. Support users through technology-based applications for "cloud" access.

- 6. Assist in the preparation and submission of applications for grant funding and other assistance, relevant to the District's Principal and Teacher Evaluation Initiative, from public and/or private sources.
- 7. Assist in the preparation of reports and course roster data collection and auditing procedures inclusive of transferring student database information to and from NJSMART and the student information system.
- 8. Retrieve information from employee human resource/financial systems, student information systems, assessment software, and integrate for reporting purposes inclusive of conducting periodic auditing, data integration, and verification.
- 9. Develop spreadsheets and databases as required.
- 10. Prepare presentations using PowerPoint or equivalent programs and department reports as required.
- 11. Participate in presenting in-service workshops, seminars, and orientations.
- 12. Make recommendations and manage the implementation of a continual cycle of process and procedure improvement, to enhance efficient and effective communication throughout the department.
- 13. Write reports and complete mandated documentation to meet the various Federal, State, and Local requirements as needed.
- 14. Communicate with administrative and supervisory staff regularly about assigned programs and services within the Accountability department.
- 15. Promote a close working relationship with Assistant Superintendents for Schools, School Leadership Teams and the Chief Accountability Officer to ensure information exchange, coordination of efforts, and support for the decision-making process within all levels of the school organization.
