QUALIFICATIONS:

The Supervisor of Science shall:

- 1. Hold a New Jersey administrative certificate in accordance with the requirements of N.J.S.A 18A:27.1 et seq., and N.J.A.C Title 6 Chapter 11, with a supervisor endorsement (N.J.A.) 6:11-9.3 and 9.6). Hold a standard teaching certificate in Science.
- 2. Hold a Master's degree from an accredited institution (College or University).
- 3. Have a minimum of five years teaching/administrative experience.
- 4. Hold and maintain a valid driver's license with no serious violations.
- 5. Have excellent administrative and/or teaching experience and work with students.
- 6. Demonstrate excellent organizational skills and the ability to motivate people.
- 7. Have excellent integrity and demonstrate good moral character and initiative.
- 8. Demonstrate knowledge and understanding of curriculum development and program evaluation, child growth and development, effective instructional strategies, classroom management, learning assessment and diagnosis, and research relating to learning.
- 9. Exhibit a personality that demonstrates enthusiasm and interpersonal skills to relate well with students, staff, administration, parents, and the community.
