Dr. Ronni Zagora, Assistant Superintendent, presented the proposed Family, Career, and Community Leaders of America program. It would include curriculum and after-school activities, with a focus on leadership, skills, competitions, and community service. Stipend for the FY2025-2026 program sponsor would be Column I, Step 1 at \$450.

Board members asked about transportation and other costs. The program will start as an in-house activity. Additional costs may come as the program grows.

Approve career technical education and qualify for a career pathway for DESE funds. There would be no minimum enrollment. Program would be open to students in grades 9-12. If desired, students could participate all four years. BSD would participate in local competitions.
