NATURE AND SCOPE OF JOB:

The School Based Therapist/Counselor delivers individual and group therapy to students. The clinician will be responsible for individual, parent/student, family and group services, complete assessments on identified students, monitoring student performance, consulting with the instructional staff to assist them in providing strategies for student social and personal growth, coordinating services for and communications with a student's family and other social service resource and provide consultation and professional development programs to staff. In addition, school-based therapists will provide outreach, educational and consultative services to the community, as well as conduct risk-assessments. The School Based Counselor is a part of the therapeutic team and will provide quality services to our students while ensuring the maintenance of standards for compliance with regulations and licensure. This Therapist will comply with school district administrative procedures.

QUALIFICATIONS:

The School-Based Therapist/Counselor shall:

- 1. Hold a valid New Jersey educational services certificate in accordance with the requirements of N.J.S.A. 18A:27.1 et seq., and N.J.A.C. Title 6 Chapter 11 with a School-Based Therapist/Counselor endorsement (N.J.A.C. 6:11-11.8) and other appropriate endorsement(s) in accordance with the requirements of N.J.A.C. 6:11-10.1 et seq.
- 2. Hold and maintain a valid driver's license with no serious violations.
- 3. Have excellent integrity and demonstrate good moral character and initiative.
- 4. Have experience in teaching and working with adolescents in an alternative school setting.
- 5. Demonstrate knowledge and understanding of child growth and development, community social service resources, and current social work issues.
- 6. Exhibit a personality that demonstrates enthusiasm and the interpersonal skills to relate well with students, staff, administration, parents, and the community.

- 7. Demonstrate the ability to communicate effectively in English, both orally and in writing, using proper grammar and vocabulary.

- 9. Provide proof of U. S. citizenship or legal resident alien status by completing Federal Form I-9 in compliance with the Immigration Reform and Control Act of 1986.

EMPLOYMENT TERMS:

The School-Based Therapist/Counselor shall be employed under the following terms:

- 1. Work year of ten months.
- 2. Salary or hourly wage, benefits, and leave time as specified in the Collective Bargaining Agreement.
- 3. Conditions established by all laws and codes of the State, and all policies, rules, and regulations established by the Board of Education (N.J.S.A. 18A:27-4 et seq.).

JOB FUNCTIONS AND RESPONSIBILITIES:

The School-Based Therapist/Counselor shall:

- 1. Provide the training and the tools that will enable parents to understand and meet their child's social and emotional needs.
- 2. Individual therapy with students
- 3. Therapeutic Groups sessions with students experiencing behavior or therapeutic issues
- 4. Classroom observations of students:
- 5. Weekly communication with parents and/or guardians
- 6. Complete clinical documentation
- 7. Consult with school personnel on strategies for working with students including behavioral and resiliency based interventions;
- 8. Create treatment goals, contribute, where appropriate, in conjunction with Child Study Team, in prepare behavior contracts, monitor student's progress, and write progress reports;
- 9. Complete required written reports such as: progress notes and summaries.
- 10. May facilitate learning experiences for school staff members on resiliency, behavior and classroom management, specialized treatment topics, or other learning needs as identified by school personnel.
- 11. Collaboration with community agencies to develop cooperative and positive relationships.
- 12. Work as a positive team member supporting the team's mission and goals, consistently working in a trusting and cooperative manner with fellow team members and supporting the team's common operating approach.
- 13. Accepts professional responsibility and serves as a role model for positive, pro-social behavior; modeling respect, responsibility, integrity, empathy, impulse control, emotional self-awareness, and professional boundaries.
- 14. Provide on-going communication regarding therapeutic strategies, interventions, case needs/concerns
- 15. Coordinate with affiliated service providers to identify community supports and promote overall continuity in care.

JOB FUNCTIONS AND RESPONSIBILITIES:

The School-Based Therapist/Counselor shall:

- 16. Attend mandatory monthly staff meetings and any other assigned in-services and / or training's.
- 17. Perform independently other duties as assigned.
- 18. Completes weekly communication with the parents and/or guardians of the students.
- 19. The School Based Counselor will complete documentation of all services.
- 20. Incorporate principles of trauma informed care in all areas of service delivery.
- 21. Assume leadership and cooperative roles in identifying and working with students with social problems and conditions that may interfere with effective learning.
- 22. Serve as the school liaison to all community agencies by consulting and collaborating regularly with school personnel, social agencies, and other community resources to establish and provide coordinated social services to students and families.
- 23. Attend juvenile court, probation and/or the Division of Youth and Family Services (DYFS) hearings, when requested, as a representative of the school.
- 24. Visit pupil homes when appropriate or upon request of the principal or supervisor.
- 25. Attend required staff meetings and serve, as appropriate, on staff committees.
- 26. Participate in faculty, school, parent, and community meetings and programs, sharing observations, issues and resources available.
- 27. Conduct or provide social services related staff development sessions for staff members and educational programs for parents.
- 28. Complete in a timely fashion all records and reports as required by law and regulation or requested by supervisors.
- 29. Notify immediately appropriate personnel of any evidence of substance abuse, child abuse, child neglect, severe medical or social conditions, potential suicide, or individuals appearing to be under the influence of alcohol, controlled substances, or anabolic steroids.
- 30. Continue to grow professionally through collaboration with colleagues and professional growth experiences. Complete the required 100 clock hours of State-approved continuing professional development every five years in accordance with State and district procedures, as specified in the Professional Improvement Plan (N.J.A.C. 6:11-13).
