NATURE AND SCOPE OF JOB:

The Classroom Instructional Assistant provides assistance to the teacher in any and all tasks regarded as necessary in the conduct of a class both in and outside of the classroom and school building.

QUALIFICATIONS:

The Classroom Instructional Assistant shall:

- 1. Have a minimum of sixty (60) undergraduate college credits.
- 2. Hold a valid driver's license with no serious violations.
- 3. Have excellent integrity and demonstrate good moral character and initiative.
- 4. Exhibit a personality that demonstrates excellent interpersonal skills to relate well with students, staff, administration, parents, and the community.
- 5. Have excellent organizational skills.
- 6. Demonstrate the ability to communicate effectively in English, both orally and in writing, using proper grammar and vocabulary.
- 7. Provide proof of U. S. citizenship or legal resident alien status by completing Federal Form I-9 in compliance with the Immigration Reform and Control Act of 1986.
- 8. Provide evidence that a criminal record history check has been conducted and clearance has been given by the Department of Education. During the initial six month period provide a sworn statement that the individual has not been convicted of a crime or a disorderly person's offense in accordance with 18A:6-7.1.
- 9. Provide evidence that health is adequate to fulfill the job functions and responsibilities with reasonable accommodation pursuant to 42 U.S.C. 12101 and in accordance with N.J.A.C. 6:3-4A-4.
- 10. Pass the State required Mantoux Intradermal Tuberculin Test as required by N.J.A.C. 6:3-4A-4.

- 2. Assist the teacher in preparation of materials for class and pupil use.
- 3. Assist the teacher in clerical work.
- 4. Assist the teacher in supervision of children in all aspects requested by administration.
- 5. Perform other duties as approved by the Board of Education.
- 6. Serve as a role model for students and staff in demonstrating positive attitudes, appropriate attire and grooming, and effective work ethic.

- 7. Participate in appropriate in-service and workshop programs and attend any required meetings.
- 8. Display ethical behavior in working with students, parents, school personnel, and outside agencies associated with the school.
- 9. Protect confidentiality of records and information gained as part of exercising professional duties and use discretion in sharing such information within legal confines.
- 10. Adhere to New Jersey school law, State Board of Education rules and regulations, Board of Education policies and regulations, and school regulations and procedures.
