NATURE AND SCOPE OF JOB:

The Glazier under direction performs skilled work in the installation of glass or similar materials in windows and skylights of buildings and does other related duties.

QUALIFICATIONS:

The Glazier shall:

- 1. Hold a high school diploma or equivalent.
- 2. Hold and maintain a valid driver's license with no serious violations.
- 3. Have previous experience as a glazier.
- 4. Have excellent integrity and demonstrate good moral character and initiative.
- 5. Exhibit a personality that demonstrates interpersonal skills to relate well with students, staff, administration, parents, and the community.
- 6. Demonstrate the ability to communicate effectively in English, both orally and in writing, using proper grammar and vocabulary.
- 7. Provide proof of U. S. citizenship or legal resident alien status by completing Federal Form I-9 in compliance with the Immigration Reform and Control Act of 1986.
- 8. Provide evidence that a criminal record history check has been conducted and clearance has been given by the Department of Education. During the initial six month period provide a sworn statement that the individual has not been convicted of a crime or a disorderly persons offense in accordance with 18A:6-7.1.
- 9. Provide evidence that health is adequate to fulfill the job functions and responsibilities, with reasonable accommodation pursuant to 42 U.S.C. 12101 and in accordance with N.J.A.C. 6:3-4A-4.
- 10. Pass the State required Mantoux Intradermal Tuberculin Test as required by N.J.A.C. 6:3-4A-4.

JOB FUNCTIONS AND RESPONSIBILITIES:

The Glazier shall:

- 1. Cut glass or similar material to size for various installations.
- 2. Scrape putty from frames.
- 3. Set glass in metal or wooden sash with glazier's points or metal clips.
- 4. Apply putty.
- 5. Remove caps from skylights and sets in new glass after preparing bed of putty.
- 6. Putty and replace caps.
- 7. Cut and set window or skylight glass.

- 8. Cement glass panes or similar materials into sash with putty and putty knife.
- 9. Fasten by clips into puttyless steel skylight sash.
- 10. Cut, fit, and fasten glass or similar material into doors.
- 11. Cut desired size part, using straightedge and glasscutter.
- 12. Drive glazier's points into frame to hold it in place and press and smooth colored putty into joint, or nail strips of molding in place.
- 13. Use computers and/or electronic equipment to fulfill job functions.
- 14. Serve as a role model for students and staff in demonstrating positive attitudes, appropriate attire and grooming, and an effective work ethic.
- 15. Protect confidentiality of records and information about staff, and use discretion when sharing any such information within legal confines.
