The Upper Adams School District (UASD) recognizes that with an educational instructional device, there is a need to protect the investment by both the District, the student, and the parent/guardian. The parent/guardian has the option to purchase a protection plan or to waive the protection plan when the device is issued to their student. As the parent/guardian you will need to make your choice at the bottom of this form, sign the document, attach payment and return the information to your student's building office. The protection plan covers the district issued device only. The loss or damage to the cord, charger, or Logitech Crayon are the responsibility of the parent/ guardian.

The device, which is the property of UASD, will remain in possession of the student throughout the designated school year. In the event of termination of enrollment for any reason, the device must-be returned in the same condition it was received. Failure to return a device may result in charging the parent/guardian full price for replacement.

Technology Device Protection Plan

The Technology Device Protection Plan is available for students and parents/guardians to cover the device's replacement in the event of damage, loss or theft. The annual, non-refundable protection plan cost is as follows:

Grades 4-6	\$20.00 PER SCHOOL YEAR
Grades 7-12	\$30.00 PER SCHOOL YEAR

Waived Coverage

If parents/guardians waive the Technology Device Protection Plan, they accept full responsibility for any loss, theft or damage to the device and accessories while issued to their student. Applicable fees/payment must be made prior to repairs or replacement being completed to the original issued device. The replacement cost must be provided before a loaner device is assigned to your student. If a loaner device is returned damaged, all applicable fees will be the responsibility of the parent/guardian.

The estimated cost of repair or replacement without the protection plan:

iPad (Grades 7-12):

- Cracked glass only service - \$199.00
- Charger port service - \$159.00
- Replacement Logitech Crayon - \$50.00
- Replacement of iPad - \$569.00
- Replacement of Case – \$129.00

What is a device protection program?

The device protection plan is offered to parents/guardians of UASD students. The protection plan is there for those unexpected accidents that can happen at any time. It provides peace of mind that the student’s device may be covered for damages should they occur. You will have the opportunity to purchase the device protection plan annually at the beginning of each school year.

What is covered with a device protection plan?

Your student’s device will be fully covered for any accidental damage that occurs. The protection plan is strictly for accidental damage, any direct, purposeful damage will not be covered and you will be responsible for the repair or replacement costs associated with that incident. The protection plan is for the main device only. Accessories such as charging cords, charging adapters, and Logitech Crayons are not covered. The estimated cost for charging accessories is as follows:

- Logitech Rugged Combo 4 Case - \$129.00
- 1m cable - \$19.99
- 20w brick - \$19.99
- Logitech Crayon - \$50.00
- USB-C to 3.5 MM Headphone Adapter - \$9.00

Returning the device

Students will be required to return the device and charger at the end of each school year during a designated time period in the same condition as received. If applicable, an exception may be made for the return of the device. If a student withdraws from the district, they must return the district issued device prior to the last day of attendance. Failure to return a device may result in charging the parent/guardian full price for a replacement.
