# **Title I: Overview of Services**

## **Purpose:**

Title I is a federally funded program designed to help qualified students achieve proficiency on Ohio's challenging academic achievement standards. Our district offers a "building-wide" program of service from Kindergarten through Eighth Grade. Funding is determined by the percentage of students identified as low income based upon free and reduced lunch counts.

## **Service Model:**

The service model that is used is a combination of push-in and pull-out. The push-in service allows students to participate in the Title I program while remaining in the general education classroom; the Title I teacher/tutor goes into the classroom to provide extra support. Pull-out is moving the student to another classroom setting for small group or individual instruction. Both settings are supplemental to the district/state curriculum. The services provided are designed to provide students instruction based upon educational needs using research-based strategies and/or interventions.

## **Student Selection:**

Students who qualify for Title I are identified through a multi-criteria process. The buildings utilize multiple forms of data to determine the highest needs and routinely assess student progress to determine if adjustments are needed. The data assists with identification of who would benefit from push-in vs. pull-out service and programs.

## **Staff:**

***You have the right to know the professional qualifications of the Title I tutors who instruct your child:***

- Whether the Ohio Department of Education has licensed or qualified the teacher for grades and subjects he or she teaches
- Whether the Ohio Department of Education has decided that the teacher can teach in a classroom without being licensed or qualified under the state regulations because of special circumstances.
- The teacher's college major, whether the teacher has any advanced degree and, if so, the subject of the degree.
- Whether any teachers' aids or similar paraprofessionals provide services to your child and/ if they do, their qualifications.

## **Parent Involvement:**

The district has developed a Parent Involvement Policy that is listed on the district website under Title I & Federal Programs. Title I requires that there is an annual meeting to review and disseminate information about the program. Our district does this during open houses, PTA meeting, and Title I nights. We ask parents at these events to complete a Title I Survey that is used to evaluate the strengths and weaknesses of our services. Parents are given the rights to be involved in the decision making and planning of their child's education. If a parent so chooses to not allow their child to participate in a Title I related service outside of the classroom, they must do so in writing.

## **How is my child identified as a student who needs Title I services?**

The Struthers City Schools utilizes multiple data points to determine what students qualify for additional Title I services.

### **English Language Arts/Reading:**

- DRA (Developmental Reading Assessment) is used to identify their reading level and comprehension
- Classroom Observations
- Grades and Assessments within class
- Spelling Inventories to determine spelling levels
- KRA (Kindergarten Readiness Assessment)
- Ohio OST Assessment Results (Grades 3-8)

### **Mathematics**

- Math Diagnostic Assessments
- Ohio OST Assessment Results (Grades 3-8)
- Classroom Observations
- Grades and Assessments within class
