It is ***the parent/guardian(s)*** responsibility to have the student(s) at the designated **AM bus pick-up** by the designated time and it is ***the parent/guardian(s)*** responsibility to be at the designated **PM bus drop-off**.

If your child(ren) **will not** be at the designated bus stop, please contact the bus service by 5:30 a.m. for morning pick-ups and by 12:00 p.m. for afternoon drop-offs.

- *If your student(s) is a **NO SHOW** at the AM pick-up time, the bus driver will wait for approximately 5 minutes. If your student(s) is not there by then, bus driver will leave and it will be your responsibility to get your student(s) to school.*
- *It will be your responsibility to contact the bus service before 12:00 p.m. for afternoon school drop-off. If they do not hear from you on a no show day, they will not drop-off student(s).*
- *Student(s) is responsible for any and all make up work.*
- *If you know you will be dropping-off or picking-up student(s) for appointments etc., please call the bus service.*

Consequences of NO CALL/SHOW:

1st time NO CALL/SHOW – Warning to parent/student by transportation personnel.

2nd time NO CALL/SHOW – Notice to homeless liaison, homeless liaison notifies parent of 2nd warning.

3rd time NO CALL/SHOW – Notice to homeless liaison, and suspension of bus services.

- Please note that these consequences can/will result in suspension of bus services under the McKinney-Vento Homeless Program.
- If you do not own a phone or have access to a phone and you know your child(ren) are not going to need bus services, **please send note with student(s) to leave in the front office so that they can notify the Transportation Department for either AM or PM.**

By signing this document, I understand all that is my parental responsibility and adhere to the contract between our transportation services and those of the district.
