HOW TO SUBMIT THE APPLICATION:

- Complete the application in its entirety (typed) except “name of scholarship” on the first page and save this copy to your desktop.
- Type in the “name of scholarship” on the first page for each scholarship for which you are applying.
- Print the completed application.
- Sign and date it under “certification” and have your parent sign and date it.
- Request two letters of recommendation sealed in envelopes from your references.
- Request a sealed official transcript from the counseling office.
- Bring your completed application and supporting documents to get an envelope and submission details.
- Put the completed/signed application in a manila envelope and put your name and the name of the scholarship on the envelope.
- Attach any additional information required by the individual scholarships.
- **Please make sure your application is complete. Incomplete applications will not be considered for the scholarships.**
