

**Summer Program Accident Waiver and Release of Liability Form**

I hereby give my permission for my child \_\_\_\_\_ to participate in the Marble Charter School Summer Program.

I understand that camp activities will include play and outdoor activities around and near the Marble Charter School grounds, hikes, and walks in the woods. There could be mosquitoes, bees, ticks, poison ivy, open bodies of water, and slippery and jagged surfaces, among other dangers and risks. I also understand that my child may travel by school bus to local sites and be visiting businesses, historical sites, and privately-owned spaces. I also understand that outdoor activities may occur in the hot sun and the rain. I agree to see that my child is appropriately attired for camp activities and provide insect repellent and sunscreen for my child to use. I will not expect the Marble Charter School Summer Program to give these items. I give Marble Charter School Summer Program staff members my permission to apply or assist with using the repellent and sunscreen I provide.

In illness, injury, or accident, I authorize any Marble Charter School Summer Program employee to act on my behalf. They may approve any non-emergency or emergency treatment and are authorized to sign any medical release or required form(s) on my behalf. In an emergency, I understand that a Marble Charter School Summer Program employee will notify me as soon as possible. I agree to pay all expenses incurred in my child's medical treatment.

I understand that the Marble Charter School Summer Program may, in its sole discretion, dismiss any camp participant for inappropriate, disrespectful, or dangerous behavior at any time. I understand that I will not receive a refund of camp fees for unattended days in this event. If my child breaks or damages any property due to their direct or indirect behavior, I agree to pay for its total repair or replacement.

I understand that the risks associated with camp activities could result in injury or death to my child. With this, I assume these risks and, knowing them, give my child permission to participate. I understand that the Marble Charter School Summer Program is not liable for any injuries due to camp activities, related risks, or the actions or omissions of Marble Charter School Summer Program staff members and volunteers.

I acknowledge this Accident Waiver and Release of Liability Form for the event holders, sponsors, and organizers of the activity in which my child may participate. They will use this form, and it will govern the actions and responsibilities at said activity.

In consideration of my application and permitting my child to participate in this activity, I agree to:

WAIVE, RELEASE, AND DISCHARGE from all liability, including but not limited to, liability arising from the negligence or fault of the Marble Charter School Summer Program, its employees, volunteers, or other persons released, for my child's death, disability, personal injury, property damage, property theft, or actions of any kind which may hereafter occur to them including their traveling to and from this activity. I INDEMNIFY, HOLD HARMLESS, AND PROMISE NOT TO SUE the Marble Charter School Summer Program, its employees, volunteers, or persons released from all liabilities or claims made as a result of participation in this activity, whether caused by the negligence of release or otherwise.

I understand that while participating in this activity, my child may be photographed. I agree to allow their photo, video, or film likeness to be used for any legitimate purpose by the activity holders, producers, sponsors, organizers, and assigns.

The Accident Waiver and Release of Liability Form shall be construed broadly to provide a release and waiver to the maximum extent permissible under applicable law. The Marble Charter School Summer Program, its director, employees, acting officially or otherwise, are now released from all claims, demands, actions, or causes of action on account of any injury to my child that may occur. This release binds my heirs, executors, administrators, or assigns.
