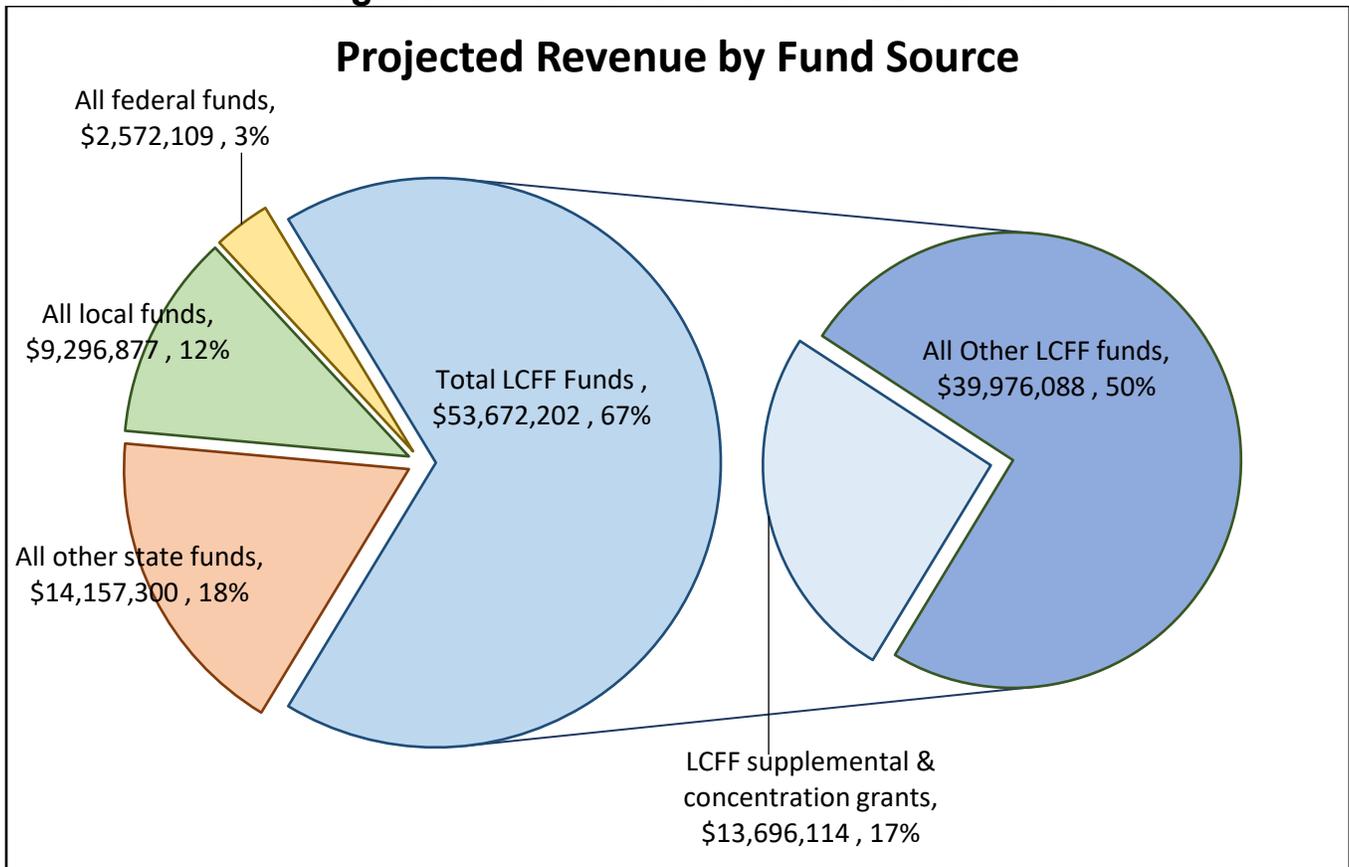

Budget Overview for the 2025-26 School Year

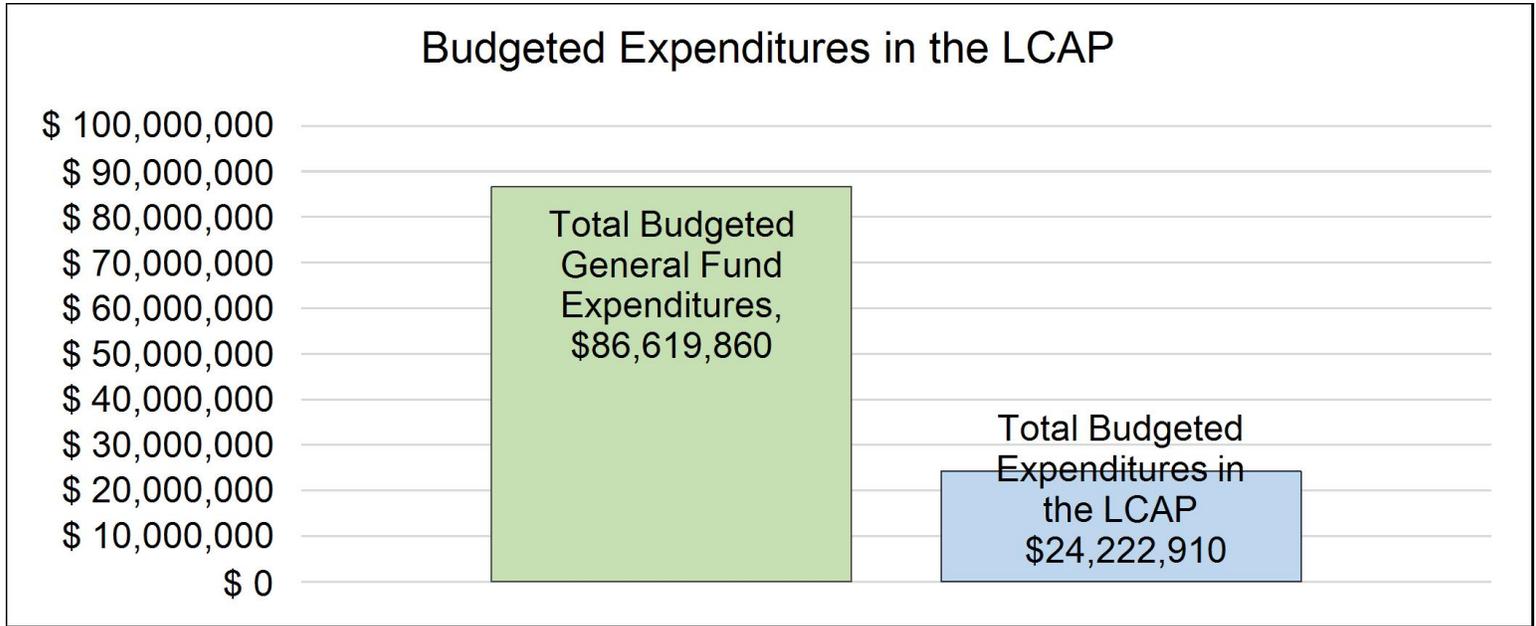


This chart shows the total general purpose revenue Buena Park Elementary School District expects to receive in the coming year from all sources.

The text description for the above chart is as follows: The total revenue projected for Buena Park Elementary School District is \$79,698,488, of which \$53,672,202 is Local Control Funding Formula (LCFF), \$14,157,300 is other state funds, \$9,296,877 is local funds, and \$2,572,109 is federal funds. Of the \$53,672,202 in LCFF Funds, \$13,696,114 is generated based on the enrollment of high needs students (foster youth, English learner, and low-income students).

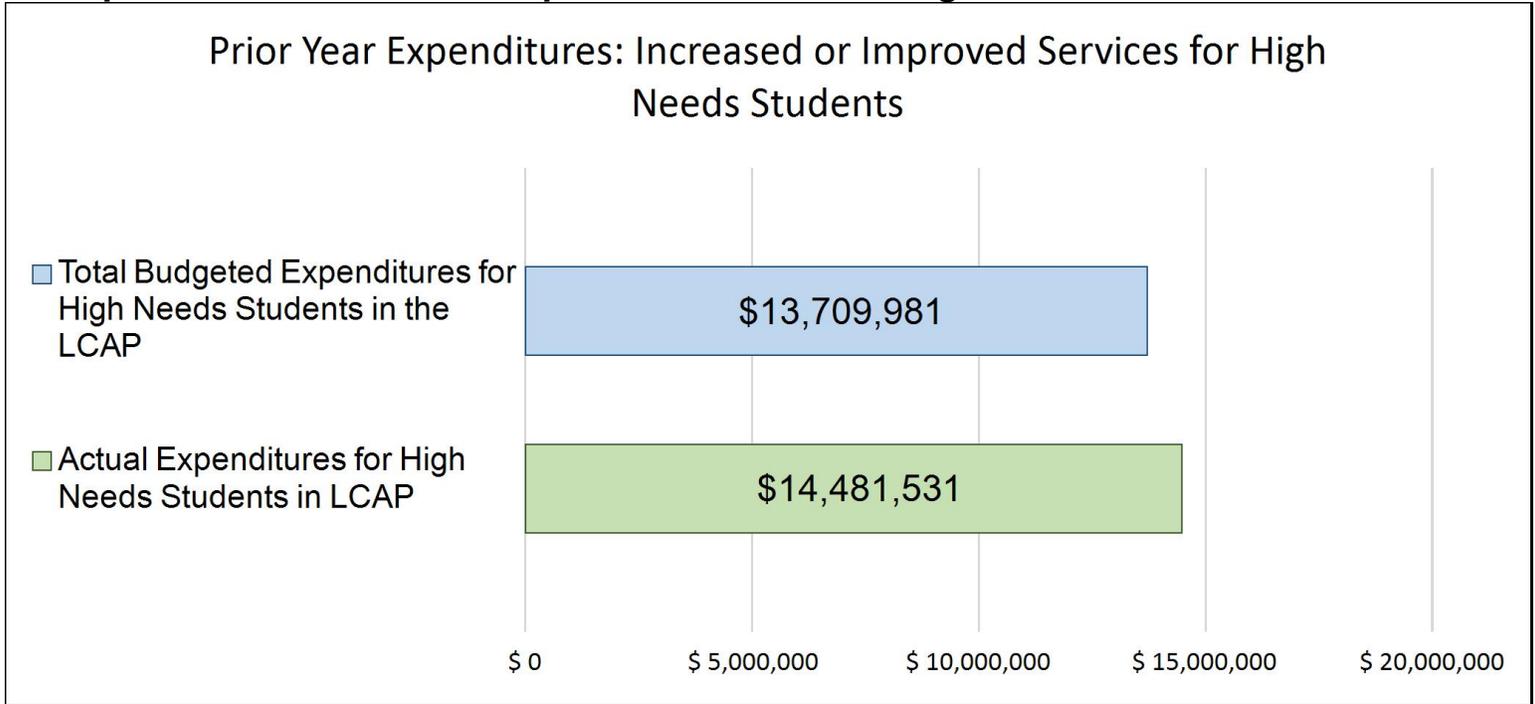

In addition, the overhead and administrative expenditures, such as utilities, property and liability insurance, payroll, and other contracted services and supplies, are required for the operations of the school and district.

Increased or Improved Services for High Needs Students in the LCAP for the 2025-26 School Year

In 2025-26, Buena Park Elementary School District is projecting it will receive \$13,696,114 based on the enrollment of foster youth, English learner, and low-income students. Plan Summary [2025-26]

General Information

Buena Park School District's mission is to "Inspire and Ignite all students to pursue high achievement; empowering them to follow their passions". BPSD consists of five PK through 5th-grade elementary schools, and two 6th through 8th-grade middle schools that are all identified as Title 1 schools. There are also preschool programs at the Buena Park Learning Center. We serve a diverse ethnic and socio-economic student population of approximately 3744 TK-8th students who speak over 30 primary languages at home, with a majority speaking Spanish, Korean, and Tagalog. Our children live in the diverse cities of Buena Park, Fullerton, La Mirada, Anaheim, and La Palma. Based on the most current data submitted and certified in CALPADS as of the first Wednesday of October for the 2024-2025 school year, indicate that approximately 27% of our students are English language learners, 80% are considered low-income, about 0.7% are foster youth, 8% are students experiencing homelessness, and 17% receive Special Education services.

Students in our district experience a rigorous and comprehensive curriculum taught through integrated, standards-based instruction and supported by technology. All students in grades PK through 8th have access to devices to support and individualize learning. We will strive to increase the number of students who meet or exceed grade-level standards as measured by state and local assessments. BPSD is proud of its over 535 committed staff members who strive to provide a safe and positive learning environment daily for students. Approximately 245 are certificated teachers and administrators. Another 290 are classified employees and management who support our goal of providing outstanding academic programs for students. Parents are supported by offering quality before and after-school programs through Kid Connection and the Expanded Learning Opportunities program (ELO-P) in partnerships with community organizations, and through our grant-funded After-School Education and Safety (ASES) program run in collaboration with Cal State Fullerton. These options will continue to grow through the ELOP funding to offer more enrichment opportunities and academic intervention. Parent engagement is always encouraged

and welcome at both site and district levels through many engaging events, workshops, and opportunities to participate both online and in-person (when safe to do so) in various advisory committees such as SSC, ELAC/DELAC, LCAP Steering Committee, and other groups.

Reflections: Annual Performance

A reflection on annual performance based on a review of the California School Dashboard (Dashboard) and local data.

A critical component of developing a responsive LCAP is the comprehensive analysis of both state and local data. As part of this process, the District conducted a thorough review of California School Dashboard indicators and local performance measures. This analysis identified notable progress in key areas while also highlighting persistent disparities among specific student groups. These findings informed the priorities and actions outlined in this plan.

The District met the "Standard Met" level for several local indicators, including appropriate teacher assignments, student access to standards-aligned instructional materials, and safe, well-maintained facilities. Additionally, the District met standards for Parent and Family Engagement and School Climate, as determined by the annual local climate survey measuring connectedness and safety.

Attendance, Chronic Absenteeism, and Suspensions

The District's 2023–24 attendance data indicates a 93.59% attendance rate as of March 2024. Subgroup attendance data highlights areas of both strength and concern:

Students with Disabilities: 91.86%

Homeless: 88.14%

Foster Youth: 94.88%

English Learners: 94.14%

African American: 88%

As of March 31, 2025, updated subgroup attendance rates show progress in most areas:

Students with Disabilities: 92.5%

Homeless: 89.6%

Foster Youth: 95.4%

English Learners: 94.4%

African American: 91.2%

While these rates reflect positive movement, the District aims to increase overall attendance to 96% and raise subgroup attendance rates by at least 3% annually.

In the area of Chronic Absenteeism, the 2023 Dashboard reported that 24.7% of students were chronically absent, placing the District in the Orange performance level. The 2024 Dashboard shows improvement, with 18.8% of students chronically absent, moving the District into the Yellow performance level.

Despite this improvement, several subgroups continue to experience high rates:

Homeless: 42.4%

African American: 34%

Students with Disabilities: 26.8%

English Learners: 18.6%

Socioeconomically Disadvantaged: 21.2%

Foster Youth: 27.3%

Long-Term English Learners: 19.4%

Schools with subgroup performance at the lowest level in chronic absenteeism include:

Buena Park Middle School: Homeless – 42.9%, African American – 48.1%

Arthur F. Corey: English Learners – 17.8%, SWD – 32.1%

Whitaker: ELL – 18.3%, SWD – 33.8%, Hispanic – 27.3%

Emery: ELL – 8.5%

Pendleton: ELL – 21.7%

The District will continue efforts to reduce chronic absenteeism by 3% annually across all subgroups and improve tiered systems of support, including family outreach, incentives, and partnerships.

In terms of suspensions, the District also showed improvement. The 2023 Dashboard showed 2.8% of students suspended at least once, while the 2024 Dashboard decreased to 2.0%, maintaining an Orange performance level.

Suspension rates by subgroup (2024):

African American: 3.4% (down from 7.2%)

Homeless: 3.2% (down from 5.8%)

English Learners: 2.4%

Students with Disabilities: 3.7%

Socioeconomically Disadvantaged: 3.2%

Long-Term English Learners: 7.3%

Foster Youth: 3.3%

Site-level data reflects some continued areas of concern:

Buena Park Middle School: Homeless – 8.3%, African American – 6.5%

Gordon H. Beatty Middle School: White – 13.9%

Although several student groups showed decreased suspension rates, African American and homeless students remain disproportionately impacted. In response, the District will continue its focus on restorative practices, trauma-informed strategies, and alternatives to suspension. These include expanded use of behavior intervention teams, site-level SEOCs (Student and Family Outreach Coordinators), and access to mental health services.

Academic Achievement and MTSS Implementation

CAASPP results in ELA and Math reflect continued growth:

ELA DFS: -25.2 (improved from -28.6)

Math DFS: -41.9 (improved from -45.6)

i-Ready Diagnostic (Winter 2024) showed positive gains:

Reading: 41% of students were Early/On/Above Grade Level

Math: 35% were Early/On/Above Grade Level

Notable subgroup gains include:

ELL Reading: 30% (+4%), Math: 22% (+6%)

SWD Math: 11% (+5%)

Socioeconomically Disadvantaged Math: 27% (+3%)

ELPAC results showed 65.4% of English Learners made annual progress—a 3.6% increase from the prior year. The reclassification rate also rose by 6.5 points, with 55.3% of eligible students reclassified in 2024–25 (up from 47.2%).

Supported by the Learning Recovery Emergency Block Grant (LREBG), Buena Park School District has expanded its Learning Recovery Program under Action 1.7 to address persistent performance gaps through a strengthened Multi-Tiered System of Supports (MTSS). These targeted supports are aligned with the District's CARE Pathway and are designed to ensure equitable access to high-quality instruction, address disproportionality, and improve student outcomes across all tiers of support. To address persistent performance gaps, the District has strengthened its Multi-Tiered System of Supports (MTSS), emphasizing targeted intervention across three tiers:

Tier 1: High-quality, standards-aligned instruction supported by instructional coaches focused on high-impact strategies.

Tier 2: Small-group, data-driven instructional support tailored to emerging student needs.

Tier 3: Intensive foundational literacy interventions provided by learning coaches for students performing two or more grade levels below.

As part of a comprehensive needs assessment, the MTSS Steering Committees conducted staff fishbowl discussions, stakeholder surveys, and analysis of student performance data, including i-Ready results. This process identified critical needs in foundational literacy at both Tier 1 and Tier 3 levels. In response, the District adopted new curriculum materials following a districtwide audit, prioritized foundational reading instruction, and provided all teachers with ongoing professional development. Teachers are supported with diagnostic tools and protected collaboration time to make informed instructional decisions. Through these targeted efforts, the District is committed to addressing disproportionality, improving outcomes for all students, and ensuring equitable access to high-quality education and support systems.

The overall district rate of chronic absenteeism declined by 1.4% across school sites, but Whitaker Elementary School has the lowest performance level on the 2023-24 California Dashboard.

In regard to the state core subjects of ELA/ELD and math, Dashboard indicators reveal that none of our schools are at the lowest performance level, showcasing math growth that merits celebration. However, there is still a need to focus attention on the specific needs of several subgroups. Indicators for our multilingual students (English learners) show that their progress in English proficiency has increased by 3.6%, which is higher than the state's progress rate. Indicators for ELA show that the number of multilingual learners who have recently reclassified increased by 6.5 points and are 39.8 points above grade level compared to English-only students, who maintained their level at 21.3 points above grade level. African American and White students are not only at a higher level than the state, but they increased by 12 points. In contrast, the district performance level of students experiencing homelessness and students with disabilities is at the lowest level.

The following are student groups within a school that received the lowest performance level for ELA:

Buena Park Middle School: English Language Learners, homeless

Pendleton Elementary School: English Language Learner, Students with Disabilities

Whitaker Elementary School: English Language Learners, Students with Disabilities, Hispanic, Low-income

In response to the low ELA performance levels, the District has thoughtfully revised its Multi-Tiered System of Supports (MTSS) to align with the California MTSS framework, emphasizing enhanced tier supports.

Reflections: Technical Assistance

Buena Park School District (BPSD) qualifies for Differentiated Assistance (DA) based on the following:

- In 2022–23, BPSD was identified for DA due to Chronic Absenteeism (Priority 5) and Suspension (Priority 6) rates among African American (AA) students. While this group showed improvement and is no longer eligible for DA in 2023–24, it remains under state monitoring.
- In 2023–24, BPSD is eligible for DA based on the performance of the Homeless (HOM) and Foster Youth (FY) student groups:
- Homeless students: Priority 4 (Academic Achievement in ELA/Math) and Priority 5 (Chronic Absenteeism)
- Foster Youth: Priority 5 (Chronic Absenteeism) and Priority 6 (Suspension)

The Buena Park School District continues to address the underlying and systemic challenges impacting student outcomes through DA. In collaboration with the Orange County Department of Education, BPSD is focused on refining systems and implementing targeted supports for our most vulnerable student groups—including African American students, foster youth, and students experiencing homelessness, who face disproportionate rates of chronic absenteeism and suspension.

As part of the Buena Park School District’s ongoing efforts to improve outcomes for all students, particularly those identified through Differentiated Assistance, the district is prioritizing the following focus areas:

- Analyzing data from all subgroups to ensure equitable access and support.
- Providing targeted academic support in ELA and Math through tiered interventions and focused instructional strategies.
- Increasing both emotional and cognitive engagement to reduce chronic absenteeism.
- Decreasing suspension rates while improving academic achievement.

Planned Outcomes in Partnership with the Orange County Office of Education

- Analyzing Data from All Subgroups: BPSD is committed to ongoing data analysis disaggregated by student subgroup across performance, attendance, and behavioral metrics. This allows the district to identify disparities, conduct root cause analyses, and develop targeted action plans that deliver equitable and responsive support.
- Decreasing Suspension While Increasing Academic Engagement: The district is relaunching Positive Behavioral Interventions and Supports (PBIS) to strengthen tiered behavior systems, promote a positive school climate, and proactively reduce suspension rates. Behavior response site and district teams were created and restorative justice practices, Social Emotional Learning (SEL) programs, and staff training in behavior management and de-escalation techniques were expanded. In addition training will be provided to address the underlying causes of behavior and build student capacity in emotional regulation and self-advocacy. In tandem, students will receive academic interventions and targeted small-group instruction to close learning gaps, increase engagement, and prevent disengagement.
- Decreasing Absenteeism through Tiered Interventions: Chronic absenteeism is addressed through a multi-faceted strategy that includes:
 - Tiered interventions and early warning systems
 - Incentives and outreach to remove logistical barriers
 - Culturally relevant enrichment opportunities to increase student and family connection

- Strengthening the Mentorship Program: BPSD will expand its mentorship program by connecting students with trained mentors who provide consistent academic and emotional support. The goal is to help students develop stronger school connections, increase motivation, and navigate school-related challenges effectively.

Monitoring Progress and Accountability

To ensure the effectiveness and sustainability of these strategies, the following systems will be implemented:

- Data Tracking System: A centralized platform will be used to monitor suspension and absenteeism trends, disaggregated by student subgroup, incident type, and intervention applied.
- Regular Data Analysis and Reporting: Periodic reports will be shared with site leadership teams, teachers, and parent groups to promote transparency, drive decision-making, and ensure shared accountability.
- Early Warning Indicators: A proactive system will flag students at risk of chronic absenteeism or repeated behavioral incidents by integrating academic, attendance, and behavioral data.
- Feedback Loops: Surveys, focus groups, and family forums will provide feedback from students, families, and staff to evaluate the effectiveness of current interventions and school climate.
- Success Metrics: Measurable goals will be established for each intervention, and progress will be reviewed regularly to inform adjustments and sustain improvements.
- Parent and Community Involvement: The district will continue to build parent partnerships through expanded outreach, workshops, and opportunities for shared leadership to support student well-being and learning outcomes.

Commitment to Access and Connectedness

The Buena Park School District, in close partnership with the Orange County Department of Education, is deeply committed to fostering an inclusive, engaging, and academically rigorous environment. Through these targeted actions, BPSD aims to reduce suspensions and chronic absenteeism—particularly for African American, Homeless, and Foster Youth students—while also improving academic achievement in ELA and Math. These efforts are designed to strengthen the systems that promote student belonging, academic success, and long-term well-being.

The Buena Park School District is eligible for Differentiated Assistance(DA) due to the increase in suspension rate and chronic absenteeism of our African American students based on the 2022-23 CA Dashboard Report. The DA is to address multifaceted challenges within the learning environment, aiming to foster a more equitable, engaging, and supportive learning community for all students, especially our students of color, who experience an increasing rate of chronic absenteeism and suspension. In partnership with the Orange County Office of Education, the district works to refine the systems and define specific supports and solutions that address the unique needs of our students of color and other students not represented by the mainstream. Focus areas include:

- Analyzing data from all subgroups to ensure equitable support.
- We are implementing strategies to increase both emotional and cognitive engagement to reduce absenteeism.
- Simultaneously decreasing suspension rates while boosting academic achievement.

The following is a summary of the planned outcomes from the DA work with our County partners:

1. Analyzing Data from All Subgroups: We focus on gathering and analyzing data across various demographic subgroups within the student population, including performance, attendance, and behavioral metrics. This analysis helps identify patterns and disparities, allowing for targeted interventions that address specific challenges and ensure equitable support for all students.
2. Decreasing Suspension while Increasing Academics: To boost student engagement across the District, expand the use of Universal Design for Learning (UDL) strategies. Additionally, provide academic tutoring and targeted instruction to enhance engagement further and prevent disengagement.
3. Decreasing Absenteeism with Tiered Interventions: Our approach to reducing absenteeism includes incentives for attendance, clear policies, support for logistical barriers, and outreach to families. Increasing student and family engagement through culturally relevant social opportunities is crucial to motivating regular attendance.
4. Decreasing Suspension Using Alternative Corrective Measures: With County support, we are committed to restorative justice as an alternative to traditional disciplinary measures. We will continue to train staff in behavior management techniques and implement SEL programs that address root causes. Our strategy includes behavior response teams and school counselors trained in de-escalating problematic behaviors and helping students develop emotional management and self-advocacy skills.
5. Mentorship Program: Elevate the current mentorship program to include experienced mentors working with students to build strong, supportive relationships. This program is designed to help students navigate school challenges, enhance their academic and social skills, and connect them more deeply with the school community.

By organizing our efforts across these focused areas, we aim to create a more supportive, engaging, and equitable learning environment for all students. To effectively monitor efforts aimed at reducing suspensions and chronic absenteeism, several strategies are being planned to be implemented to ensure continuous progress and timely interventions:

1. Data Tracking System: Establish a robust data management system to track and analyze suspension rates and absenteeism patterns regularly. This system should be able to disaggregate data by student demographics, reasons for absenteeism or suspensions, and interventions applied.
2. Regular Data analysis: Develop a schedule for regular reports that provide insights into trends and problem areas. These reports should be shared with school leaders, staff, and parent groups to ensure transparency and collective responsibility.
3. Early Warning Indicators: Utilize an early warning system that flags students at risk of becoming chronically absent or frequently suspended. Factors such as academic performance, attendance records, and behavioral reports should be integrated into this system.
4. Feedback Loops: Create mechanisms for receiving feedback from students, families, and teachers about the effectiveness of interventions and the overall school environment. This could be through surveys, focus groups, or community forums.
5. Success Metrics: Define clear, measurable outcomes for interventions aimed at reducing suspensions and absenteeism. Regularly review these metrics to gauge success and adjust strategies as necessary.
6. Parent and Community Involvement: Engage parents and community members in monitoring and support efforts. Their involvement can increase accountability and provide additional resources and support for students.

By employing these strategies, schools can maintain a vigilant and responsive approach to managing and reducing suspensions and chronic absenteeism, ensuring that interventions are effective and students receive the support they need to succeed.

The District's partnership with the Orange County Office of Education has moved the District toward our goal of creating a more inclusive, supportive, and engaging learning environment that fosters all students' academic success and well-being. Strengthening systems that foster connectedness for students will reduce suspensions and chronic absenteeism for our African American students and other student

subgroups.

The following is a summary of feedback provided directly by the LCAP Steering Committee comprised of multiple educational partners, including staff, parents (EO, English Learners, Low Socio-economic, Unique Needs), bargaining unit representatives from BPTA and CSEA in the areas of SEL, ELA/Math, Designated English language development, and other suggestions. In addition, advisory committee groups such DELAC gave input via surveys and feedback gathered during meetings. Feedback from our Director of Special Education, the SELPA Director, and parents of students with unique needs was also included.

- Focus academic supports on middle school.
- Target support for ELs, SwD, FY, and MV students.
- Use ELPI data and monitor reclassification, especially for 4th/5th-year ELs.
- Strengthen understanding of ELA standards in grades 3, 4, and 8.
- Support Early Childhood readiness and SEL skill development.
- Emphasize critical thinking in ELA/Math and support ELs with additional needs.

Feedback on Priority 5: Pupil Engagement

- Promote student voice (e.g., councils).
- Use culturally relevant materials.
- Encourage attendance with positive incentives.

Feedback on Priority 6: School Climate

- Expand SEL supports for ELs and SwD.
- Increase staff awareness of mental health resources.

In summary, feedback from our educational partners has guided the refinement and continuation of key initiatives that support student learning, engagement, and well-being. Their input reinforced the need for targeted academic interventions, instructional coaching, and site-specific professional development. As a result, we are maintaining support for collaborative teacher time, instructional materials, and professional learning focused on core content areas and student work analysis.

Educational partner input also underscored the importance of inclusive supports for early learners, English Learners, and students with disabilities, influencing our continued investment in instructional coaches, special education staff, and kindergarten supports. Enrichment programs such as Passion Projects, STEM, music instruction, and college readiness courses remain priorities, with an emphasis on cultural relevance and embedding them into school culture. Our dedication to behavior support continues, with the establishment of behavior teams and planned professional development in restorative practices. Consequently, our efforts are geared towards fostering authentic parent engagement through sustained parent workshops and leadership opportunities.

In response to parent feedback, we are expanding family workshops, improving language access, and fostering more welcoming campus environments. SEL supports continue through guidance specialists, behavior response teams, and student outreach clerks addressing attendance and climate. These actions reflect our ongoing commitment to aligning resources with the needs and voices of our students, families, and staff.

An explanation of why the LEA has developed this goal.

The goal was developed following input from educational stakeholders, including the LCAP Steering Committee, composed of a variety of educational partners, who reviewed both state and local data. Examination of CAASPP and i-Ready results highlighted the necessity for continuous efforts to diminish the achievement gap among student subgroups, aiming to guarantee proficiency in grade-level standards for all students.

2023 CAASPP ELA data:
 The overall Performance Level Color was Orange (-26 points below standard) in ELA.

- English Learners: -57.3 points Distance from Standards (DFS)
- Socioeconomically Disadvantaged: - 41.5 points DFS
- Foster Youth: - 76.7 points DFS

2023 CAASPP Math data:
 The overall Performance Level Color was Yellow (-46.3 points below standard) in ELA.

- English Learners: -72.3 points Distance from Standards (DFS)
- Socioeconomically Disadvantaged: - 62.3 points DFS
- Foster Youth: - 61.8 points DFS

Progress towards language proficiency based on ELPAC for our ELLs was 50.4% in 2023.

For the 23-24 school year, the Winter i-Ready data results indicate that:

- Overall, 44% of students are on or above grade level in reading, and 35% are on or above grade level in math, again showing a need to increase academic proficiency for all students.

- Our subgroup data showed that the percentage of English learners on or above grade level in reading was 17%, and 14% are on or above grade level in math.
- The percentage of socio-economically disadvantaged students on or above grade level in reading is 39%, and 28% are on or above grade level in math.
- For students with disabilities, 13% were on or above grade level in reading, and 12% were on or above grade level in math.
- For students identified as foster, 12% are on or above grade level in reading, and 13% are on or above grade level in math.
- For students identified as homeless, 24% are on or above grade level in reading, and 12% are on or above grade level in math.

The data highlights the necessity to enhance academic proficiency. The district will enhance both academic and language proficiency by implementing actions aimed at supporting and enhancing student learning, with a particular focus on English Language Learners (ELLs), students from low socio-economic backgrounds, foster youth, and those with special needs.

Goal Analysis [2024-25]

An analysis of how this goal was carried out in the previous year.

A description of overall implementation, including any substantive differences in planned actions and actual implementation of these actions, and any relevant challenges and successes experienced with implementation.

Goal 1 was implemented to improve student proficiency in ELA, math, and English language development, with a focus on supporting English Learners, low-income students, foster youth, and students with disabilities. Actions included instructional coaching, tiered interventions through MTSS, foundational literacy and math support, and professional learning communities focused on essential standards and data analysis.

An explanation of material differences between Budgeted Expenditures and Estimated Actual Expenditures and/or Planned Percentages of Improved Services and Estimated Actual Percentages of Improved Services.

Most planned actions were implemented as intended, though a few adjustments occurred:
 Action 1.9 - ACCESS: Program costs varied based on student participation.
 Action 1.10 - PLC: Increase in expenditures due to rising salary and benefit costs.
 Despite these variances, implementation remained robust, with continued emphasis on instructional coaching, foundational reading support, and small-group intervention structures aligned with MTSS.

A description of the effectiveness or ineffectiveness of the specific actions to date in making progress toward the goal.

Effectiveness:
 While the district did not meet its full targets in CAASPP and i-Ready assessments, there have been clear signs of progress in student achievement and instructional improvement. i-Ready data from Winter 2024 showed growth across multiple subgroups, most notably foster

youth, who increased from 12% to 27% at or above grade level in reading. This indicates that targeted intervention strategies are beginning to yield positive results.

A key driver of this growth has been the successful implementation of Buena Park School District's Learning Recovery Program, which aligns with the district's CARE Pathways. This multi-tiered system of support was designed to accelerate student learning and strengthen instructional practice.

At Tier 1, teachers received personalized instructional coaching centered on high-impact strategies and standards-aligned instruction.

At Tier 2, students were supported through small-group instruction designed around essential standards and targeted needs.

At Tier 3, learning coaches delivered intensive foundational literacy interventions for students significantly below grade level.

This system was reinforced by ongoing professional development in areas such as foundational literacy (especially in grades K–2), curriculum-based instruction, and PLC structures. PLC professional learning helped teacher teams focus on essential standards, student work analysis, and differentiated instruction across all tiers, increasing alignment and coherence in teaching and learning. Further, the implementation of Cognitively Guided Instruction (CGI) in math and the Reading/Writing Workshop model contributed to improved instructional quality. These were supported by strategic curriculum investments, including new middle school math materials and ELD supports.

Although the percentage of English Learners making progress on the ELPAC declined from 50.4% to 46.8%, this was primarily due to a larger number of high-performing ELs meeting reclassification criteria. As these students were reclassified, their higher scores were removed from the cohort, resulting in a lower average among remaining ELs, who now represent a group with more intensive support needs.

Ineffectiveness:

Despite growth in some subgroups, CAASPP performance remains lower than expected, particularly for English Learners, students with disabilities, and homeless youth. These groups showed limited gains in Distance from Standard (DFS), indicating that while the instructional systems are in place, they require more time, fidelity of implementation, and refinement to fully close achievement gaps.

Furthermore, long-term English Learners and students with disabilities continue to face persistent academic challenges, underscoring the need for even more tailored interventions, deeper cultural responsiveness in instruction, and continued development of language acquisition strategies.

A description of any changes made to the planned goal, metrics, target outcomes, or actions for the coming year that resulted from reflections on prior practice.

*Based on reflection and review of implementation outcomes, Goal 4 has been reclassified from a Focus Goal to a Broad Goal. This change reflects the district's continued commitment to promoting emotional engagement and connectedness among students, families, and staff through a wide range of actions and metrics. Rather than being prioritized for focused improvement based on a specific data point, this goal encompasses multiple ongoing efforts that collectively support safe, supportive, and culturally responsive learning environments across the district. The reclassification aligns with the definition of a Broad Goal, as the grouped actions and metrics are designed to sustain and advance the district's overarching vision for student and community well-being.

Based on implementation feedback and student outcome data, Action 1.7 has been expanded to now fully encompass Buena Park School District’s Learning Recovery Program. This multi-tiered system of support is designed to accelerate student learning and strengthen instructional practice. It includes:

- Tier 1 personalized instructional coaching for teachers, focused on high-impact strategies and standards-aligned instruction.
- Tier 2, students receive targeted small-group instruction addressing specific skill gaps identified through data analysis and aligned to essential standards.
- Tier 3 targeted foundational literacy interventions delivered by learning coaches for students needing intensive support.
- Ongoing professional development for teachers in foundational literacy (especially in grades K–2), curriculum-based strategies, and PLC structures that emphasize essential standards, data analysis, and small-group instructional design.

These refinements were made in response to ongoing needs for literacy acceleration, improved Tier 1/2 alignment, and stronger support for students below grade level. While no changes were made to the overarching goal or metrics, this action reflects a deeper integration of instructional coaching and professional learning into our systemwide support model, ensuring more cohesive alignment with MTSS and the CARE roadmap.

Action 1.11 – Math Professional Development: While we continue to implement this professional development approach, funding is no longer required as internal staff capacity has been built to sustain CGI practices.

Goal Analysis [2024-25]

An analysis of how this goal was carried out in the previous year.

A description of overall implementation, including any substantive differences in planned actions and actual implementation of these actions, and any relevant challenges and successes experienced with implementation.

Actions outlined in the 2024–25 LCAP to support the goal—Highly qualified staff will deliver standards-based instruction and support district systems designed to increase cognitive engagement for all students, especially those with unique needs, within clean, well-maintained school facilities that foster a positive learning environment—were implemented fully or to some extent.

Successes:

The district met its objective of maintaining clean and safe learning environments, with 100% of facilities rated in “Good Repair” on the California Dashboard. Perception data across students, staff, and families remained strong, with 92% or more agreeing that classrooms were kept neat and clean, and 96% of parents stating classrooms were in good shape. These outcomes reflect consistent implementation of facility maintenance practices that contribute to a positive learning climate.

Professional development opportunities were provided across content areas, including CGI Math, ELD, PLC, Artificial Intelligence, Foundational Literacy, Collaborative Teaching, and assessment training. These were designed to deepen staff capacity in delivering standards-aligned instruction and supporting the unique learning needs of students. Survey data showed that 87% of staff agreed the professional learning helped implement the State Standards in ELA/ELD, and 86% reported the same for math. The district also maintained 100% access to standards-aligned instructional materials, verified by the Williams review.

Challenges:

While the district previously reported 98% of teachers as fully credentialed, the 2024 CA Dashboard showed a decline to 86.6%. Efforts continue to align with the statewide average and ensure 100% of teachers are fully credentialed and appropriately assigned.

There was a slight decrease in the percentage of staff who found professional learning useful for technology integration (from 78% to 79%), suggesting a continued need for more targeted support in this area to strengthen cognitive engagement through tech-enhanced instruction.

A description of the effectiveness or ineffectiveness of the specific actions to date in making progress toward the goal.

Overall, Goal 2 has been effectively implemented with meaningful progress toward fostering high-quality teaching and maintaining clean, safe, and engaging learning environments.

Effectiveness:

The implementation of Goal 2 resulted in several positive outcomes. All school facilities continued to meet the “good repair” standard, as verified by the Williams Act, and students maintained 100% access to standards-aligned instructional materials. Perception data from students and families reflected high levels of satisfaction—over 95% indicated that classrooms were clean, well-maintained, and adequately equipped with necessary instructional materials and technology.

Professional development also emerged as a strength. Teachers participated in multiple training opportunities focused on key instructional strategies, including CGI Math, PLC structures, and ELD integration. Staff survey results indicated strong approval, with 87% of teachers finding ELA/ELD training useful, 86% reporting usefulness in math PD, and 79% acknowledging support in integrating technology into standards-based lessons. These learning opportunities helped build teacher capacity, particularly for meeting the needs of students with disabilities, English learners, and students requiring differentiated instruction. The presence of instructional coaches, special education staff, and early learning supports further strengthened classroom instruction and engagement.

Ineffectiveness:

Despite these successes, there were areas of concern that impacted full implementation of the goal. The percentage of fully credentialed and appropriately assigned teachers declined from 98% to 86.6%, highlighting ongoing challenges in staffing, recruitment, and retention. This reduction may have implications for consistency and quality of instruction, particularly in high-need areas.

Additionally, while student and parent survey data remained strong, only 76% of staff reported that classrooms were in good shape—a slight decline from the previous year—suggesting a need to address facility upkeep from the staff perspective. Furthermore, although the quality of professional development remained high, the quantity of training sessions in some key content areas decreased from the previous year.

A description of any changes made to the planned goal, metrics, target outcomes, or actions for the coming year that resulted from reflections on prior practice.

Based on reflections from prior practice, no changes have been made to the planned goal, metrics, or actions for Goal 2. However, the District will take targeted steps to address areas identified as less effective. To improve the percentage of fully credentialed and appropriately assigned teachers, the District will strengthen recruitment efforts, expand partnerships with teacher preparation programs, and provide additional support for credential completion. In response to staff feedback regarding classroom conditions, the District will prioritize facility enhancements based on site-reported needs to ensure environments are conducive to learning. Additionally, while professional development was rated positively, efforts will be made to increase the frequency and reach of training sessions, particularly in high-impact instructional strategies, to ensure all staff are equipped to meet the diverse needs of students. These focused improvements aim to reinforce the effectiveness of existing actions and further support staff and student success.

The goal to increase student outcomes through impactful instruction of core subjects and expand college and career pathway programs is deeply rooted in feedback from a variety of educational stakeholders. This feedback includes data from district-wide LCAP Surveys, recommendations from the LCAP Steering Committee, insights gained from focus group interviews, and specific data from PFT and CAST-Science assessments. Educational partners have expressed a clear desire to expand College and Career Readiness programs, highlighting a community-wide interest in enhancing educational offerings that prepare students for post-secondary success. This is further supported by the 2023-24 LCAP Student Survey results, which show strong student engagement and satisfaction with existing programs that promote college and career readiness:

- 91% of students reported having access to programs and services such as after-school sports, which contribute to a well-rounded educational experience.
- 94% confirmed that their schools offer elective classes designed to help them explore future career interests, indicating a robust framework to support career exploration.
- 96% stated that their schools provide opportunities to take honors or advanced courses, which are crucial for academic advancement and college preparation.

These survey results not only validate the existing programs but also underscore the need for continued and expanded efforts in these areas. The goal of enhancing instruction and expanding pathway programs directly addresses these needs and desires, ensuring that all students have the resources and opportunities to excel academically and prepare for future careers. Progress towards this goal will be meticulously assessed using the metrics provided, ensuring that the programs not only exist but are effective and continue to meet the evolving needs of students.

Goal Analysis [2024-25]

An analysis of how this goal was carried out in the previous year.

A description of overall implementation, including any substantive differences in planned actions and actual implementation of these actions, and any relevant challenges and successes experienced with implementation.

During the 2024–25 school year, Goal 3 was implemented with a continued focus on strengthening student outcomes through high-quality instruction in core subjects and expanding access to college and career pathway programs. Several initiatives were successfully rolled out, including the implementation of STEM and music instruction, expansion of district passion programs, and a middle school college course offering that aligns with early college exposure strategies.

Successes

One of the major successes was the sustained implementation of enrichment and elective opportunities that reflect student interests and real-world connections. The passion programs, including those focused on arts, STEM, and leadership, were well-received and supported, with engagement and exploration of their interests. Additionally, the music instruction program enhanced access to the arts and supported standards-based music education across sites.

The middle school college course, in partnership with Fullerton College, also marked a successful step toward college and career readiness. These programs have been valuable in increasing student motivation, expanding access to diverse pathways, and building future readiness. Middle schools offered a wide range of elective courses, including CTE pathways, including drumline, visual arts, applied arts, STEM, digital media, horticulture, and leadership, allowing students to explore diverse interests and develop real-world skills. In addition, the district continues to invest in strengthening passion programs at each site.

Career Weeks were hosted at all school sites, introducing students to a variety of industries and professional pathways. The Career Connected Schools initiative, in partnership with the Orange County Department of Education, also officially launched at the middle school level, providing early exposure to college and career exploration through activities aligned with the Realistic, Investigative, Artistic, Social, Enterprising, Conventional (RIASEC) framework and staff professional development.

The middle school college course pilot further expanded early college access and was met with strong student interest and participation, especially among underrepresented groups. Collectively, these programs contributed to increased student motivation, access to meaningful learning pathways, and strengthened college and career readiness.

Challenges

While most planned actions under Goal 3 were implemented as intended, a few differences arose. The implementation of some elements of STEM and elective expansion varied by site depending on staff availability, space constraints, and student enrollment patterns. For instance,

some campuses experienced delays in staffing specialized elective teachers or securing instructional materials in a timely manner. These challenges impacted the breadth of course offerings at some school sites.

Additionally, while the college and career readiness initiatives were positively received, early data suggest a need for stronger alignment between middle school academic preparation and the expectations of early college coursework. Some students required additional academic and executive functioning support to fully benefit from the opportunity.

Despite these minor differences, the district successfully moved forward in expanding college and career pathways and providing high-quality instruction through engaging and relevant content, which is reflected in increased student participation and interest in these programs.

An explanation of material differences between Budgeted Expenditures and Estimated Actual Expenditures and/or Planned Percentages of Improved Services and Estimated Actual Percentages of Improved Services.

Several material differences were observed between the budgeted and estimated actual expenditures for Goal 3:

Action 3.7 (Middle School College Course): There were no actual expenditures for this action because Fullerton College provided the necessary funding, allowing students to participate at no cost to the district.

Action 3.11 (Educational Programs) and Action 3.12 (Program Specialist): Both actions experienced an increase in expenditures due increase in salary and benefit costs necessary.

These variances did not impact the overall delivery of services, and the planned percentage of improved services was maintained across actions.

A description of the effectiveness or ineffectiveness of the specific actions to date in making progress toward the goal.

Overall, Goal 3 has been effectively implemented with meaningful progress toward increasing student outcomes through high-quality instruction in core subjects and expanding access to college and career pathway programs.

Effectiveness:

Actions under Goal 3 have been effective in broadening student access to diverse learning opportunities and strengthening engagement in core academic areas. The expansion of STEM instruction, supported by professional development aligned with NGSS standards, enabled teachers to implement hands-on, inquiry-based learning that increased student interest and participation. Passion programs in areas such as arts, music, leadership, horticulture, and STEM were successfully implemented across school sites, offering students voice, choice, and relevant connections to real-world experiences. These programs also contributed positively to school culture and supported social-emotional development.

Ineffectiveness:

Despite these successes, some areas require further refinement. The implementation of passion programs varied in consistency across school sites, and while they enhanced student engagement, their direct impact on academic performance in ELA and Math remains unclear. Stronger alignment between enrichment opportunities and academic outcomes, along with more robust progress monitoring, is needed. Continued support, clearer instructional integration, and strengthened data collection will be essential to ensuring sustained improvement in college and career readiness

A description of any changes made to the planned goal, metrics, target outcomes, or actions for the coming year that resulted from reflections on prior practice.

Based on reflections from the 2024–25 implementation of Goal 3, two notable changes were made to the planned actions for the 2025–26 school year.

Action 3.7 (Middle School College Course) will have a decrease in budget since Fullerton College will continue to provide funding for student participation, eliminating the need for district expenditures for this program. This reflects a successful partnership and resource alignment that supports college and career readiness without impacting the general fund.

Action 3.12 (Program Specialist) has been discontinued for 2025–26 due to a strategic shift in staffing priorities and program streamlining. The duties previously assigned to this position will be integrated into existing roles to maintain program continuity while optimizing resources.

No changes were made to the overall goal, metrics, or target outcomes, as the district remains committed to expanding college and career pathway programs and strengthening instruction in core academic areas.

Promoting emotional engagement and connectedness among students, families, and staff by fostering safe and culturally responsive learning environments is an essential goal for school districts within the Local Control and Accountability Plan (LCAP). This initiative is crucial as data from the district highlights disparities in suspension rates and chronic absenteeism, which can be mitigated by enhancing student connectedness and the inclusivity of the educational setting. Culturally responsive practices and the establishment of secure, supportive environments encourage students to participate actively and feel valued within their educational community. This not only leads to improved academic outcomes but also reduces behavioral issues and absenteeism.

Suspension and chronic absenteeism data by student subgroups at the district level and within schools substantiates the need for a goal that promotes specific strategies designed to eliminate disparities and increase attendance for all students if necessary. Additionally, student, parent, and staff surveys also indicate a need to continue efforts that are in place that are supportive of safe and healthy habits of mind and body, connections with adults, and parent engagement. By integrating family and staff into the development of this goal, the school strengthens its community, enhancing communication and cooperation, which are pivotal for sustaining student cognitive and emotional engagement, which is critical to academic success.

Goal Analysis [2024-25]

An analysis of how this goal was carried out in the previous year.

A description of overall implementation, including any substantive differences in planned actions and actual implementation of these actions, and any relevant challenges and successes experienced with implementation.

Overall, Goal 4 has been effectively implemented with meaningful progress in promoting emotional engagement and connectedness among students, families, and staff.

Successes:

The district prioritized creating safe, inclusive, and culturally responsive environments through the implementation of site-based outreach staff, behavior response teams, wellness supports, and family engagement initiatives. Professional development in social-emotional learning (SEL), trauma-informed practices, and restorative justice enhanced staff capacity to support student well-being. Feedback from student, staff, and parent surveys reflected improved perceptions of school climate, with notable gains in student connectedness and family engagement. Additionally, the district saw a reduction in suspension rates and improved attendance for key student groups, indicating positive shifts in student engagement and behavior.

Challenges:

While progress was evident, ensuring consistent implementation of supports across all school sites remained a challenge. Variability in staffing, training timelines, and site capacity impacted the uniformity of SEL and behavioral supports, indicating the need for continued alignment and monitoring to sustain progress districtwide.

An explanation of material differences between Budgeted Expenditures and Estimated Actual Expenditures and/or Planned Percentages of Improved Services and Estimated Actual Percentages of Improved Services.

Several material differences between budgeted and estimated actual expenditures occurred under Goal 4:

Action 4.2 - Student Engagement and Outreach Clerk: Increase in expenditures due to rising salary and benefit costs.

Action 4.3 - Middle School Attendance Clerk: Decrease in expenditures due to a change in staffing, with the replacement staff placed at a lower step and column.

Action 4.6- Parent Workshop: Decrease in expenditure as some resources initially planned for purchase were later acquired through a free option.

Action 4.7 - LCAP Advisory: Expenditure decreased due to the finalized contract amount being lower than originally projected.

Action 4.9 - Enhanced Condition of Learning: Decrease in expenditures due to anticipated changes in staff salary and health plans.

Action 4.15 – Wellness Teacher: Increase in expenditures due to rising salary and benefit costs.

These differences did not significantly impact the delivery of services, and the planned percentages of improved services were met or exceeded in most areas.

A description of the effectiveness or ineffectiveness of the specific actions to date in making progress toward the goal.

Goal 4 was effectively implemented, with most actions completed as planned. The district maintained its commitment to fostering safe, inclusive, and culturally responsive learning environments, promoting strong emotional engagement and connectedness among students, families, and staff.

Effectiveness:

Actions under Goal 4 were largely effective in fostering positive school climates and increasing stakeholder engagement. The presence of Student and Family Outreach Coordinators (SEOCs), behavior intervention teams, and site-based wellness supports contributed to reduced suspension rates and stronger student-teacher relationships. Parent workshops and expanded communication efforts increased family involvement and trust, especially among historically underserved groups. Staff professional development in cultural responsiveness, SEL, and de-escalation strategies further supported emotionally safe learning environments.

Ineffectiveness:

Some variability in implementation fidelity across sites limited consistent impact, particularly where staffing transitions or resource constraints delayed full deployment of supports. Additionally, although family engagement efforts improved, participation in some workshops and leadership opportunities remained uneven, indicating a continued need for targeted outreach and accessibility improvements.

A description of any changes made to the planned goal, metrics, target outcomes, or actions for the coming year that resulted from reflections on prior practice.

After further review of Goal 4, we have determined that it aligns more closely with the definition of a broad goal rather than a focused goal; therefore, it has been reclassified to better reflect its purpose and scope.

No changes were made to the overall goal, metrics, or target outcomes for Goal 4, several updates were made to actions for the 2025–26 school year based on implementation review and program needs:

Action 4.2 has been updated to reflect the addition of a Program Specialist for Attendance Recovery, strengthening the district's efforts to improve student attendance and reduce chronic absenteeism through targeted supports and family outreach. The Program Specialist will provide support through additional learning options, including long-term and short-term independent study, as well as attendance recovery opportunities such as Saturday School. This adjustment reflects the district's continued focus on increasing student connectedness and engagement by offering flexible and responsive attendance interventions. Action 4.6 will continue at no cost due to the identification of a free alternative, allowing the district to redirect funds to higher-priority needs.

Budget adjustments were made for Actions 4.2 and 4.16 to account for increases in salary and maintenance costs.

Actions 4.3 and 4.9 saw reductions in expenditures due to staffing placement changes and anticipated health plan adjustments.

Action 4.14 – There are no funds allocated as this position will be eliminated effective June 30, 2025, as these responsibilities will be fulfilled by personnel funded through grants and federal resources.

These refinements reflect a responsive approach to improving emotional engagement, school connectedness, and family partnership efforts across all school sites.
