**RECEIVED QUESTIONS AND REPSONSES:**

- 1. Are all schools to be restriped regardless of the extent of work?  
[Response:](#) No. Pavement marking touch up to be done where more than 40% of the existing line is obscured. Including playground markings. All areas to receive seal coat must be repainted.
- 2. For an example of the above, if a playground is only being crack sealed is it being restriped?  
[Response:](#) If the crack seal obscures more than 40% of the existing pavement markings, then repainting of markings must occur.
- 3. We are asking for at least a week extension on the bid due date due to the amount of time that will be required to put together a competitive bid.  
[Response:](#) The bid due date has been extended for bids now to be due Thursday October 17, 2024 at 1pm. Questions are due Monday October 14, 2024 by 9:00am.
