Approval of meeting minutes: Scott Richards made a motion to approve the June 25, 2024, meeting minutes and Martine Frey provided a second. Minutes were unanimously approved.

Measure M Update:

Matt Washburn updated the committee about the ribbon-cutting ceremony at Alder Creek Elementary School, marking the opening of the new facility. He noted that staff and students began their first day at the school on August 8, 2024. Following that, he provided a summary of the SFID 3 Advisory Committee recommendations:

Summary:

- **Measure M/Tax Rates** – The remaining Measure M funding will not be issued except to ensure equitable distribution between both cities in SFID 3.
- **Equitable Funding** – Funding from Measure M will be allocated based on total debt service payments from 2024 to 2029, excluding the unincorporated area.
- **Next High School Location** – The first of two comprehensive high schools will be built in southeast FCUSD, with plans for a small specialty high school in southwest FCUSD.

Additional topics for future discussion will include redesign work for elementary, middle, and high schools, as well as future funding needs and timelines.

- The Board will hold a study session on September 25, 2024, Facilities to discuss this information further.
