# 6. Student/Staff Recognition and Superintendent's Report

- a) Superintendent Brown began by thanking the administrators, Coach Littlejohn, and Coach Williams for attending the meeting and presenting their reports.
- b) Superintendent Brown introduced and welcomed to the Bamberg County School District family new and existing hires at the administrative level: Dennis Ulmer, Assistant Superintendent; Denise-Robinson Crosby, Truancy Officer; Mallie Shaw, Title I Coordinator; Jraquarie Washington, Social Worker; Jordan Smith, Principal for Bamberg-Ehrhardt High School; Patricia Goldsmith, Principal for Denmark-Olar Middle School; and April Morgan, Assistant Principal for Richard Carroll Elementary School.
- c) Superintendent Brown lead into agenda item #7 by advising that the district is taking every precaution to make the buildings and athletic events safer for all and that improvements being made by the technology department to the district's cameras, audio, and security systems are increasing these efforts.

## 7. District and School Safety Plan PowerPoint: Phyllis Overstreet

Phyllis Overstreet, Safety Director for Bamberg County School District, presented and explained in depth the district's safety plans. Miss Overstreet advised that all schools are working on their safety plans and are on track with all required staff trainings. Miss Overstreet further advised that emergency operations are reviewed annually and trainings are conducted regularly so that every employee knows their role in implementing the plans. Miss Overstreet stated that earthquake drills, fire drills, active shooter drills, along with behavioral threat assessments are standard trainings.

#### 8. **SCAGO Bond Resolution**

Francenia Heizer of McNair Law Firm reviewed and explained the SCAGO Bond Resolution, how the SCAGO program allows smaller districts to receive the same lower rate as larger districts, and how it allows for millage stabilization. Ms. Heizer indicated the bond is issued every year and the district pays it in full every year.

Trustee John Hiers moved and Secretary Tonie Holman seconded to accept the SCAGO Bond Resolution. The motion passed 8-0.
