4. **Discussion: 2022-2023 Budget**

Handout: Tentative 2022-2023 Budget and Salary Scales

During a review and discussion of the 2022-2023 budget prepared by Finance Director Devon Furr, Ms. Furr advised allocations from the state were received prior to the start of the meeting, so the numbers had not been incorporated in the handout presented. Ms. Furr reported the budget was balanced at \$18,365,598.65, but was certainly subject to change based on the information that just came down from the state legislators and board decisions. The legislation did reflect a \$4,000.00 increase for teachers and a 8% increase for bus drivers. Ms. Furr noted she had still not gotten all of the federal program allocations.

Ms. Furr presented several examples of neighboring salary scales for positions that were not included in Bamberg's existing salary scales that could be utilized to create new scales, if desired.

5. Executive Session

Board Chair Janeth Walker called for a motion to enter Executive Session. Trustee Cynthia Hurst moved and Vice Chair Beverly Bonaparte seconded to enter Executive Session. The motion carried 8-0.
