WELCOME & Introductions

Jake Kuper welcomed everyone to the FACT meeting and discussed with the committee the school district will be working on the budget for next year within the next few months after the Legislature is done with their session. He stated the committee will reconvene after he presents the budget to the Board and look at the overall status of the budget for next year and go from there in May. The committee agreed to wait until May in order to proceed with the discussion of consolidation.

Review of Student Enrollment SY15/16-24/25

Jake reviewed the current enrollment and reviewed the steady decline. A question was asked about why the school district has been hiring teachers if we have been on

an enrollment decline trend? Jake stated that every year we have retirements, attrition and moves that happen every year therefore still need to hire teachers.

- **Monitor Progress:** Establish a process for ongoing review and adjustment as next steps are carried out.
- **Budget:** The district will be in budget season this spring and as it develops we will update the FACT committee.
- **Legislative Updates:** Jake informed the FACT committee that as legislative sessions release budget-related news, Liz Gonzalez will forward updates to keep the committee informed.
- **Next Meeting:** The FACT committee will reconvene in May 2025 to review the new budget and any updated data. This will help with being able to make the most informed decisions.
