



## FEE SCHEDULE 2025-2026 - EFFECTIVE SEPTEMBER 1, 2025

Fees are non-refundable unless indicated overleaf and payable in advance in accordance with the fee structure approved by the Board of Directors. The 6% Service Tax (SST) imposed by the Malaysian Government in June 2025 applies to private schools where annual fees exceed RM60,000 per student. ### LIFE-CENTERED EDUCATION

An additional annual fee of RM 52,364 (RM 49,400 + 6% SST) applies for students receiving the Life-Centered Education learning support service. This personalized level of support is designed to meet the needs of students with more significant intellectual, learning, and/or developmental differences.

### STUDENTS ENTERING ISKL DURING THE SEMESTER

Due dates for fees are as stated in the table above, however for students entering ISKL after the semester has commenced, fees are payable in advance of attendance as follows:

#### Semester 1: August 6 - December 19, 2025

- Students entering August 6 till October 17, 2025 i.e before the October break (October 18 - October 26, 2025) to pay 55% of the annual tuition fee before their first day at ISKL, and pay the remaining 45% by December 1, 2025.
- Students entering after the October break to pay 30% of the annual tuition fees before their first day at ISKL, and pay the remaining 45% by December 1, 2025.

#### Semester 2: January 12 - June 5, 2026

- Students entering January 12 till March 13, 2026 i.e before the March break (March 14 - March 22, 2026) to pay 50% of the annual tuition fees before their first day at ISKL.
- Students entering after the March break to pay 25% of the annual tuition fees before their first day at ISKL.

# FEE PAYMENT POLICIES

## NEW STUDENTS

**Application Fee:** non-refundable and payable when the student's application is submitted. An application is not considered complete until this fee has been paid. The fee is valid for the school year for which the application is submitted.

**Non-Refundable Enrollment Deposit:** due within 15 days of accepting an admission offer (or before the first day of attendance), whichever is earlier. This payment is used to secure the place for the student and is credited towards Semester 2 tuition fees.

**Student Registration Fee:** non-refundable and payable in full with the initial tuition fee invoice. This fee applies to new students entering Prep-Senior to Grade 12 and when a Prep Junior student enrolled in or after August 2025 advances to Prep Senior.\* This fee is used for costs associated with investments in, and maintenance of, campus facilities and technology. This is a one-time, non-transferable fee, and is valid for a 12-month period from the date of the admission offer.

For new students entering during the school year, the initial invoice for the annual tuition fee and student registration fee is due by the first day of attendance.

## RETURNING STUDENTS

**Non-Refundable Enrollment Deposit:** payable annually by April 1, and credited towards the Semester 2 Tuition Fee payment. This fee is used to secure a place for returning students in the next school year.

**Annual Tuition Fee:** may be paid in full by July 1, or in two parts: Semester 1 Tuition Fees due by July 1 (55%) and Semester 2 Tuition Fees due by December 1 (45%). Fees are payable in advance of the start of each semester, in order to allow the school to manage enrollment accordingly. A remittance rebate of RM200 is offered to those who pay 100% of a student's tuition fees in advance. Tuition Fees are used to support the general annual operations of the school.

## ADDITIONAL FEES

- A one-time Society Membership Fee (RM 50) to join The Society for The International School of Kuala Lumpur and the annual Society Membership Subscription Fee (RM 20) are included in the Student Registration Fee and annual Tuition Fees.
- External exam fees, associated registration and courier costs for examinations marked and graded by an external examining board for example, IB, AP are incurred and charged separately from fees listed in this schedule.
- ISKL provides opportunities for students to engage in curricular and co-curricular activities and parents may be required to contribute toward the costs incurred on certain specified activities. The High School Global Action Program (GAP) is mandatory for Grade 9-11 students and is a graduation requirement. A separate non-refundable GAP fee is charged based on the destination selected. This will be billed together with tuition fees listed in this schedule.

## REFUNDS

All fees are non-refundable, except in the case of Tuition Fees where a refund of 50% of the applicable semester fees will be granted if formal written notice of withdrawal is received after July 1 or December 1 and before the official first day of school on August 6, 2025 and January 12, 2026. If written notice is not received before the official first day of school, no refund will be granted, even if the student has not attended school. Students having attended a day of class are contractually liable to pay the full fees. In instances where a refund of fees is processed and those fees were previously subject to SST, the SST portion will be refunded accordingly.

## PAYMENT

All Fees are set and are payable in RM (Ringgit Malaysia). In exceptional circumstances, USD-based invoices and payments may be arranged, subject to confirmation of the exchange rate with the Finance Department via [billing@iskl.edu.my](mailto:billing@iskl.edu.my). Payment must be made by one of the following methods, indicating student name(s) and Family Number by:

All payments made must be net of any bank charges (wire transfer charges, etc), which are the responsibility of the payer. A surcharge of RM 500 shall be levied on any dishonoured checks. The parent must provide proof of payment for wire transfers and direct deposits, even if payment is made by a sponsoring entity.

An installment plan is available. Please contact the Finance Office for an application. Terms and conditions apply.

A 2.5% surcharge will be levied on any balance of fees not paid by the due date, and an additional 2.5% will be levied on any balance of fees still not paid 30 days after the due date. Failure to pay fees by the stipulated due date carries consequences including withholding of student records and the exclusion of a student from school until fee payments are settled in full.
