INFORMATION FOR 2025-2026 School Year

Before and After School Extended Day Child Care will be available for students at Dentzler, Green Valley, John Muir, Pleasant Valley, and Thoreau Park. Ridge-Brook & PAGE students will be bused to/from Thoreau Park for EDC

After School Extended Day Child Care will be available for students in 5th and 6th grade for Greenbriar Middle School (Greenbriar is bused to Shiloh for EDC) and Shiloh Middle School. (Child Care is not offered at Hillside Middle School.)

*Operation of middle school programs and/or site locations is contingent upon enrollment.

ENROLLMENT PROCEDURES

1. EDC is licensed by the Ohio Department of Education and staffing is 1:18 ratio. Children must be capable of functioning safely within the stated ratio. The EDC program does not provide one-on-one care.
2. To inquire about EDC availability at your child's school, complete the **2025-26 Inquiry Form** at www.parmacityschools.org/edc
3. Be prepared to provide the following information:
 - a) School building your child(ren) will attend
 - b) Child(ren)'s grade
 - c) Service needed: Before School, After School, or Before and After School
 - d) Days needed
 - e) Intended start date
4. ONLY the Extended Day Child Care Office can confirm that there is an open EDC space for your child in a program. If a space is available, you will be directed to complete our online Registration forms and pay the Registration Fee and Deposit.
5. If space is not available at your child's EDC school upon completion of the online Inquiry Form, you will be placed on the wait list and contacted when a space becomes available.
6. Your child may not begin attending EDC until all required forms have been completed and submitted with the necessary registration fee and calculated tuition paid.
7. **EDC is not a drop-in service.** You are charged for all days as contracted whether your child has attended EDC or not. Notify the Extended Day Child Care Office to make any changes to your contracted service.
8. A 10% sibling discount for families with more than one child attending full time (4-5 days) is applied.
9. Families with rotating schedules are charged the full time (4-5 days) tuition rate.
10. Tuition payments must be paid on a monthly or bi-monthly basis in advance of services. Invoices will be emailed to families on or around the 5th of the month PRIOR TO THE SERVICE PERIOD. See the schedule of service periods and payment due dates on our website. Payments are due upon receipt no later than the 15th of the month. Bi-monthly payments are due on the 15th and the 30th of the month.
11. We do not accept Ohio Department of Jobs and Family Services county vouchers as payment.
