Tonight, we recognized the Basha Indoor Percussion Ensemble, commonly known as BIPE, along with Band Director Miles Denny.

BIPE competes in both the WGAZ and WGI circuits, presenting meaningful shows and opportunities for individual and ensemble skill development.

After securing their 13th state title in Arizona, BIPE traveled to Dayton, Ohio in April to compete at the WGI Winter Guard International World Championship. This is a nationally ranked event.

The WGI Competition began with 64 ensembles from around the country. 2 groups of 32 schools performed and half of each advanced to semifinals. BIPE was ranked 6th out of their group 32!

After delivering three outstanding performances of their program, BIPE placed 13th overall. Qualifying for semifinals, and then finals at this elite level is an enormous accomplishment. BIPE is the first Scholastic Open group to ever make finals from Arizona, trailblazing a standard for other Arizona groups. We are so proud of how the students, band directors, ensemble staff, and families represented CUSD and Arizona.

## 10.06 Fee Schedules for the 2025-2026 School Year

Pursuant to A.R.S. 15-342, a school district may charge fees for school activities and programs. The Board recognizes the need for student fees to fund certain school activities that are not financed by local, state, or federal funds. It also recognizes that some students may not be able to pay these fees. All fees shall contain a provision that allows the fees to be waived in the event of economic hardship to the pupil. No student will be denied an education as a result of their inability to pay these supplementary charges.

Elementary and Secondary Course Fees/CTE Course Fees:

Elementary, Secondary and CTE course/activity changes highlighted in RED have minimally increased from the previous board approved fee schedules. The majority of these changes are due to material/supply price increases. Fees that are black are at no change from the previous school year. Fee changes to CTE course fees were also minor and were necessary to cover the cost of increased material/supply prices or were due to a new course being added. Also included in this fee schedule are Kindergarten Readiness and Gifted Testing fees. There are no changes to these fees from the previous year.

Elementary and Secondary Extracurricular Activity Fee Schedule:

Changes are highlighted in RED and have minimally increased from last school year due to rising travel costs. In addition, overnight/out of state field trip fee clarification on junior high groups who are participating with a high school is listed.

Community Education Fee Schedule:

Community Education reviews participation in programs and fees annually and will recommend the attached based on:

- 1. Minimum wage increase, (\$14.70/hourly),
- 2. District support staff wage increase, (2.4%),
- 3. Food & Nutrition increase, (2.3%),
- 4. Licensing & Transportation cost increase (2%), and
- 5. Evaluation of the overall financial effectiveness of the programming.

Changes to last year's Community Education fees are reflected in RED.

Food and Nutrition Fee Schedule:

Each year the Food Service Department must evaluate its annual budget to assess the need to increase meal prices. School food authorities depend on two sources of revenue to cover costs associated with the National School breakfast and lunch programs: funds collected from paid student meals and Federal reimbursement. The costs associated with the programs have increased significantly due to inflation in food and rising labor costs. The Food and Nutrition Department is requesting approval for attached meals and a la carte pricing. Recommended approval of proposed fees for the 2025-2026 school year.

#### 10.07 Fundraising for 25/26 School Year

Each year, fund-raising activities must be approved by the Governing Board (per Policy 5-212). District administration requested that the attached list of fundraising activities be approved for school clubs and organizations for FY25-26. Recommended approval.

#### 10.08 Science Curriculum – 6th Grade OpenSciEd

OpenSciEd is an Open Educational Resource (OER) providing high-quality science education materials for K–12 students. These standards aligned curriculum includes unit and lesson plans, student videos, simulation library, and on-demand teacher support. While the curriculum is free of charge, consumable and non-consumable items will be purchased to further support students in a hands-on learning environment. The total cost for materials is \$75,295.22 including estimated tax, shipping, and processing.

In accordance with A.R.S. 15-721, the curriculum was placed on display for the 60-day review period for comment at the Melinda Romero Instructional Resource Center starting February 27, 2025. There were no comments. Recommended approval.
