I understand that the Birdville Independent School District has an Open Enrollment process to enroll students who live outside the school district or outside internal district attendance boundaries. A person who presents false enrollment documents is also liable for tuition costs, currently \$6,200.00.

The presentation of false information or neglect to notify the Birdville Independent School District of a change in the residency status, which results in a lack of proof of residency in the Birdville Independent School District, will cause immediate withdrawal from school. I agree to notify the Birdville Independent School District immediately if the student and/or parent move from my residence in the district.

I have been informed that the Birdville Independent School District may investigate the residency of this student and parent including but not limited to a search of various records and/or home visit(s) if necessary to verify or reverify residency in the district.
