ROSSVILLE CONSOLIDATED SCHOOL DISTRICT SCHOOL BOARD MEETING June 3, 2025

The Rossville Consolidated School District Board of Education held its regular meeting on Tuesday, June 3, 2025, at 7:00 p.m. in the Rossville School Media Center. Board members present included Joe Hufford, Nathan Root, Nathan McCullough, Jentry Pendleton, and Brent Michael. Also in attendance were Superintendent Dr. James Hanna, Kim Prather, Dustin Shadbolt, Mandi Pennington and others who chose not to sign in.

Lindsay Simonetto and Maddy Shewey with BakerTilly, presented a detailed overview of Senate Enrolled Act 1 (SEA 1). The report highlighted substantial financial implications of the legislation, including projected reductions in revenue related to property tax deductions and credits. According to Simonetto, these changes could result in an annual loss of \$130,000 to \$200,000 for Rossville Schools, based on current property values. Key points from the presentation included: 1) A reduction in homestead property tax revenue, 2) Elimination of Local Income Tax for Property Tax Relief, set to take effect in 2028, resulting in a loss of over \$106,000. 3) Adjustments to the budget and debt issuance processes are prompting the District to consider new financial strategies and explore approaches to levy management.

No public comment was entered.

On a motion by Nathan Root, seconded by Jentry Pendleton, the Board approved the regular session meeting minutes from May 6, 2025, claims 21500- 21604, payroll claims dated May 9 & 23, 2025, and review of May 2025 financial reports. The motion passed 5-0.
