December 2023, the Winter FY24 Comprehensive Needs Assessment was completed by a schoolwide team, which ensured that data was up-to-date and accurate. The completed CNA identified specific areas that are in need of assistance. It was identified that extra support continues to be needed addressing student's social-emotional needs and providing them with strategies for future success. It was also identified that diverse learning gaps and academic needs will have to be supported.

• February 2025, a Staff/Teacher and Parent Survey was conducted to identify needs that still need to be addressed for FY26. Social Emotional security as it relates to students still is an area of focus and extra support for students. Training for the parents in the area of bullying and internet safety was identified as a need.

Emerson follows the proven instructional strategies incorporated into the Response to Intervention model. Research-proven instructional strategies are in place throughout the instructional tiers. The data from iReady and classroom assessments are used to identify our Tier 2 and Tier 3 groups and direct intervention instruction. Tier II instruction is directed in small group or individual support in and/or out the classroom to best meet the needs of identified students.

The following are the processes that are used to identify and support the students at Emerson.

- grade level PLC teams meetings once every other week for 60 minutes
- Progress monitoring (WIN for Teacher) meetings
- Interventions in place for 6 weeks
- Revisit progress at follow up WIN for Teacher meeting
- Title I funds have been used in the past to provide materials, such as LLI and Leveled Readers, as well as to pay personnel to be in the school to provide the most appropriate intervention.
 - After school tutoring
 - Summer tutoring (partnering with Title IV Summer Program)
- Provide services under the McKinney-Vento Act and school funds to students deemed homeless or migrant.
