2011-2012 TRANSPORTATION VEHICLE PROPOSITION

BE IT RESOLVED, that the following proposition be placed on the ballot at the Annual Meeting of the qualified voters of the Webutuck Central School District, to be conducted on May 17, 2011:

BE IT RESOLVED, that the Board of Education of the Webutuck Central School District, Dutchess and Columbia Counties, New York, be authorized to (1) purchase two 65-passenger school buses at a maximum estimated cost of \$110,000 each, for an aggregate maximum estimated cost of \$220,000, (2) equipped with radios and cameras (3) expend such sum for such purposes, (4) levy the tax necessary therefore, to be levied and collected in annual installments in such years in such amounts as may be determined by the Board of Education, taking into account state aid received, and (5) in anticipation of the collection of such tax, to issue bonds and notes of the District at one time or from time to time in the principal amount at a maximum estimated cost of \$220,000 and levy a tax to pay the interest on said obligations when due.

4. Approval of the Donation of the Millerton Elementary Building

Upon the recommendation of the Superintendent of Schools, BE IT RESOLVED that the Board of Education approves the donation of the real property commonly known as the Millerton Elementary School located at 5833 South Elm Street, Millerton, New York to the Village of Millerton, in the Town of North East or any other Public Entity as approved by the Board.
