### **INVITATION TO BID**

The Blount County Board of Education will accept written sealed bids for the following: To furnish labor and equipment for Surface Preparation and Painting as needed for Blount County Schools for the period August 1, 2025 through July 31, 2026 with the option to renew each year upon agreement of both parties.

### **CONDITIONS**

1. All quotations must be made on official forms provided with this bid package and must be signed by an authorized company official.
2. The successful bidder must allow a representative of the Board of Education an opportunity to inspect the work in progress.
3. Bidders shall submit quotes for labor per hour, per man.
4. The majority of surfaces will be masonry, sheetrock or wood.
5. It is the policy of the Board of Education to purchase on the basis of low bid, it being understood that the purchaser reserves the right to make the determination by whatever means that may be required.
6. Bidders must be able to demonstrate that they have been doing business under the same name with work experience similar in category and scope to what is described in this bid request for a minimum of five years prior to the date of this bid.
7. Work area should be cleaned after each work session.
8. Paint shall be provided by the Board of Education.

9. Whenever possible, all work will be performed while students and faculty are not present at the site.

#### TERMS

1. The successful bidder will be notified of the award of the contract and given a notice to proceed.
2. A purchase order will be issued for each job.
3. Payment will be made within 15 days upon completion of each project and acceptance by the owner.
4. By signing this contract, the contracting parties affirm, for the duration of the agreement, that they will not violate federal immigration law or knowingly employ, hire for employment, or continue to employ an unauthorized alien within the state of Alabama. Furthermore, a contracting party found to be in violation of this provision shall be deemed in breach of the agreement and shall be responsible for all damages resulting therefrom.

#### WARRANTY

Workmanship will be warranted for 1 year from the date of acceptance of the project.

Non-resident bidders must accompany any written bid documents with a written opinion of an Attorney at Law licensed to practice law in such non-resident bidder's state of domicile, as to the preferences, if any or none, granted by the law of that state to its own business entities whose principal places of business are in that state in the letting of any or all public contracts and bid awards.

Any deviation from specific items must be noted by stating the item number and how the specification differs.

**Said sealed bids will be received until 10:00 A.M. on Wednesday, July 16, 2025, at which time said bids will be opened publicly at the Blount County Schools Maintenance Office, 3070 Swann Bridge Rd., Cleveland, AL 35049. Bids should be submitted in an envelope plainly marked "Painting Bid."**

The Board of Education reserves the right to reject any or all bids.
