### **JOB DESCRIPTION:**

The Family and Consumer Science (FCS) Teacher is responsible for delivering engaging and standards-based instruction in one or more FCS courses aligned with the North Carolina Essential Standards for Career and Technical Education. The teacher will create a dynamic classroom environment that supports student learning, personal growth, and career readiness. This role includes planning, organizing, and implementing instructional programs that develop students' academic, social, and practical life skills.

- ➤ Teach Family and Consumer Science courses aligned with NC Essential Standards, including topics such as nutrition, child development, interior design, and personal finance.
- ➤ Plan and deliver engaging, hands-on lessons that promote student understanding and real-world application.
- > Create a safe, inclusive, and productive classroom environment that supports student learning and growth.
- Assess student progress using a variety of formative and summative tools and provide timely feedback.
- Maintain accurate records of student performance, attendance, and behavior.
- ➤ Manage classroom materials, equipment, and supplies, ensuring proper care and inventory.
- Establish and enforce clear expectations for student behavior and classroom procedures.
- Collaborate with colleagues in PLCs to analyze data, plan instruction, and improve student outcomes.
- Communicate regularly with parents, guardians, and school counselors regarding student progress and concerns.
- Participate in school-wide supervision, extracurricular activities, and committee work as assigned.
- > Stay current with best practices in FCS education and participate in professional development.
- Adapt instruction to meet the needs of diverse learners, including students with IEPs and 504 plans.
- Perform other duties as assigned by school administration to support student success and school goals

## **WORKING ENVIRONMENT:**

The usual and customary methods of performing the job's functions require the following physical demands: some lifting, carrying, pushing, and/or pulling; and significant fine finger dexterity. Work in this classification is considered light physical work requiring the exertion of up to 20 pounds of force occasionally and a negligible amount of force
