The district initially planned to purchase **182 Chromebook laptops** for students using funds allocated through the Smart Schools Bond Act. However, due to favorable pricing, the district was able to purchase **330 Chromebooks**, significantly exceeding the original estimate while staying within the overall Classroom Technology approved budget.

Other items initially budgeted for—**HP LaserJet Pro printers** and **Google Chrome Licenses**—were not purchased. Following Board of Education and NYSED approval of the plan, the district made strategic changes:

- **Printer Strategy Update:** The district opted to partner directly with **Toshiba** through a **BOCES bid**, transitioning away from individual desktop printers to **high-speed, high-capacity multifunction printers**. This change was made to increase efficiency, reduce maintenance, and lower long-term costs.
- **Google Platform Transition:** In the 2017–2018 school year, Eden CSD transitioned all students and staff to the **Google Workspace for Education** platform. The full Google suite was purchased through **Erie 1 BOCES**, our local Regional Information Center (RIC). As a result, Chrome licenses were no longer needed to be purchased with Smart Schools funds.

Based on these factors, the district determined it was most cost-effective and beneficial to reallocate the funds toward additional Chromebooks and leave the remaining funding open for future Smart Schools projects, rather than purchasing printers or Chrome licenses. This strategic shift maximized the impact of the Smart Schools funding while aligning with the district's evolving technology infrastructure and instructional goals.
