

### MINUTES OF THE CHELSEA SCHOOL COMMITTEE MEETING

### **December 5, 2024**

### **APPROVED 1-2-2025**

The Chelsea School Committee held a meeting on December 5, 2024, in the City Council Chambers, City Hall, 500 Broadway, Chelsea.

Having 8 school committee members present and 1 member absent, the meeting proceeded.

**School Committee minutes:** Ms. Balderas motioned to accept the meeting minutes of the Regular Meeting on November 13, 2024 and commend them to the record. Vice Chair Cabral seconded the motion.

### **Public Comment:**

- Kathryn Anderson of 15 Powderhouse Terrace spoke in support of the resolution reaffirming Chelsea as a sanctuary city. She shared that she thought it was important to this was reaffirmed so families who feared being separated, felt safe. She added her appreciation for the gender identity piece in the resolution
- Ana Vanegas resident of Chelsea and immigrant of Guatemala. She shared her support for the resolution and it was important that students felt safe.
- Andy Fisher (did not state address), spoke of support of the resolution stating that it was an opportunity to offer protection to the youth.

#### **Presentations:**

- *Name, Strength, & Story Awards* were presented to crossing guard Emmanuel Garcia, CHS AP teacher Denise Grannis, and AVID/La Vida manager Jackie Boyd. Dr. Abeyta shared a message received from a caller who shared her gratitude from Crossing Guard Garcia (Smiley Manny).
- Dr. Abeyta then presented Monica Lamboy with an Outstanding Achievement award on behalf
  of Cabinet and the Chelsea School Committee. She thanks her for her years of service and for
  being committed and compassionate during Covid, and for holding CPS fiscally responsible over
  the years. Members of the committee also shared their heartfelt appreciation and thanked Ms.
  Lamboy for answering their budget questions over the years, and the work she put into the bigger
  projects like the CHS library and cafeteria.
- Dr. Abeyta then presented outgoing 2024 Chair Hernandez and Vice Chair Cabral with awards for their service during the 2024 term.

### **Report of the Superintendent of Schools:**

**Indicators of Success:** Mr. Howshan presented the <u>Indicators of Success</u> for the month of November. Some highlights from the indicators she presented were:

- Attendance for the month of November averaged 95% district wide for grades 1-8 stating they were similar to October's numbers but a little higher YTD than last year.
- Mr. Howshan shared that the dropout rates were lower YTD than last year.
- The district's mobility rate was 52 students in and 60 out.
- Mr. Howshan shared CHS failing grades for both 9th and 10th graders stating they were also lower than last year.
- Dr. Neville asked about retention rates and Mr. Howshan answered that those numbers are seen at the end of the year and are for students who do not receive enough credit to move onto the next grade.

**Student Representative Updates:** Student representatives Vanessa Lopez and Diana Salinas Garcia shared updates from Chelsea High.

Here are some of the highlights they shared:

- Winter sports season is beginning and the CHS football team held their last game
- Snow Angel Play from 12/5/24-12/7/24
- CHS Winter Concert would be held on 12/10/24
- Students would be hearing back regarding early decisions over December break and other college applications are fast approaching
- College & Career nights were successful and one was held in the evening so parents could attend
- Winter Formal coming up will be LaLa Land theme
- Donation opportunities: Crossing Guard fund led by CHS teacher Sarah Ruddy and Toy Donation drive led by Student Rep. Vanessa.
- NHS having Candy Bag Sale up until 12/18.
- Student Achievement: 4 students received full rides to Amherst College through the QuestBridge scholarship

**Committee Reports:** Dr. Abeyta went over the Personnel and Enrollment reports to commend them to the record. Ms. Balderas motioned to accept the subcommittee reports and commend them to the record. Vice-Chair Cabral seconded the motion.

Item #: 24SC96: Dr. Neville provided a First read of Resolution Affirming Chelsea Public Schools' Status as a Sanctuary District that Welcomes and Educates Students of all Immigration Statuses and Gender Identities/Expressions. Dr. Neville then shared her reason for putting forth the resolution and how she felt it was important to publicly state that families are safe and welcome and people should still continue to seek services and not be afraid. She added that it was also important to add protection for our trans students because of the rhetoric. She stressed the importance of being prepared to call upon the State to be prepared if federal funds are threatened. Members shared their thoughts on the resolution. Mr. Gomes-Pereira encouraged members to hold City Council accountable and to apply pressure and organize at the State level. Ms. Covas Caraballo reminded folks that both CPS and the City have shared their commitment to welcoming all since the elections, and she asked if there could be legal advice sought to make sure we are covering all possibilities and mentioned bringing others into the conversation to discuss because of the nature and magnitude this could have. Ms. Alfaro shared her experience when in 2008 and 2016 school committee and members of the community organized to help protect the community. She added that this also affects our Haitian families and we need to reemphasize that families should not be afraid. Chair Hernandez that the committee would work together to make this a strong resolution and would bring this to a special meeting to work on.

**Communications:** Clerk Dyer-Medina shared three late communications submitted via email to members.

• Mr. Gomez Pereira congratulated the QuestBridge scholarship recipients and to all those who are receiving scholarships. He wished them the best of luck.

### **Chelsea Public Schools Cell Phone Policy**

Cell phones are a normal means for parents/guardians to coordinate after-school activities, schedules, and transportation issues. However, in the classroom cell phones are a distraction, taking away from the educational process by decreasing classroom engagement, hindering student communication, negatively impacting school culture, and limiting student success. Recognizing this reality, the following policy will apply to cell phones within the above schools:

<u>Prohibited Cell Phone Use</u>—No cell phones in classrooms, while out in the hall during class time, or during any other part of the school day, including lunch and free periods. Cell phones (and other electronic devices) must be turned off at the time and place designated by individual school procedure, and cell phones must be put into the container, pouch, or other storage area designated by the school.

Any student who repeatedly violates the cell phone policy will have his or her phone confiscated, lose the privilege to carry a cell phone in school, and will need their parent/guardian to come collect the phone and discuss the potential further disciplinary action.

Photography and videography are prohibited in school or on school grounds without prior permission. Use of the cell phone in unauthorized ways, including unauthorized picture taking or filming, harassing and bullying behavior, or a complete disregard for the policy, may result in more serious disciplinary actions.

Though the school will secure the phone, the ultimate responsibility for any loss or damage remains with the student.

Any parent/guardian who feels the need to reach his or her child during the school day is asked to call the main office of the designated school. In the case of an emergency, students can be reached quickly.
