Having 7 school committee members present and 2 absent, the meeting proceeded.

School Committee minutes: Ms. Henriquez motioned to accept the meeting minutes of the Regular Meeting on September 5, 2024 and commend them to the record. Ms. Covas Caraballo seconded the motion.

Presentations:

- Dr. Abeyta announced this month's Name, Strength, & Story Awards. The following recipients
 received the award for the month of October: Miguel Hernando-CHS Bridge Academy Teacher,
 Carlos Cora-CHS School Counselor, Samuel Vega-Berkowitz Elementary School Teacher, and
 Meg Maccini-Principal of Chelsea Virtual Learning Academy. All recipients were recognized
 for their outstanding commitment to their students.
- Dr. Abeyta recognized the Berkowitz Elementary School for a special School Recognition Award for their achievement and great strides made with their MCAS scores. The Berkowitz school had a 7% increase in ELA and a 23% increase in Math. The Department of Elementary and Secondary Education has identified them as a School of Recognition.

Chair Hernandez brought the agenda back to order at this time.

Public Comment:

Vanessa Mendoza-Mercado-CTU Vice-President/Chelsea Resident: 318 Chestnut Street, Chelsea, MA Shared her support of the contract negotiation proposal proposed by CTU. She shared that 20% of CTU are residents of Chelsea and like her love their community. She asked to value supporting schools.

Brittany Fitzgibbon: 74 Hadley Street, Malden, MA

Shared her support for the parent leave proposal from CTU. She her experience with parent leave and financial anxiety that she experienced during and after pregnancy.

Sam Chirco: 74 Hadley Street, Malden, MA

Shared support for the parental leave proposal stating that it was the only ethical choice.

Elias Carver: 11 Spring Street, Malden, MA

Shared support for class size caps. He shared his experience in teaching 2 class sections one with 38 students and the other with 40.

Alison Gorman: 9 Crush Lane, Burlington, MA

Shared support for parental leave. She spoke about the new Massachusetts law that went into effect except for within public schools. She shared her experience when she had her children and stated that what was being offered is not enough support.

Sarah McAllister: 410 Summer Street, North Andover, MA

Shared support for parental leave. She shared that she had to save up enough sick time over 6 years to afford maternity leave. She also touched on the special ed vacancies and as a special education educator, she is concerned for her students when she goes out on leave to have her child.

Gena Restiano: 7 Cedar Mill Road, Saugus, MA

Shared her concerns regarding class sizes. She shared her experience of having large numbers of students in gym class (more so with construction taking place at CHS), and how it is impossible to teach.

Kathryn Anderson-CTU President

She shared that CTU has been working without a contract since July 1 and that they have been bargaining since February. She stated that they have received 87% support from their members and have made some movement. She asked for getting rid of unnecessary meetings, review of living wages, and not doing business as usual.

Report of the Superintendent of Schools:

Indicators of Success: Dr. Blake-Canty presented the <u>Indicators of Success</u> for the month of September. Some highlights from the indicators she presented were:

- Attendance for the month of September averaged in the 90th percentile from grades 1-8 and in the 80s at the high school level.
- Drop out rates are 1.63% which are less than last year at this time.
- The district's mobility rate was 217 students in and 132 out.

MCAS Presentation: Dr. Abeyta shared a <u>presentation</u> on MCAS trends, accountability, and areas of growth. She shared that some trends mirrored where the State measured and that there was slight growth in Math. She classified the areas of growth as middle school & high school scores, and graduation rates. She lastly highlighted once again the Berkowitz school for their recognition for their growth in both ELA and Math.

Student Representative Updates: The three new student representatives introduced themselves: Vanessa Lopez, Diana Salinas Garica, & Rosalia Hernandez. Each representative shared a brief update. Here are some of the highlights they shared:

Family Night at CHS was a success. The Girls Volleyball team recently had a great comeback game. Cross Country would be starting October 18th. The yearbook club finalized their contract for the 2025 yearbook. NHS had their first bake sale. Students helped started an initiative to register voters at CHS. CHS will be hosting spirit week and pep rally soon.

Committee Reports: Dr. Abeyta went over the Personnel and Enrollment reports to commend them to the record. Ms. Covas Caraballo motioned to accept the subcommittee reports and commend them to the record. Ms. Balderas seconded the motion.








