

MINUTES OF THE CHELSEA SCHOOL COMMITTEE MEETING

September 5, 2024

APPROVED 10-9-24

The Chelsea School Committee held a meeting on September 5, 2024, in the City Council Chambers, City Hall, 500 Broadway, Chelsea.

Having 8 school committee members present and 1 absent, the meeting proceeded.

School Committee minutes: Ms. Henriquez motioned to accept the meeting minutes of the Regular Meeting on June 6, 2024 and the Special Meeting on June 10, 2024 and commend them to the record. Ms. Balderas seconded the motion.

Presentations:

- Dr. Abeyta announced and recognized the 2024 Butterfly Award Recipient Nina Silva Bowe of the Early Learning Center, and then announced the September 'Name, Strength, & Story' Award Recipient Max Benfield of the Chelsea Opportunity Academy.
- Human Resource Director Christine Lee then presented the educators who have earned Professional Status in the district for this upcoming school year.

Report of the Superintendent of Schools: At this time Dr. Abeyta called Ms. Lamboy up to provide an update on the Chelsea High School cafeteria construction project. Ms. Lamboy presented highlights on the renovation and expansion of the area. She went over the previous conditions and demolition. Ms. Lamboy provided a timeline of how the work began with surveys to receive feedback on the space and went over the plans that were concluded from the feedback. She explained and showed samples of how the student seating area, kitchen, and serving stations would look like once complete. She stated that the seating would increase and there would be more grab & go counters for easy access to students to shorten wait times. She then discussed the budget for the project and where the funds came from. She then shared when the projected completion of the project would be and how long students would have to continue with the outdoor dining while the project was underway. She described the additional safety measures being taken while students are eating in outdoor tents. She lastly extended her gratitude to the Buildings & Grounds crew for their efforts and the Construction company who is overseeing the project. Members thanked Ms. Lamboy for the update and Vice-Chair Cabral said that the space looks welcoming and reflects what students deserve. Ms. Covas Caraballo added that the space will look more modern. She then asked if the outdoor dining has added more stress to staff or if they have expressed concerns. Ms. Lamboy answered that she would defer that to Principal Morales. Dr Abeyta ended this update by thanking the educators for working through the changes.

Indicators of Success: Dr. Blake-Canty presented the <u>Indicators of Success</u> for the month of June. Some highlights from the indicators she presented were:

- Dr. Blake-Canty shared the attendance rates from June. She stated that grades 1-8 were in the 90% for attendance and all other grades had slight increases.
- Dr. Blake-Canty then reviewed 8th grade students enrolled in Algebra 1, AP Courses, Calculus Courses, Early College Pathways, and Dual Enrollment. All enrollments head steady with a slight drop in calculus. She pointed out the end of year numbers for Dual Enrollment being at a high of 231.

- Dr. Blake-Canty then went over iReady end of year progress monitoring results. There were increases in math and reading K-8m there was however a dip in reading in grade 8.
- Dr. Blake-Canty then reviewed AP course scores stating that there was 30% average number of students scoring 3 or more.
- Dropout rates were discussed the end of year percentage rate of 8.86% and broke this down by grade and programming. There were a total of 30 withdrawn with 29 destination unknown. She then provided the mobility rate ending with 771 in and 488 out.
- Dr. Blake-Canty then discussed the failing grades a the high school for students in grades 9 &10 with a total of 21.8% of 9th graders and 10.5% of 10th graders being retained.

At this time Dr. Neville added that the numbers don't always pain the whole story for students and that it was important to keep an eye on trends. Dr. Abeyta then turned the presentation over to Ms. Lee to go over retention numbers.

• Ms. Lee shared that 12% of staff left CPS; which was a decrease from previous years. She broke down the retirements and those who left on their own. She stated that the diversity has increased by 17% in the district.

Committee Reports: Dr. Abeyta went over the Personnel and Enrollment reports to commend them to the record. Ms. Balderas motioned to accept the subcommittee reports and commend them to the record. Ms. Henriquez seconded the motion.
