Purpose: Deliver comprehensive school health services
Reports To: Building School Nurse, Building Administrator and Lead Nurse

Qualifications:

- Graduate of an accredited Licensed Practical Nurse (LPN) program
- A valid and current Licensed Practical Nurse (LPN) License by the Commonwealth of Massachusetts
- Valid CPR and First Aid Certification by a recognized provider, renewed biannually
- School nursing experience preferred

Essential Duties and Job Responsibilities: (*other duties may be assigned*)

- Deliver 1:1 nursing care and monitoring during school hours and bus transportation (if required).
- Administer medications and treatments per the student's physician orders and IHP (e.g., tracheostomy care, ventilator support, seizure management, G-tube feedings, insulin).
- Monitor vital signs and overall health status; document and report changes or concerns promptly.
- Respond appropriately to medical emergencies; follow the student's Emergency Care Plan (ECP).
- Maintain accurate, daily nursing documentation per DESE and MA Department of Public Health guidelines.
- Collaborate with the school nurse, special education staff, therapists, and the student's family.
- Assist student with mobility, positioning, feeding, toileting, and classroom participation as needed.
- Maintain infection control and hygiene standards in all school settings.
- Participate in training sessions related to student care, as appropriate.
