No-Go List Policy

In accordance with [BP3620](#)

Mission Statement: *We value people and we love to learn.*

Our mission is to prepare students for success after graduation. Students who violate school or district policy are placed on the No-Go List.

What is the No-Go List?

This is an internal list of students who have violated a school policy or earned a fine. This list consists of students who have had their privileges temporarily suspended from school activities.

No-Go Minga Sticker Overview and How Students May Obtain:



= Discipline

- **Overview:** Students who are suspended are automatically on the No-Go List for at least six (6) weeks. Additional reasons include overall failure to follow through with detentions assigned, habitual absences, and other repeated behaviors.
- **How can a student get more information?** Reach out to your assigned Assistant Principal for assistance.



= Lunch Detention

- **Overview:** Students who are on the No-Go List for Detention are issued once they fail to serve a detention that was assigned for attendance reasons (e.g. tardy, truancy, leaving class without permission, excessive absences).
- **How can a student get more information?** Reach out to the LSS, Mr. Derris, located in the Admin Building near the Finance Office.
- **How can a student get off of the No-Go List for Attendance?** Serve detention on Wednesdays in Oak on the 2nd floor (common area).



= Fine is owed

- **Overview:** Students who owe a fine for a lost or damaged Chromebook, athletic uniform/gear that has not yet been returned, missing textbooks, missing library books, etc. Students will be removed as soon as the fine is resolved. Students may reach out to the Finance Office for assistance.
- **How can a student or parent find out why a fine is owed?** Login to your Aeries portal and click on "Fees & Fines."
- **How can the fine be paid?** Pay online through the Student Store and select "Open Items," then pay the amount that is showing in Aries. Email kcleveland@rjuhsd.us to request step-by-step directions if you need additional support. Students can also pay fines directly at the Finance Office with cash, check, or credit card (additional fees may be applied for payment with credit/debit cards).
- **Library Books & Textbook Fines:** If you owe a fine for a missing book, you may turn in your book to the Library and it will remove the full amount of the amount due if there is no damage.



= Attendance

- **Overview:** Students who have excessive absences and/or tardies (often also placed on a SART, Attendance Contract).
- **How can a student get more information?** Visit the Assistant Principal Office.
- **How can a student get off of the No-Go List for Attendance?** Reach out to your assigned Assistant Principal or their Secretary for assistance.



= Data Confirmation Incomplete

- **Overview:** Students who do not have their annual Data Confirmation completed by Panther Pick-Up Days will receive this sticker.
- **How can a student get more information?** Share [this letter](#) we send out regularly to families who have not completed Data Confirmation so they can update their student's information as soon as possible.
- **How can a student get off of the No-Go List for Attendance?** Once the student's parent or guardian completes Data Confirmation ([more info](#)), the student will be removed from the No-Go List. This is updated daily for the first few weeks of school.

What activities can't students attend?

Any school-wide leisurely activities, such as attending an athletic game, dance, or rally, just to name a few. (Athletes may still participate in their sports, but they may not attend any other sport or event

as a spectator.)

What happens if the student already paid to attend an event prior to being placed on the No-Go List?

Refunds may not be issued.

How do students know if they are on the No-Go List?

It will appear as a sticker on the student's [Minga digital ID](#) which can be seen on the app (if downloaded on their phone) and on their school-issued device when logged into their account.

What happens if a student who is on the No-Go List sneaks into an event?

Students who proceed to attend a function that they were explicitly instructed not to attend may result in further disciplinary consequences.
