As of July 31, 2024, the current year (2023) adjusted tax levy is \$254,508,809.

Through July 31, 2024, 99.73% or \$253,838,498 of the 2023 adjusted levy has been collected (October 2023 – July 2024).

The balance to be collected of the 2023 adjusted levy is \$670,311.

Delinquent taxes to be collected from prior year levies total \$2,275,751.

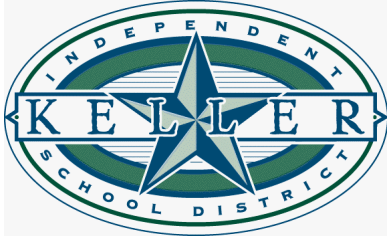

Delinquent taxes to be collected from prior year levies total \$2,297,183.

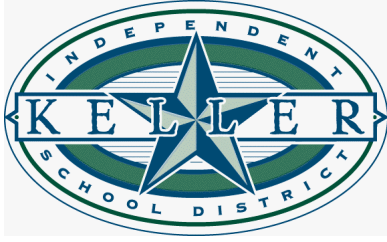

Delinquent taxes to be collected from prior year levies total \$2,325,254.

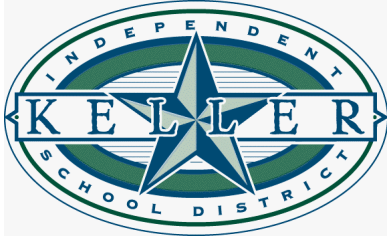

Delinquent taxes to be collected from prior year levies total \$2,778,485.

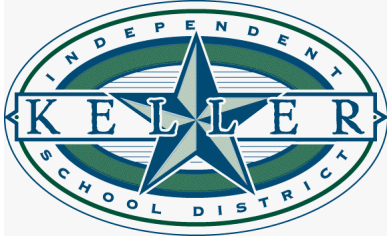

As of March 31, 2025, the current year (2024) adjusted tax levy is \$271,488,671.

Through March 31, 2025, 96.44% or \$261,834,244 of the 2024 adjusted levy has been collected (October 2024 – March 2025).

The balance to be collected of the 2024 adjusted levy is \$9,654,427.

Delinquent taxes to be collected from prior year levies total \$1,926,822.

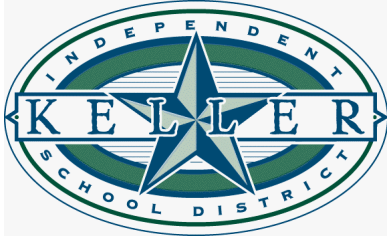

Delinquent taxes to be collected from prior year levies total \$2,206,479.

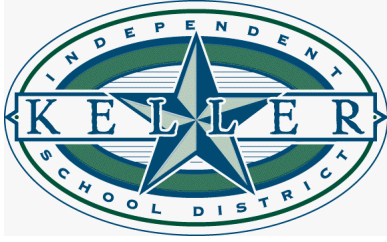

Delinquent taxes to be collected from prior year levies total \$2,267,594.

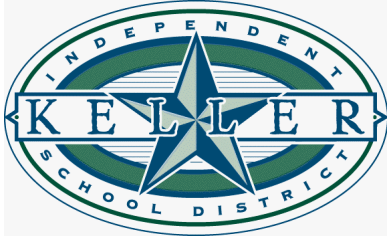
