School Board Briefs

March 14, 2018

At the March 13, 2018 School Board meeting the Central Bucks Board of School Directors:

Approved the minutes of the February 27, 2018 School Board meeting.

Received the Curriculum Committee, Finance Committee, Operations Committee, Policy Committee, BCIU Board, and MBIT Executive Council minutes.

Approved the February 28, 2018 and March 6, 2018 General Fund check disbursements; the February 22 Capital Fund check disbursements; and the February 22, 2018 Food Service check disbursements.

Accepted the 2016-2017 audit report as prepared by Maillie LLP.

Approved the contract with Green Ridge Landscaping for District-wide grass cutting and lawn care services for the remainder of FY17/18 in the amount of \$48,708.00 and all of FY 18/19 in the amount of \$115,128.00. The term shall be a one-year period, 7/1/18 – 6/30/19 with the option mutually to renew a successor agreement annually for an additional four (4) years with no percentage increase.

Approved the contract with Five Star Mechanical for the condenser water pipe sleeve installation at Groveland Elementary School for a total contract amount of \$59,700.00.

Approved the contract with Donald Reisinger, Inc. for the CB East High School Natatorium Renovations General Construction Contract Base Bid and Alternate Bid #2 for a total contract amount of \$111,000.00.

Approved the contract with Rogers Mechanical for the CB East High School Natatorium Renovations Mechanical Construction Contract Base Bid and Alternate Bid #1 for a total contract amount of \$304,500.00.

Approved the contract with Yates Electrical Service, Inc. for the CB East High School Natatorium Renovations Electrical Construction Contract Base Bid and Alternate Bid #1 and #2 for a total contract amount of \$60,000.00.

Approved the contract with Fisher Mechanical for the CB East High School Natatorium Renovations Plumbing Construction Contract Base Bid and Alternate Bid #1 and #2 for a total contract amount of \$27,980.00.

Approved the continued waiver of facility use fees for certain outside groups who have not been charged a fee in the past.

Approved the purchase and installation of the School Gate Guardian – School Visitor Management System (Self-Service Kiosk) from School Gate Guardian, Inc. for 23 schools and 3 administration buildings at a total cost not to exceed \$150,000.00.

Approved the purchase and installation of a video door entry system District-wide for 23 schools and 3 administration buildings for a total not to exceed cost of \$102,000.00.

Tabled for First Read and Comment the following School Board Policies: Policy 140.1, Policy 142, Policy 143, Policy 144, Policy 146, Policy 150, Policy 200, Policy 202, Policy 203, Policy 204, and Policy 205.

Approved to maintain the following original existing policy as recommended by the Policy Committee: Policy 201.

Approved withdrawing from the Bucks and Montgomery County Schools Healthcare Consortium effective June 30, 2018.

Approved various personnel items and staff conferences/workshops.

Received a Sabbatical Leave of Absence request as a Board information item.

Dr. Kopicki announced that graduation would be held on Friday, June 15, 2018; April 30, 2018 has been changed to a full student day K-12; and that Professional Development will be held June 18-22, 2018.
