### **Description of Unpaid/Unfinished Bonds Previously Approved by Voters of the Jurisdiction:**

As of the 9th day of September, 2025, Independent School District No. 11, Tulsa County, Oklahoma, has 3 General Obligation bond issue(s) outstanding:

\$31,000,000 Combined Purpose Bonds of 2023, dated June 1, 2023 (\$30,000,000 outstanding in principal as of the 9th day of September, 2025);  
\$8,300,000 Combined Purpose Bonds of 2024, dated March 1, 2024 (\$8,300,000 outstanding in principal as of the 9th day of September, 2025); and  
\$33,660,000 Combined Purpose Bonds of 2025, dated March 1, 2025 (\$33,660,000 outstanding in principal as of the 9th day of September, 2025).

The School District has \$4,455,000 in unissued building bonds authorized at an election held on the 9th day of December, 2024. These bonds will be used to acquire vehicles for pupil transportation.
