Lenape Tech 2025-2026 Student-Driver Information

To ensure the safety and security of our campus, Lenape Technical School administration has developed rules and regulations for operation and parking of vehicles on school grounds. As stated in **Joint Operating Committee Policy 223**, *“the use of motor vehicles by students for travel to and from school is a privilege. Parents and students are expected to read and comply with all driving/parking/riding regulations should they elect not to use bus transportation.”*

Students must have a legitimate reason to drive to school and will be required to provide appropriate documentation to verify the permit request/need.

All parking on school grounds is by permit only. Any unauthorized/unregistered vehicle on campus shall be detained and/or towed at the owner’s expense along with notification to law enforcement. Failure to comply with these regulations may forfeit any current or future parking privilege. Due to the limited parking space available, these regulations will be strictly enforced.

Parking permits will be issued beginning with 12th grade drivers on a first come, first served-basis. Remaining spaces will be made available to 11th graders. Permit applications will be made available in the main office for full and part-time 11th and 12th grade student the first week of school. Sophomores must ride the school bus. **There are no advanced sales/applications of permits.** Permits cannot be processed unless all required information is submitted at the same time (see application).

Upon approval of the permit application, students will be issued a numbered permit. Students will only park in their assigned space unless otherwise directed by school staff. The cost of the permit is \$25. **Drivers will enter the school using the gym entrance each day.** For students needing to drive due to an appointment, interview, or other parent-verified reason, a One-Day permit may be purchased in the main office for \$1. Students will be limited to five (5) One-Day permits per school year unless otherwise approved by an administrator.

As parking spaces become less available, students are encouraged to submit their application and documents to be placed on a waiting list. They are not to be driving/parking on campus until approval has been made. Those students enrolled in an approved cooperative education (co-op) employment experience will still need to submit an application and required documentation to receive a permit. Students on co-op are given priority.

It is important that both parents and students read and understand our student-driver information provided in the application. Please contact the main office at 724-763-7116 with any questions concerning this policy. Thank you and we look forward to the 2025-2026 school year!
