The Hampton Township School District is offering a property tax rebate program to senior citizens, widows, widowers and disabled persons with limited incomes who applied for and received a Pennsylvania Property Tax Rebate for the 2024 year. In order to qualify for the Hampton Township School District Rebate, the maximum reported income on the applicant’s approved 2024 PA-1000 application – Line 13 must be \$36,000 or less. The Hampton rebate does not include the supplemental rebate that is added to some applicant’s rebates by the State.

The 2025-2026 Hampton Property Tax Rebate amounts are as follows:

A rebate is available, upon filing an application, to a person **owning** and **residing** in a primary residence within the Hampton Township School District. The District rebate is calculated using the income information from the 2024 PA-1000 form and the amount of 2025-26 school real estate taxes paid.

Rebate applications must be filed at the Business Office in the School District Administration Building 4591 School Drive, Allison Park, PA 15101 no later than **April 30, 2026**.

Q. Did you remember to file your Pennsylvania State Property Tax Rebate?

- A. In order to apply for the Hampton Township School District Property Tax rebate, you must first file a Property Tax Rebate with the Pennsylvania Department of Revenue. To obtain this rebate, an applicant must file Form PA-1000 "Pennsylvania Property Tax or Rent Rebate" with the PA Department of Revenue. **A signed copy of this form is required to be filed with your Hampton Township School District Rebate Application.** You may obtain Form PA-1000 by calling (800) 362-2050 or by visiting the Pennsylvania Department of Revenue's web site at https://www.revenue.pa.gov/FormsandPublications/FormsforIndividuals/PTRR/Documents/2023_pa-1000.pdf

Q. Who can file a Hampton Township School District Property Tax rebate claim?

A. In order to qualify for a Hampton Township School District Property Tax Rebate:

- You must have applied for **and** received a 2024 Pennsylvania Property Tax Rebate (form PA-1000)
- You must have **owned** and **occupied a residence** within the Hampton Township School District during the 2024-2025 school year.
- You or your spouse must have been at least 65 years old as of December 31, 2024.
or
- You were a widow or widower during all or part of 2024 and must have been 50 years or older as of December 31, 2024.
or
- You were permanently disabled during all or part of 2024, 18 years or older during 2024 and were unable to work because of a medical determined physical or mental disability.
- Your total 2024 household income, including your spouse's, must have been \$36,000 or less. Note: Fifty percent (50%) of social security/railroad retirement income can be excluded in determining income limits.
- You or someone on your behalf must have paid the school district taxes on the residence for 2025-26. The payment must have been made on or before the date of filing the claim.
- Only one member of each household may file a claim even if more than one person is qualified to receive a rebate.

Q. What is the income limit for the Hampton Township School District rebate?

A. To qualify for the Hampton Township School District Property Tax Rebate Program, an applicant may have annual income up to \$36,000 (50% of any social security/railroad retirement income is excluded). The Pennsylvania rebate program allows for annual income of up to \$46,520. **Therefore, some residents will qualify for the Pennsylvania program, but not the Hampton program.**

Q. Can I file a claim form for someone who has recently died?

A. You may file a claim for an eligible claimant, who **died after December 31, 2024.**

You may not file a claim if the claimant **died during 2024.**

The law governing the Property Tax Rebate Program requires that a claimant must have lived for the entire 2024 calendar year in order to receive a rebate.

If you are filing a claim for an eligible decedent, please include "Estate of" before the claimant's name.

Q. What do I attach to my form to claim a property tax rebate?

A. You will need to provide a copy of your **receipted 2025-26 school tax bill** for the year claimed. Canceled checks are not acceptable. If your name does not appear on the tax bill, proof of ownership must be submitted. Proof of ownership can be in the following forms: a copy of the deed, trust, will, or decree of distribution. If the address is not on the receipted bill or mortgage statement, a letter from your tax collector or mortgage company verifying your home address must be submitted.

You also must submit a signed copy of Form PA-1000 "Property Tax and Rent Rebate Program" 2024 application as submitted to the Pennsylvania Department of Revenue and a copy of the State rebate check or bank statement verifying a direct deposit that was issued to you.

Copies of Forms W-2, 1099-INT, 1099-DIV, 1099-R, 1099-MISC, SSA-1099 or copies of your federal income tax return or your PA tax return for the claim year are not required when filing your claim form. However, copies of these forms may be required to be submitted to substantiate your income if your return is selected for audit purposes.

Q. What is the total amount I can be eligible to receive as a rebate?

A. The maximum amount that you may be eligible to receive as a rebate is \$1,040. The school district rebate is based on school district property taxes only. The amount of the state and school rebates cannot exceed the 2025-26 school real estate tax bill. If this happens, the school rebate will be reduced to equal the school real estate tax bill.

Q. If I am eligible, how do I obtain my tax rebate?

- A. All eligible taxpayers must file a Tax Rebate Claim Form with the district and include a signed copy of the PA-1000 for 2024, a copy of your state rebate check or a copy of the bank statement depicting the direct deposit receipt, and a copy of a receipted 2025-26 school tax bill. The Tax Rebate Claim Form must be signed and dated and filed by the appropriate deadline to be eligible to receive a rebate.

NOTE: You must be approved by the state for the rebate before you can be eligible to receive the school district's rebate.

Q. When do I file my tax rebate claim form? Is there a deadline?

- A. The Tax Rebate Claim Form must be filed between July 1, 2025 and April 30, 2026. No Tax Rebate Claim Forms will be accepted **AFTER** April 30, 2026 for 2025-26 rebate claims.

Q. Where do I send my tax rebate claim form?

Q. Are there penalties for fraudulent claims to obtain a tax rebate?

- A. In any case in which a Tax Rebate Claim form is excessive and was filed with fraudulent intent, the claim shall be disallowed in full and the claimant or any person who assisted in the preparation or filing of a fraudulent rebate claim will be reported to the proper authorities.
