a. Interim Executive Director's Report Update

Dashboard is presented.

AC: What is Decreased enrollement due to?

KS: Issue between the parents for one of the kids, Someone moved away.

KJ: It's the personality of the teachers.

VM: These teachers are also the ones doing the most attendance-based incentives.

KN: So that's what the DOE schools do. Has anyone thought to have these teachers present their best practices?

VM: I actually shared those practices at morning meeting, and this is something we have been working on. As Ms. Jones said, the personalities are also very important.

b. Academic Leader's Report

KJ: I am almost finished with the observations. The Academic committee was concerned about retentions. I talked to the teachers and in K 3 are expected to be retained. In $1^{\rm st}$

grade, 4, and in 2nd 7. In 3rd grade it's 6 there are children whom we did not retained but are not catching up. In the 4th grade, 2 and in 5th 5 of 42.

KN: What happens if they do well from the state assessment.

KJ: We might discuss with the teacher if they score very high 3's. But, there are students who don't do well on assessments even do they behave well and do their work, and so I asked the teacher not to retain them.

CR: That's what the promotion policy is about.

JM: We did get approved for expansion 6-7-8.

VM: We have new schedules for our team so that they can be predictably in the classroom. They do character Ed in the morning in each class. They have office hours and also check in particular classes if necessary in the afternoon.

I will start doing observations based on Marzano. It's a 3-page rubric adapted to our needs. That will start on Monday.

The Dean and I are working on Behavior intervention plans for some students.

Suspensions: 2^{nd} grade and 5^{th} grade are the greatest challenge. We had a big intervention with 5^{th} grade recently.

January was rough, we had to reinforce expectations.

JS: Why is 2nd grade so challenging?

VM: As Ms. Jones pointed out, we added an entire class, and so there's that, but they are right next to the suite so we are working on that.

6:33 d. Operations Report

KS: As Josh Explained our total enrollment is 328. For kindergarten lottery was 149, last year we had 199, lottery ends April 1st. 197 kids on the waitlist for 1-6. We have 66 kids for the 3rd grade waitlist. For Staff Recruitment, Karent, Val, Josh and I are working with Kent on this. We are breaking it up between us and making sure the process is uniform. The job fair is Match 6th, and later in the month there is a student recruitment fair.

b. Education Committee - Cecelia Russo

CR: We had 2 conference calls, what was said by Karen and Valerie and what was in January minutes will suffice.

c. Financial/Operations Committee – Angel Charriez

Building: FV: The building is generally stable. For instance we had a call recently that it is excessively cold in the gymnasium, hopefully this has been fixed. There was a leak at the

Cafeteria issue but it has been temporarily fixed. The Vault: Catholic Charities contacted us to say we were responsible for to secure the vault where the oil tank is. The oil tank is in front of 72 Lewis, instead of 82 Lewis. Expenditures wil be about \$25,000 over the next 4 months. They wrote us a letter asking how we will pay that. We need to pay 5,500 tomorrow, and then 5,500 next month.

KN: Are we subject to their payment schedule?

P: This is our payment schedule.

IS: What about the heat?

JM: We were low on oil, the cash is tight, and it was cold for one day last week.

JS: How would we know that our school is closed because the heating is not working?

JM: Someone complained and we received a warning.

It is the Executive Director's responsibility to warn the Board if the school has to close.

Last time I mentioned I would talk with leaders at John Jay. We talked about afterschool, how to get CUNY students to be involved. We talked about educating towards justice. Some students are interested in having an even in Juvenile justice, they would like their event to have a donation-admission that would go to our school. The event is in April. They need to know from us what supplies we need, we might think of a particular item we want.
