



Parents' Guide to Student Achievement (PGSA) **Based on Parents' Bill of Rights - SB 49; Session Law 2023-106**

Duplin County Schools (DCS) recognizes the critical role of parents in the education of their children and in the schools. The Board directs school administrators to develop programs that will promote and support parental involvement in student learning and achievement at school and home, and encourage successful progress toward graduation. Each parent is encouraged to learn about the educational program, the educational goals and objectives of the school district, and his or her own child's progress. The Board also encourages parents to participate in activities designed by school personnel to involve them, such as parent conferences, to encourage effective communication. If parents are unable to access this document electronically, printed copies are available at each school.

Our aim must be that all students have the reading, writing, language, mathematics, and computing skills to be successful at the next level of schooling. Third Grade Promotion Guidelines**Read to Achieve Requirement for meeting Third Grade Promotion Standards:**

- a. Proficient score on BOG 3 **or**
- b. Proficient score on grade (EOG) reading assessment **or**
- c. Pass state-developed alternative assessment (Read to Achieve Test) **or**
- d. Meet 70% proficiency on passages in the portfolio **or**
Meet the state-approved diagnostic assessment end-of-the-year score for literacy and reading

Good Cause Exemptions if a student does not meet one of the Read to Achieve requirements for third-grade reading promotion listed above:

- Limited English Proficient students with less than two school years of instruction in an ESL program.
- Students with disabilities, as defined in G.S. 115C-106.3(1), and whose individualized education program indicates (i) the use of the NCEXTEND1 alternate assessment, (ii) at least a two school year delay in educational performance, or (iii) receipt of intensive reading literacy interventions for at least two school years. ([Guidance Document](#))
- Students who demonstrate reading proficiency appropriate for third-grade students on an alternative assessment approved by the State Board of Education. (725 Lexile on mClass or STAR)
- Students who demonstrate, through a student reading portfolio, reading proficiency appropriate for third grade.
- Students who have (i) received literacy interventions and (ii) previously been retained more than once in kindergarten, first, second, or third grades.

Promotion Guidelines in Grades Four to Eight

1. Progress toward proficiency in both reading and mathematics
2. Class coursework – passing reading, mathematics, language, and two (2) other subjects
3. Age and maturity of the student
4. Attendance record
5. Number of times retained previously
6. Student work samples/portfolios
7. Input from Others (i.e., parents, resource teachers, outside agencies, etc.)
8. Other pertinent information and assessment data deemed appropriate to use in determining a student’s preparedness to perform at the next grade level
9. Progress in appropriate and focused intervention to assist the student in meeting grade-level expectations.

High School Promotion Requirements

9th grade to 10th grade English I and NC Math 1 plus 4 units = 6 units of credit

10th grade to 11th grade English I and II plus 11 units = 13 units of credit

11th grade to 12th grade English I, II, and III plus 17 units = 20 units of credit

- Mid-year promotions are not permitted, except in cases where a HS student was previously retained.
- Students approved for the three-year accelerated graduation track will graduate as 11th graders without participating in senior activities or receiving senior privileges, unless they meet the established criteria for promotion to Grade 12 at the conclusion of their sophomore year (including but not limited to Homecoming senior court, Prom King or Queen, senior parking, etc.).
- Please note that senior privileges do not include participation in graduation ceremonies or graduation-related services (e.g. Baccalaureate).

Three-Year Accelerated Graduation Track
 Duplin County Schools encourages students to complete a minimum of 28 credits and four years of secondary education before graduating from high school. We offer additional electives, Advanced Placement, and dual enrollment courses that prepare students for college, a career, or the military. However, we understand that in some circumstances, completing 28 credits does not align with some students' future educational and/or career goals. In this instance, students may choose to graduate in 3-years upon completion of 22 required credits. What is my child learning at school? How can a parent review these materials?

Parents may request to inspect district textbooks and other supplementary instructional materials, request information to purchase district textbooks and other supplementary instructional materials from third-party vendors, at the parent's expense, or review all available records of materials my child has borrowed from a school library by submitting this [FORM](#) to the school principal.

State Assessments:

Individual Student Reports for end-of-grade/course tests and other state assessments (English language proficiency assessment) are accessible in the Infinite Campus Parent Portal.

In NC, all students take end-of-grade assessments for reading and math in grades 3-8. Students take end-of-grade science assessments in grades 5 and 8. In high school, students take end-of-course assessments in English II, Biology, NC Math 1, and NC Math 3.

Students in Grade 3 also take a beginning of grade (BOG 3) assessment in reading. Students in grade 3 who do not demonstrate reading proficiency on the BOG 3, reading end-of-grade assessment, or have a good cause exemption also take the Read to Achieve assessment at the end of the school year. Students in Grade 4 who are reading retained also take the Read to Achieve assessment in the fall.

Students in Grade 10 take the Pre-ACT. Students in grade 11 take the ACT. Students who are CTE Concentrators in Grade 12 take the ACT WorkKeys. Those results are shared by ACT.

An **Individual Reading Plan (IRP)** shall be developed for any student in kindergarten through third grade demonstrating difficulty with reading. An IRP will have specific strategies/ideas that can be done at home.

North Carolina's Department of Public Instruction (NCDPI) selected mCLASS DIBELS® 8th Edition as the state's K-3 Literacy Assessment. mCLASS is an integrated literacy system based on the Science of Reading. mCLASS has been revised and upgraded from the assessment that NC districts have used in the past, based on the latest research and the Science of Reading. It is a valid and reliable assessment, supporting universal literacy screening, screening for risk of dyslexia, and progress monitoring.

<p>What are the qualifications of my child’s teachers?</p>	<p>Parents may look up your child’s teacher licensure status at the NCDPI Online Licensure System website. The licensure look-up webpage does not include current employment information. Parents may need additional information (i.e., middle name or license number) to identify the teacher accurately. Substitute teachers (either short- or long-term) may not hold an NC teaching license. Please contact your district’s Human Resources office to verify an educator’s licensure status.</p>
<p>What are the requirements for school enrollment? What are the immunizations needed or recommended for children?</p>	<p>Duplin County Schools uses Infinite Campus's digital enrollment platform for new student enrollment. New Enrollments to Duplin County Schools (never enrolled in a Duplin County School) may use this link to begin your enrollment or visit the school to enroll. If your child has previously been enrolled in a Duplin County School and you wish to enroll again, please visit the school, and they will assist you with logging in to your parent portal account for registration. Students who were enrolled in Duplin County Schools for the 2024-2025 academic year should not enroll. What are the rigorous academic programs available to my child? How can I learn more about them?

DCS offers a variety of options for students to pursue their interests and develop skills at their academic level.

Career and Technical Education (CTE):

NC has made a significant investment in developing students and programs to meet the needs of the future workforce. Through Career and Technical Education (CTE) programs, Public Schools offer opportunities for students to develop career awareness in 5th grade, explore careers in grades 6-8, and experience leadership, career development, and career-aligned content in grades 9-12.

In Duplin County Schools, students in grades 6-8 have the opportunity to explore careers in all 16 of the career clusters using the Xello career development platform and through hands-on, innovative modules. Students also have the opportunity to learn more about themselves through a learning style inventory, interest inventory, and a durable skills credential that are all part of the DCS CTE middle grade program.

DCS students are able to experience leadership, career development, and career-aligned content from grades 9-12.

Academically and/or Intellectually Gifted (AIG):

In NC, school districts must identify and serve academically or intellectually gifted (AIG) K-12 students. These are students who are performing, or have the potential of performing, at high levels of accomplishment in intellectual and/or specific academic areas, such as reading and/or math, when compared with other students of their age, or in their grade level, experience, or environment.

DCS has developed an *AIG website* to help parents better understand the AIG program. This describes how students will be identified and served across grades K-12. Visit [this link](#) for parent information.

In DCS, students are often provided the following services:

- Differentiated curriculum and instruction with flexible student groups;
- Accelerated opportunities (subject and/or grade acceleration, honor courses, credit by demonstrated mastery (CDM), AP/IB/CIE courses, dual enrollment courses;
- Enrichment experiences, which may be during the school day or beyond, and may be within the regular calendar year or may include summer opportunities; and
- Other opportunities for the extension of the content standard.

Services for AIG students may be provided by AIG personnel or within the regular classroom by teachers trained to meet the needs of gifted students. Contact the district/school AIG Coordinator with questions, *Lindsay Skidmore*, lskidmore@duplinschools.net.

Honors Level Courses:

DCS students have access to a variety of honors-level courses in high school. These courses are available in the course catalog located at [this link](#). Honors-level courses typically have a faster pace than standard-level courses. They offer additional rigor, complexity, and creativity than standard-level courses.

Career and College Promise (CCP):

DCS partners with James Sprunt Community College to offer dual enrollment opportunities through the CCP program. If your high school student qualifies, students may earn high school credit by completing community college coursework.

CCP courses may be taken in the College Transfer or Career and Technical Education pathway. These courses count for both high school and college credit. Tuition is free for families.

Duplin Early College High School:

Duplin County Schools also partners with James Sprunt Community College to offer Duplin Early College High School (DECHS). Early College High Schools provide an opportunity for students to earn both a high school diploma and an associate’s degree and/or CTE credentials at the same time. Students can stay for an additional fifth year to complete their credentials before graduating from high school. DCS students complete an application process if they wish to be considered for enrollment at DECHS. Application information is provided to students in the spring of their eighth-grade year. Advanced Placement (AP) Courses:

Advanced Placement (AP) is a program developed by the College Board to offer college-level curricula and examinations to high school students. In NC, 40 Advanced Placement courses are offered in public high schools. DCS offers AP courses in the following schools:

Students also have access to additional AP courses through the North Carolina Virtual Public School (NCVPS). Several AP courses satisfy graduation requirements for NC students as outlined in [State Board policy](#). AP exams are free for NC public high school students enrolled in these courses.

Colleges and universities may likely offer college credit for these courses if your child scores a 3 or above on the exam. All of the colleges in the UNC System offer credit. More information is available on the [NCDPI AP website](#).

Accelerated Access

NCVPS:

[North Carolina Virtual Public School \(NCVPS\)](#) is NC's state supplemental program and leader in online education, providing inclusive learning opportunities for students across the state. Founded in 2007, with a strong commitment to ensuring quality education for all students, regardless of location, NCVPS has over 16 years of experience serving diverse learners.

Students may enroll in NCVPS courses for a variety of reasons. Work with your school counselor if you are interested in taking an NCVPS course. DCS high school students may register for any NCVPS course for which they meet course prerequisites, as long as there are district enrollment slots available.

Advanced Course Options for Middle School

Middle school students in seventh or eighth grade who demonstrate readiness shall be granted the opportunity to take high school courses. These courses will primarily be offered online through North Carolina Virtual Public Schools (NCVPS). Upon successful completion of the course, the course will appear on the high school transcript and count towards high school graduation requirements, but will not count in the student's high school grade point average.

Current course options:

- 7th Grade:
 - World History
 - Foreign Language - Spanish or French
- 8th Grade:
 - NC Math 1
 - World History
 - Earth/Environmental Science
 - Foreign Language - Spanish or French

Eligible students will receive letters informing them of the registration process during the Spring semester. Each school will hold a parent information session in April/May to share more information and answer any questions. More information can be found at [this link](#).

Credit by Demonstrated Mastery (CDM):

DCS offers opportunities for students in grades 9 through 12 to earn course credit by demonstrating mastery of course material without first completing the regular period of classroom instruction in the course. Students in grades 6 through 8 may earn credit by demonstrating mastery for high school courses offered in middle school. To earn credit by demonstrated mastery, students must demonstrate a deep understanding of the content standards and application of knowledge through a multi-phase assessment, following standards established by the State Board of Education and any additional standards established by the superintendent.
