**Student Enrollment Policies**

**Tier 1 students** include the following applicants:

- Students who are enrolled in a NJ public school in their resident school district during the time of application and for the entire year immediately preceding enrollment in a choice district.
- A student who moved during the school year and attended their resident district schools.
- Students who attend a choice district that terminates before 12th grade and have reached the final grade.
- Charter school students.
- To qualify as Tier 1 for preschool or kindergarten, a student must be attending their resident district preschool, or a student has a sibling attending the choice district in the current year and the sibling will continue to be enrolled in the following year.

Choice districts must first fill their available seats with Tier 1 students. If the number of Tier 1 applications exceeds the number of choice seats available, the choice district must hold a lottery to randomly select students.

**Tier 2 students** include NJ residents who have *not* attended their resident public school for the entire year immediately prior to enrollment in the desired choice district and do *not* otherwise meet the requirements for Tier 1. This includes students who have been attending public school outside their districts of residence or private school. Tier 2 students also include students applying for kindergarten who are **not** attending their resident district preschool and do not have a sibling attending the choice district in the current year.

**Choice districts are not obligated to accept Tier 2 students.** If a choice district accepts Tier 2 applicants, they may do so only *after all the qualified Tier 1 applicants have been accepted*. If the number of Tier 2 applications exceeds the number of choice seats available, the choice district must hold a Tier 2 lottery to select students.

**Enrollment preference** may be given to students in the following circumstances: 1) applicants with siblings enrolled in the choice district in the current year and will continue to be enrolled in the following year; 2) applicants who will have completed the terminal grade of a sending choice district (i.e., students who attend a choice district with grades that terminate before 12th grade and with a natural progression to the choice district); and 3) resident students of the choice district who move during the school year but *before the application deadline* and want to remain in the choice district the following year. The applicant's enrollment preference status will be determined from the information provided in this application and verified by the resident district.

Crest Memorial School has adopted the following policies regarding student enrollment:

The district gives <b>enrollment preference</b> to applicants with a sibling who is a currently enrolled choice student and who will continue to be enrolled in the following year, provided the applicant will enroll in a choice-approved grade/program and they meet any program-specific criteria, and the district has determined that a seat is available in the desired grade. <i>The district will receive additional choice seats above the NJDOE-approved choice enrollment maximum for sibling preference applicants who apply by the application deadline.</i>	Yes

The district gives <b>enrollment preference</b> to choice applicants who have completed the terminal grade of the sending district (i.e., students who attend a choice district with grades that terminate before 12th grade and have a natural progression to this choice district), provided there are choice seats available in the choice-approved grades/programs and the applicants meet any program-specific criteria. <i>The district will receive additional choice seats above the NJDOE-approved choice enrollment maximum for send-receive preference applicants who apply by the application deadline.</i>	N/A
d. The district gives <b>enrollment preference</b> to resident students who move <i>before the application deadline</i> . If resident students move and submit choice applications for the following year prior to the deadline, the district will give them enrollment preference, provided there are choice seats available in the choice-approved grades/programs and the applicants meet any program-specific criteria. <i>If the district has already reached its NJDOE-approved choice enrollment maximum, this preference will not apply.</i>	Yes
e. The district gives special consideration to resident students who move <i>after</i> the application deadline. Students in this situation may apply as late applicants and be added to the <i>front of the district's waitlist</i> , provided the students will enroll in a choice-approved grade/program and they meet any program-specific criteria. <i>No additional choice seats will be approved to accommodate these students.</i>	Yes
