#### Definitions:

<u>Digital Transmission of Sexually Explicit Content</u> means sending, forwarding, displaying, retaining, storing or posting sexually explicit, lewd, indecent or pornographic photographs, images or messages by or on a cell phone, computer or other telecommunication device:

- during school hours or school activities on or off campus;
- while on school district property during any recess, lunch, or leave periods on or off school district property; or
- beyond the hours of school operation of the behavior detrimentally affects the personal safety or well-being of school-related individuals; the governance, climate, or efficient operation of the school; or the educational process or experience.

<u>Disrupting the Learning Environment</u> means any intentional gesture, any intentional electronic communication, or any intentional written, verbal, or physical act or statement initiated, occurring, transmitted, or received by a student at school that a reasonable person under the circumstances should know will have the effect of:

- insulting, mocking, or demeaning a student or group of students causing substantial disruption in, or substantial interference with, the orderly operation of the school; or
- creating an intimidating, threatening, hostile or abusive educational environment for a student or group of students through substantially severe, persistent, or pervasive behavior.

<u>Third Parties</u> include, but are not limited to coaches, school volunteers, parents or guardians, school visitors, service contractors or others engaged in district business or activities that are not directly subject to district control at inter-district and intra-district athletic competitions or other school events.

<u>Mobile Devices</u> is defined as any personal mobile telephone, smartwatch, non-medical listening devices, and headsets/earbuds or other portable electronic communication device with which a user engages in a call or writes or sends a message or any device in which the use plays a game or watches a video, except that such term does not include school-issued devices.

#### MOBILE DEVICES IN THE CLASSROOM

Students in possession of a mobile device, including but not limited to cell phones, smartwatches, non-medical listening devices, and earbuds/headsets, while on school property or while attending school-sponsored or school-related activities will observe the following conditions:

- Mobile devices will be accessed and operated:
  - o In high school before school, after school, during passing period or at lunch, not during classroom instruction time, unless an emergency situation exists that involves imminent physical danger, or an administrator authorizes the student to use the device.
  - o In middle school only before or after the regular school day, unless an emergency situation exists that involves imminent physical danger, or an administrator authorizes the student to use the device.

- o In elementary school only before and after the regular school day, unless an emergency situation exists that involves imminent physical danger, or an administrator authorizes the student to use the device.
- Students may access their mobile devices to manage their documented medical condition in accordance with the student's health care provider orders and/or other written individual educational, behavioral needs, or Health Care Plans, as determined by the appropriate school team;
- Students will not use mobile devices in a manner that poses a threat to academic integrity, disrupts the learning environment, or violates the privacy rights of others;
- When a school administrator has reasonable suspicion, based on objective and articulable facts, that a student is using a mobile device in a manner that violates the law, the administrator may confiscate the device, which will only be returned to the student's parent or legal guardian;
- Students are responsible for mobile devices they bring to school. The district will not be responsible
  for loss, theft or destruction of devices brought onto school property or to school sponsored events;
- Students will comply with any additional rules developed by the school concerning the appropriate use of mobile devices or other electronic devices; and
- Students who violate this policy will be subject to disciplinary action.

#### Mobile Device Offenses

#### Initial Offenses:

Student is warned and reminded of the rules relative to each school level which may involve
confiscating the student's cell phone to be returned at the end of the class period or end of the
school day.

Repeated Offenses (after consistent reminders of the rules):

- The student's mobile device will be confiscated and returned to the student at the end of the day;
- Parents or guardians will be notified;
- A meeting may be held with the student and their parent/guardian to discuss a success plan if excessive offenses continue; and
- The district may administer appropriate interventions and student discipline.

#### REPORTING DIGITAL TRANSMISSION OF SEXUALLY EXPLICIT CONTENT VIOLATIONS

Any student, employee, parent, or guardian or third party who has knowledge of conduct in violation of this policy or any student who feels he or she has been a victim of sexting or other digital transmission of sexually explicit content, menacing, retaliation, or reprisal in violation of this policy will immediately report the concerns to:

• The building principal or designee;

- A teacher, who is responsible for notifying the building principal or designee immediately if the
  matter cannot be adequately addressed by the teacher or is deemed by the teacher to be sufficiently
  serious to warrant administrative intervention;
- A counselor, who is responsible for notifying the building principal or designee immediately if the
  matter cannot be adequately addressed by the teacher or is deemed by the teacher to be sufficiently
  serious to warrant administrative intervention; or
- The superintendent or designee.

#### **Investigating**

The principal or designee will be responsible for timely investigating a complaint made under this policy. The investigation, witness statements and evidence will be documented along with the outcome of the investigation.

In the course of the investigation, administrative staff will not send, receive or unnecessarily view or transmit sexting photographs or any other inappropriate images on either the districts or their personal telecommunication devices. The examination or viewing of the evidence/information will be limited to the extent necessary to determine that misconduct occurred.

### Parent or Guardian Notification

Parents or guardians of all students identified in the report will be notified of the investigation and informed of their student's involvement in the incident.

#### Discipline

The school district may administer discipline for students whose behavior violates this policy. Law enforcement may also be notified when conduct may violate criminal laws.

The district will make reasonable attempts to assist students and/or parents or guardians to resolve concerns and issues prior to the use of the formal criminal complaint process. Assistance may include consultation, counseling, education, mediation and/or other opportunities for problem-solving.

When administering discipline, the administrator will take into consideration the context of the events, all relevant circumstances, and the parties' prior behavior, the nature of the behavior and its potential harm and the emotional and/or physical harm resulting from the reported party's actions.

### DIGITAL TRANSMISSION OF SEXUALLY EXPLICIT CONTENT OFFENSES

#### First offense:

- Parents or guardians will be notified;
- The district will file an information report with the police by phone or in writing;
- The student's phone or electronic device will be confiscated, searched, and returned only to a parent or guardian, and

• The district may administer appropriate interventions and may take other actions as appropriate.

#### Second offense:

- Parents or guardians will be notified;
- Police may be notified;
- The student's phone or electronic device will be confiscated, searched, and returned only to a parent or guardian; and
- The district may administer appropriate interventions and may take other actions as appropriate.

#### Third offense:

- Parents or guardians will be notified;
- Policy may be notified;
- The student's phone or electronic device will be confiscated, searched, and returned only to a parent or guardian;
- The student may be ineligible to participate in extracurricular activities; and
- The district may administer appropriate interventions and may take other actions as appropriate.
