


Data Requests from Meeting 2 Regarding Capacity:

1.) What is the regional average for school capacity in SF Bay area?

- A survey of 22 schools indicates that capacity utilization is at 89%.

2.) Is there a legal requirement or recommendation for school capacity?

- The law approaches this question based on classroom load capacities and square feet per student. The assumption is that districts will place no more than the designated number of students in a single classroom and comply with the minimum square feet per pupil requirements. Otherwise, it is inferred that capacity will be maximized.
- There is no "recommended" capacity, just standards for compliance.
