### REGISTRATION & ANNUAL TUITION

#### RETURNING FAMILIES

“RETURNING STUDENT” is any student currently enrolled at any of our schools.

**RE-REGISTRATION FEE: \$200 (TK) \$300 (K-4<sup>TH</sup>) FEE WILL POST MARCH 1, 2025**

*\*an additional non-refundable \$50 testing fee is due at the time of testing for HCS Preschoolers entering TK or K*

#### RETURNING HCS FAMILY TUITION BENEFIT: LOCK IN THE LOWEST RATE!

We value our Heights Christian Schools families and are excited to offer you an exclusive benefit for the 2025/2026 school year!

As a current HCS family, you automatically secure the lowest tuition rate available for next year.

- **Your tuition will increase by only 3%\***—a minimal adjustment that ensures continued value for your investment.
  - \* The 3% increase will be calculated based on the equivalent of your current tuition rate **before any discounts**. For example, if you are currently receiving a 25% discount, your new rate will reflect a 3% increase on the full tuition amount prior to the discount.

This means you **enjoy significant savings** compared to rates for incoming families! **Thank you** for continuing to be a part of the HCS community. Your ongoing partnership allows us to invest in your child’s education and growth while keeping costs as low as possible. *Tuition Assistance will also still be available for families that qualify. A separate application is required.*

*Families not returning for 2025/2026 should submit an opt-out request by February 15, 2025. Opt-out details are available in your parent portal.*

#### NEW FAMILIES

“NEW STUDENT” is any student not currently enrolled at any of our preschools or elementary schools.

**REGISTRATION FEE: \$300 (TK) \$500 (K-4<sup>TH</sup>)**

*New Student Registration Fee includes application, testing and registration.*

- ◆ **MULTI-CHILD DISCOUNT:** Families with two or more children enrolled FULL-TIME at any HCS school will receive a multi-child discount of \$600 off the annual tuition for the second child. Families with three or more children will receive a \$1,200 annual discount for the third child, and each additional child beyond.

#### TECHNOLOGY FEE

- ◆ **TECHNOLOGY FEE: \$300 per school year.** The Technology Fee supports student devices, technical support, educational programs and software, and the infrastructure, and the Innovation Lab. **It is billed in two equal payments of \$150 each, September 1 and January 1,** for all K-8<sup>th</sup> grade students. ## REGISTRATION

- ◆ HCS follows a Continuous Enrollment model; all enrolled HCS families will be automatically enrolled each school year until the family opts out.
- ◆ Enrollment for new and returning students (who are in good standing) is on a first-come basis. If there is a waiting list for new students, being first on the waiting list is not a guarantee of next placement.
- ◆ All required documents and fees must be submitted to complete the enrollment process.

### New Students

- ◆ New Student Registration Fee includes application, testing fees, and registration (due at the time of application), that includes processing and building the admissions file, student testing, textbook usage, consumable supplies, office records, supplemental student accident insurance, standardized testing, and yearbook. All fees are non-refundable.
- ◆ New Student Registration Fees are non-refundable unless the student is not accepted by Heights Christian Schools for enrollment. However, if a new student is accepted but later withdraws, the Registration Fee remains non-refundable.

### Returning Students

- ◆ Re-Registration Fee includes textbook usage, consumable supplies, office records, supplemental student accident insurance, standardized testing, and yearbook.
- ◆ Re-Registration Fee is non-refundable for all returning students.

## TUITION ACCOUNT, FEES & PAYMENTS

- ◆ Heights Christian Schools partner with Finalsity to provide secure and convenient payment through Auto Pay.
- ◆ ***Auto Pay is required for all HCS family accounts. All tuition payments and incidental fees will be automatically drafted from the preferred payment method on the invoice due date.***
- ◆ Tuition is an annual fee based on the actual number of school days and does not include holidays or breaks. As a convenience, monthly payment options are offered. Monthly tuition fees are the same regardless of sick days, vacation days, holidays, or mandated temporary closures or periods of quarantine or isolation.
- ◆ Multi-child discount applies to families with two or more children enrolled FULL-TIME at any of our schools.
- ◆ No discounts other than those listed (on the reverse side) are available.
- ◆ When making a payment, the payment will first be applied to any outstanding balance on the account, and the remainder will then be applied to the current balance. Accounts with any outstanding balance will be assessed a late fee of \$25.
- ◆ Accounts that are not paid in full by the end of each month may result in the student being disenrolled. Report cards will be held until final payments are made.
- ◆ A service charge of \$30 will be assessed for each returned payment, such as an NSF check or NSF e-check. After two occurrences of returned payments, *only* cash, credit or money orders will be accepted for future payments.
- ◆ In the event of early withdrawal, tuition will be due through the last day of actual enrollment *plus* 10% of the annual tuition.
- ◆ Tardy policy is \$1 per minute per student for excessive tardies.
- ◆ The Technology Fee supports student devices, technical support, educational programs and software, and the infrastructure, and the Innovation Lab. **It is billed in two equal payments of \$150 each, September 1 and January 1**, for all K-8<sup>th</sup> grade students.

## DAY CARE

- ◆ Day Care programs for TK-8<sup>th</sup> second/additional children are discounted 50% when all siblings are enrolled in the same Day Care program.
- ◆ Payments for Day Care are due on the 1<sup>st</sup> of the month; late fees will apply.
- ◆ A fine of \$1 per minute per student is charged for students picked up after 6:00PM.
- ◆ Emergency use of Extended Day Care is \$5 per hour (or any part thereof) per student.
- ◆ Emergency use is limited to 5 uses per year. If emergency use exceeds 5 per year, then the monthly Extended Day Care rate will be applied to your account.
- ◆ Participation in Extended Day Care is a privilege. Violation of any of the conditions of school enrollment may result in a student being refused the use of the Extended Day Care program.

## HOLIDAY DAY CARE

- ◆ Holiday Day Care is available on Martin Luther King's Birthday, Veteran's Day, Teacher In-Service days, Teacher Conference days, Easter Break, Christmas Break (except December 25 through January 1, typically).
- ◆ Students enrolled in **Combined** Extended Day Care will receive Holiday Day Care at no extra charge, except for Easter Break and Christmas Break, which are an additional fee.
- ◆ The campus and school office are closed on the following holidays: Presidents' Day, Good Friday, Memorial Day, Labor Day, Thanksgiving (Thursday and Friday), Christmas Break (typically December 24 at noon through January 1). There is no Holiday Day Care available on these days.
