

News Release - Drug and Firearm Arrests 07/18/25

Summary:

A motor vehicle refusing to stop for a West Hartford Patrol Unit a week earlier was located on 07/18/25 in West Hartford. The occupants were arrested for amongst other things, drug and gun charges.


Details:

On 07/18/25 at 12:56 PM members of West Hartford Community Services Unit were alerted by the Town's Flock / Camera System of the presence of a vehicle parked near 450 New Park Avenue in West Hartford, which fled from another West Hartford Patrol Unit who attempted motor vehicle a week earlier.

Community Support Unit members conducted an investigative stop. In the course of the stop, the following items were located:

- One loaded 3D printed 9mm "ghost gun"
- One loaded .38 revolver
- 46 bags of fentanyl
- 2.1 grams of powder cocaine
- 5.7 grams of "crack" cocaine
- 3.2 ounces of marijuana
- US currency
