7. I/we fully understand and agree that, if I/we fraudulently allow the child(ren) named above to use my/our residence, I/we will have committed a disorderly persons offense. If I am/we are convicted of such an offense, I/we may be fined up to \$1,000.00 and/or be imprisoned for up to six months.
8. I/we fully understand and agree that any false statements contained in this affidavit may subject me/us to criminal prosecution for the crime of false swearing in violation of N.J.S.A. 2C:28-2. If I/we am/are convicted for such a crime, I/we may be punished by a fine of up to \$7,500.00 and/or be imprisoned for up to 18 months.
