We will move some of that funding to band uniforms. Two quotes were shown, and the board liked the lesser of the two for options. We will continue to leave the boiler budget as is, at this moment the second boiler is working great, however, we want to have a place holder if something were to happen to it later on down the line. The playground budget at this time is a place holder. There will need to be quite a bit of leg work done and bids before we make our final decision. The budget will be finalized in September.

9. Set teacher substitute pay (\$150/day for 1-10 days, and \$175/day for certified 11-20 days and \$210/day for certified starting the 21st day)
10. Set school board members' compensation (Last year \$150 for regular, special and any other ASBSD meetings or workshops and \$75 for committee meetings)
11. Set price of meals. Present-Breakfast-for grades K-12 or \$1.90 daily and \$1.25 Breakfast Seconds; Milk-\$0.35 for grades K-5; Lunch-\$2.85 daily for grades K-5 and \$3.10 daily for grades 6-12; Breakfast \$2.75 and Lunch \$5.25 daily for adults and \$1.50 cents for seconds
