From The Chairman....Mr. Cason VanDriel

These events were well attended, and it was very nice to see a large crowd of family and friends (representing a number of different communities) present at each of these events to witness the excitement!

Last week, a good sized group of juniors, seniors, chaperones and tour guides returned from the traditional DC trip, and by all accounts, it was a tremendous success, and greatly enjoyed by all! We are thankful that all could return safely without major accident or injury.

We also note at this time the departure of 2 of our dearly loved and appreciated teachers, Laetisia Kleyn and Jenny Tiemeyer. Tish and Jenny, we are so thankful for your years of service here at Cornerstone, and we wish you the Lord's continued Blessing in the coming years! Each of you has left an indelible impression on your students, and on our entire school community. We hope you will each keep in touch with us.

As you have already heard, the board received the disappointing news last week that our visa application for our new High School teacher, Mr. Edmund Nederveen was not selected for processing, which means he will not be able to come here to Lynden next year. (It's worth noting that this is not because there was anything wrong with our application, or with Mr. Nederveen..... there are a limited number of openings available for people to immigrate into the United States, and there are more than twice that number of people applying for those limited openings). While we were disappointed with this news, we also remember that we can place our hope and trust in the Lord, and we remain certain that he will show us a way forward. The Principal and board had already discussed possible options in the event our application didn't make it. Those plans are currently being explored further and we will inform the membership as our plans unfold more clearly. We ask for the Lord's continued guidance and blessing in this matter.

The board notes with gratitude that the membership approved the budget as proposed by the board at the spring membership meeting. As you can also read in the treasurer's report in this issue of the Link, the recently conducted pledge drive is almost completed, and it appears that we will be able to reach our pledge drive goal for the year. We express our thanks to the membership for their support and to the Lord for his great goodness to us in granting us the necessary resources to continue the operation of the school.

Finally, the Education Committee has been working on an updated discipline policy that will be put into place next year. It was approved at the last school board meeting. There was some debate about whether to introduce this to the membership formally or simply to include it in the updated parent handbook. We decided to include it in the chairman's note before the beginning of the next school year so that all can be familiar with it. We expect and hope that this circumstance is never required, but in the event it is, at least there should be no surprises!

There are 5 basic behaviors that would usually necessitate discipline from the principal (and not from the teacher). These would be:

- 1. Disrespect shown to a staff member or volunteer
- 2. Dishonesty including lying, cheating and stealing
- 3. Rebellion i.e. disobedience in response to instructions
- 4. Fighting striking in anger with the intention to harm the other student
- 5. Obscene, vulgar or profane language

In conclusion, we thank the Lord for His gracious blessing on us as a school society and community, and pray for His continued blessing in the coming months!

Short Reports of the Board..... Short Report for May 12, 2014

The chairman opened the meeting by welcoming all present, and then read from Proverbs 6 before leading in prayer. The minutes from the meeting of April 14, 2014 with the principal were adopted without changes. The minutes from the Membership Meeting from April 29, 2014 were then reviewed, and adopted after one change. As incoming mail, the secretary read aloud a letter from the Ladies Aid regarding a donation. A thank-you letter was agreed to be written. The proposed agenda was reviewed and adopted.

The principal shared his latest report with the board. He touched briefly on several recent positive events held at the school, and then the board discussed important matters from the report: a behavioral consequence outline is in the works for the elementary grades, and the Education Committee has agreed to draft it. The board reviewed a letter from the CCRTC outlining a new certificate program that they are going to be offering. Also reviewed was some monitoring software for the classroom, and the possibility of offering Home Economics again for 2014-15. It was agreed to offer the course. The chairman thanked the principal for all his work at the school.

The Education Committee chairman reviewed the minutes from their last meeting. He touched on some software and English research. An update on online courses was given. The Ed Com is currently looking into online offerings for psychology, computer programming, and accounting. The Parent Information Evening scheduled for April 13th, 2014 was discussed. Recent senior project presentations were reviewed, and it was reported that the Ed Com was impressed with the work of the students. The board also discussed shop/technical offerings, noting that there is a real interest in some students for taking more hands-on courses. It was agreed that this is an issue that the Ed Com and board need to remember.

T. Faber touched on the highlights from the CBM's recent work and meetings: spring cleaning was a huge success. The new sound system is slated to be installed this summer, but inquiries will be made to see if it can be secured before graduation on June 12. Other items discussed included the progress on contact with IDC (for summer building rental), and a sign for the gravel drive to Badger Rd. Also discussed was the aggressive behavior of the bull in the new property. The board agreed to contact the farmer to remove the bull.

The board discussed options for filling the remaining part-time teaching void. The board and principal reviewed financial impacts and course scheduling. It was agreed to fill the void with a part time teacher.

Outstanding action items were reviewed, and J. Doornbos presented a proposed new substitute teacher policy. The board approved the policy.

The next regular board meeting was set for Monday, June 9, 2014 at 7:30 in the school building. The principal was thanked for his time and participation, and was wished strength for the rest of the school year.

The minutes from the second part of the meeting of April 14, 2014 were adopted without changes. The agenda was adopted after adding one item.

The treasurer shared his latest report with the board. He reviewed the tuition & dues report, profit & loss statement, and the latest from the Finance Committee. The board briefly discussed the FC's idea of purchasing a home and renovating and reselling. Such an idea would be funded privately. Also discussed were future potential uses for the new property. The treasurer let the board know that every member's yearend financial statement will be out by the end of May. Updates were shared on a metal recycling idea, and progress on the golf tournament.

The board discussed recruiting new Society members, and reviewed outstanding action items.

C. VanDriel led in prayer to close the meeting.



Short Report for June 9, 2014

The chairman opened the board meeting by reading from Proverbs 7 and leading in prayer. The minutes from the May 12, 2014 board meeting with the principal were approved with no changes. As incoming mail, the board received a "Non-Potable Water and Fire Flow Agreement" that was recently agreed upon between the American Reformed Church and CCS, a signed lease agreement between CCS and Inspire Development Centers, and a letter from a member family. The proposed agenda was reviewed and was adopted as published.

The principal then reviewed his latest report. He shared a new discipline policy to be put in place for next year. Intended to be an in-house policy, it will give the teachers general guidelines for behavior that will necessitate discipline. The board agreed that the chairman would share this via the LINK sometime before the 2014-15 school year. The board also discussed the purchase of LanSchool software (classroom management and monitoring software), and the possible future purchase of Online Management System software; the benefits of the latter being more streamlined processes for the staff and administration. The board and principal also discussed some particulars of online courses, and the date of the next Big Picture Meeting. The date for the meeting was tentatively set for September 22, 2014, at 7:30 PM in the school building.

The Education Committee chairman reviewed the latest news from his committee. He shared that an upcoming parent information evening has been scheduled for Tuesday, November 25th, 2014, in which Hans VanDooren will be speaking.

The CBM and IT Committee chairman then touched on some items including the removal of the bull in the adjacent farmer's field, the new sound system, and the current state of the building in regard to getting ready for the IDC's summer rental. On the IT side of things, a new backup copier has been purchased, and the board agreed to permanently reduce the size of the IT committee by one after a member resigned.

The board and principal discussed further general matters. Of note were a preliminary discussion of a "plan B" in the event that Edmund Nederveen's visa was not approved, and preparation for the graduation ceremonies. Past action items were reviewed, decisions recorded, and the next regular meeting was set for August 11, at 7:30 PM in the school building (no scheduled July meeting). The principal was thanked for his efforts in the school, and his time at the meeting. The principal thanked the board for their work, and their support of him. It was noted that this was the last meeting of the school year, and the end of the principal's first full year in his new role. Everyone present reflected on the success of the past year in these regards, and how the Lord's hand was evident.

After a five minute break, the board returned. The minutes from the second part of the meeting of May 12, 2014 were approved without changes. The agenda was adopted after adding a Golf Committee update under the Treasurer's Report.

The treasurer shared items from his latest report. Discussion points included the state of the 2013/14 operating pledge drive and property pledges (74% and 82% collected, respectively), dues and tuition, the balance sheet and profit & loss statement, and the size of the Finance Committee. He also touched on the state of the current pledge drive, and the board agreed that the pledge amount thus far was substantial and much to be thankful for.

An update on the golf tournament was given by T. Faber. West Coast Homes has been found willing to again be the main sponsor. Corporate sponsors are coming along well. High school students will be approached and tutored to help with the event as in years past.

The Staff and Membership administrator then brought up a few subjects including gifts for departing staff members and the outlook for staff health coverage for the upcoming year. The board discussed options regarding health care offerings.

E. Brown led in prayer to close the meeting.







From The Treasurer......Mr. John Doornbos

Summer break is here and summer itself is officially here. Staff, students, volunteers, committee members and even the board will have a reprieve of sorts while the school is shut down for the next ten weeks. It is well deserved for sure and we have much to be thankful for as we reflect back on the 2013/14 school year, especially financially.

In the last Link the report highlighted how far ahead of budget we were tracking. At the end of July we'll have official numbers and we expect that final year-end report to confirm the trend we were seeing this spring. At November's membership meeting we will report on this in detail.

One of the items in the budget that was approved for the 2014/15 year was an Operating Pledge goal of \$80,000. This reflected about a 10% increase over what was pledged the prior year. Since the spring membership meeting the board has been diligently contacting each member to solicit a contribution to the pledge drive. Thankfully we can state that this task, although not the highlight of our board roles, generally receives a positive reception and results in a strong participation. This year again we can report that although this task is not complete it looks like we will achieve the goal approved by the membership.


One thing that was discussed amongst the board members was the wide range of participation from members, especially the younger families. It is very encouraging for us to see how many families recognize the value of reformed education by, among other things, contributing to this pledge drive even if it is only a small amount. The amount doesn't matter as much as simply being willing to share the financial load. Conversely it is discouraging when families, without much apparent thought, promptly decline to contribute anything to this drive. Clearly there are cases where the extra money is just not there, it can even be a burden for these families to make the tuition payment. However, in other cases one cannot help but wonder if perhaps the financial priorities are mixed up. The true cost per family of operating the school is \$13,500 annually or about \$1125 per month. Quick math tells you that no family's tuition actually covers the real cost of educating their children; all of us should feel some responsibility to making sure we do what we can to help share this load. The board is not dictating where in the list of household expenses funding the school should fall but hopefully we would all be prepared to go without some non-essential items before we expected someone else to carry our financial burden for something as valuable as reformed education.

Another item worth updating everyone on is the Endowment Fund. Over the past year this account has grown modestly to over \$12,000. The goal of this fund is to collect enough money in it so that the interest from it is meaningful enough that it can help fund the costs to operate the school. We don't expect this fund to grow too quickly; yet we want to keep it front and center on the minds of those who are creating a last will and testament so that they can include this fund as one place for their assets to go when their earthly journey ends.

Finally, earlier this month, another payment was made on the property purchase. This leaves \$90,000 outstanding. Much of that has already come in but please don't forget to complete those pledges by the agreed upon deadline of December of this year.

Congratulations to all for completing the 2013/2014 school year. God has richly blessed our school, and we thank Him for that. Kudos especially to the hard working principal! You have completed your first year in this new role, and have excelled! Thanks for the passion you have shown for the education of our covenant children.

In the past months, the Education Committee has continued to work on things like high school course selections (including online options), report card changes, and parent evenings. We were also privileged to take part in the senior projects. What an amazing experience to be a part of!

As we come to the end of another school year, we can reflect on the wonderful blessings that we could receive through another successful year! Thanks to all who helped throughout the year with upkeep and maintenance of our school facility.

The CBM will be installing a sign on the gravel driveway, that will read "<u>Do Not Enter - Driveway for Emergency Use Only</u>". To save on yearly maintenance cost and efforts to maintain the driveway, we are asking everyone to <u>please</u> use the dedicated asphalt access thru the church parking lot. Technically the driveway, according to our easement and school permit, is to be used for emergency use only. So technically... this driveway may only be used if the church parking lot is not accessible. Using the dedicated intersection at Northwood Road will be much safer. (especially at night) Thank you for your cooperation!

You may have noticed that the Inspire Development Center has begun to move into thenorth half of the building. LanSchool......Mr. Darryn Kleyn

If you have children in fifth through twelfth grade, you may have heard that the school recently acquired a piece of software for the school laptops called LanSchool. LanSchool classroom monitoring software gives teachers the ability to, on the teacher's computer screen, see in small thumbnail views what is up on all their students' screens. The software also allows teachers to blank students' screens to get their attention, or even take control of their screens to resolve a specific problem. This solution is about more than eliminating distractions, though. It's about encouraging students to take interest in the subject matter and engaging them with the lessons. It's very much like the teacher standing over the shoulder of a student who's using pencil and paper and monitoring his work and progress.

There are some other features that our teachers are excited about including:

- 1. The ability to share something to every monitor and demonstrate important skills
- 2. Restricting access to certain websites during classroom instruction

3. Generating quizzes so students can take them right on the computer and receive immediate feedback

At a recent education committee meeting a discussion was had around the idea of making this software mandatory on all our computers, including computers brought in from home. The education committee was impressed with the features of this software and saw wisdom in teachers having the ability to hold our youth accountable also during their computer usage. A recommendation was brought to the board which was adopted for inclusion in the parent handbook for next year.

The policy reads as follows:

- Students that wish to use a computer or tablet from home for use in the school will be required to have LanSchool installed on their computer by the school's IT personnel. Parents will be levied a charge of \$20 per computer to cover the cost of this software. This is a one-off cost for the life of the computer.
- When students are on their computers they must be logged onto the school network at all times.

While this new policy might not be something every student will be enamored with at first, we hope they will soon understand and appreciate the benefit this program offers them. Our computer age offers some powerful temptations, including innumerable time-wasting distractions and all-too easily available explicit imagery, so what a blessing it is that they have teachers both willing and now equipped to hold them accountable for what they do and where they travel on their computer during formal lessons and study halls. It should be noted that this software only monitors students while they are on the school network.
