Just recently we heard that Mr. Houweling's visa was approved by the US consulate in Perth, so it looks like we won't have visa worries on our minds this summer! We are also thankful to be in good shape due to many returning staff members, some of whom will be taking on extra duties next year.

The willingness of so many to commit financial resources to make up the proposed budget deficit for the next school year, in order to help keep tuition costs down, is also a matter for thanks. At the time this is being written, our fundraising drive is off to a good start, but we have not yet attained the goal. If you have not already done so, please consider prayerfully whether you are able to give to that cause. On a somewhat related note, the land purchase the Society has been pursuing has closed, and we are now the owners of the additional parcel of land to the south of the school property.

May the Lord grant refreshment and a safe and enjoyable time of summer vacation to staff, students, parents, and volunteers! May we also use these times of vacation to reflect on the wondrous works God has done as creator and redeemer. All praise and honor to him!



Short Reports of the Board.....

Short Report from meeting held on May 6, 2013

J. Bareman called the meeting to order, read from Psalm 14, and led in prayer. The minutes from the meeting of April 22nd, 2013 with principal were approved after one addition. Matters from the previous meeting minutes were reviewed by the board, and the status of items were noted. Incoming mail included a report from the Teachers College Board of Governors meeting, and an information document covering IRA accounts from Edward Jones. Both items were tabled for later discussion. The agenda for the first part of the meeting with the principal was adopted.

The board discussed items from the latest principal's report. The principal briefed the board on a proposal to add a new column on report cards for students' tardy arrivals. After discussion, the board agreed to implement the suggested change. A discussion was had regarding the current status of the teaching vacancy for Geography 9/10. The board decided to task the Education Committee to continue to explore options for filling this role. Other items on the principal's report were the photocopier and classroom allocation for 2013-14. In regards to the photocopier, it was noted that our current machine is having many problems. The board decided to task the IT Committee with finding a solution. The board reviewed the staff's proposal for classroom changes for the next year. After discussion, it was decided to move forward with the proposal, which includes moving the library to the mezzanine. It was also decided to inform the ARC Kindergarten board that their request for a room be granted.

B. Lodder informed the board that the Education Committee's next meeting had not yet occurred, and therefore there was nothing new to report, noting only that senior project reviews are currently underway.

T. Faber updated the board on CBM developments. He shared that the spring cleanup was a success and very well-attended. Other items of note were an update on a rooftop A/C unit for the attic server room, and the reviewing of gym rental rates.

The board briefly discussed the IT impacts of S. Houweling's Fine Arts initiative, including the possible purchase of new IT equipment.

J. Doornbos updated the board on the most recent school visit conducted by himself and J. Dykstra. Overall, the report was very positive, and J. Doornbos reflected on how much we have to be thankful for with Cornerstone.

The board reviewed Debby Lodder's report from the Teacher's College Board of Governors meeting. Noting D. Lodder's eventual desire to pass the baton to a new representative, the board discussed options for a replacement for her, and it was agreed that a call for a new rep would come in the next LINK.

The next regular meeting was scheduled for Monday June 3, 2013 at the school building, and O. Bouwman and D. Kleyn were thanked for their time and left the meeting.

The minutes from the meeting of April 8th without the principal were approved without changes, as were the minutes from April 22nd meeting. The minutes from the membership meeting with the school society of April 29th were reviewed and were approved after two changes were made.

Matters from the minutes of previous meetings were reviewed by the board, including reflections on the membership meeting, an update on the forthcoming retirement plan (tabled for later in the meeting), and use for the newly purchased land (tabled for the next meeting).

The proposed agenda was adopted after adding two HR items: professional development and staff health care costs; the board briefly had discussions on these two items.

Concerning financial matters, J. Doornbos updated the board on a few details concerning the upcoming open house for potential URC enrollees. The board also reviewed the current list of outstanding tuition dues, and some still-outstanding operating pledges from 2012-13. The board then reviewed the proposed number for the upcoming operating fundraising target, and agreed to start the process of asking for pledges before the next meeting. J. Doornbos updated the board on developments concerning the upcoming Golf Tournament, noting that the contact with corporations is under way and going well, and that the target for revenue is \$10k greater than last year.

T. Faber updated the board on some details of Cornerstone's new land.

Concerning health care options, J. Doornbos informed the board that he has formally solicited rates from different providers and plans, and is awaiting the results. Also shared was an update on the upcoming retirement plan offering.

J. Doornbos led in prayer and the meeting was closed.

Short Report from meeting held on June 3, 2013

The chairman J. Bareman called the meeting to order, read from Psalm 15, and led in prayer. The minutes from the meeting of May 6, 2013 with the principal were approved after making two changes. Minutes from a special meeting of the board, held May 24, 2013, to deal with a matter of student discipline, were approved without changes. Matters from the previous minutes were looked over by the board and noted as underway or finished.

As incoming mail, a letter was received from the Reformed Bible College outlining its offerings and availability for staff. The board agreed to file it as information, with the desire that the Principal keep it in mind as an option for Reformed professional development. A letter was received from a member concerning a matter from the spring membership meeting, as well as a letter from another member outlining a staff proposal. The last item of incoming mail was a signed contract from a staff member.

The agenda for the first part of the meeting with the principal was adopted after adding an item for review of the recently transpired URC Information Evening.

The board spent time on items from the latest principal's report that were relevant for discussion including a student discipline case, high school staffing for next year, and the workload of the new principal. Also raised was the matter of lending out band instruments to the membership. It was decided that at the discretion of the principal, instruments may be lent out so long as some type of tracking system is put in place to prohibit instrument damage or loss.

- B. Lodder updated the board regarding the latest Ed Comm meeting. The committee has been reviewing the senior projects, and he noted the high quality of all the projects. O. Bouwman spoke on IOWA test findings, and explained some of CCS's results.
- T. Faber updated the board on the latest CBM developments, including exterior painting, air conditioning for the attic, gym rental rates, and the library move happening on June 18.
- T. Faber updated the board on IT Committee highlights, including a goal to install five desktop computers, obtaining quotes from TD Curran and CDW for iPad Minis (Fine Arts), the photocopier, the Nimbus cloud software, and the need for A/V projectors.

The board discussed several general matters including two letters from the membership, feedback from the recent meeting with URC families, and the pending changes in staff health care.

The next regular meeting was scheduled for Monday July 1, 2013 at the school building. It was also agreed to start scheduling regular Big Picture Meetings in the fall.

O. Bouwman and D. Kleyn were thanked for their time and left the meeting at 9:45 PM. Noting the significance of this meeting in that it was O. Bouwman's last, the board members expressed gratitude for his many years of service and dedication, and words of encouragement and thanks were shared.

The minutes of the board meeting of May 6, 2013 without the principal were approved without changes, and all matters from the previous meeting were reported as completed. The agenda for the remainder of the meeting was adopted.

The board discussed several financial matters, including the pledge drive for 2013-14's deficit reduction, a matter raised by a member regarding tuition, different options for health care, and the current status of tuition and dues. J. Bareman also informed the rest of the board that the purchase of the new property has closed, and that the payment schedule has been pushed back six months due to the delayed closing. T. Faber updated the board regarding property usage. In order to add the additional property to the school's tax free designation, the school would have to make use of the property for school-related purposes. It was noted that more research is needed before settling on what will be done with the property for now.

E. Brown led in prayer and the meeting was closed.

From the Treasurer......Mr. John Doornbos

Summer break is here and summer itself is officially here. Staff, students, volunteers, committee members and even the board will have a reprieve of sorts while the school is shut down for the next ten weeks. It is well deserved for sure and we have much to be thankful for as we reflect back on the 2012/13 school year, especially financially.

The most notable item of the past school year was the decision by the board and membership to pursue purchase of the adjoining four acres of land. We are confident that this purchase, while financially significant today, will be something we look back on in future, as a very prudent move. We have positioned ourselves nicely regardless of when, and even if or how, we use this land. The acquisition process culminated recently (these past few weeks) when we made the first installment and received the signed documentation. The purchase will continue to impact the membership as we work to collect the pledges and make the next three payments over the following eighteen months. Many of us will be writing checks on hard earned money, money that has many competing suitors, as we honor our pledges long after the initial decisions were made. The board is very appreciative of how enthusiastically the school and church community embraced this decision, made their pledges, and wrote their checks. Thank you for your part in making this process so painless!

One implication of this purchase was that these pledged dollars eroded away some of the money that might have otherwise been pledged for the 2013/14 operating pledge drive. The board anticipated this and budgeted for less money from this operating pledge drive. We are still in the midst of making our calls for the operating pledges and, while we can see that money is tighter this year, we are still hopeful that we will receive enough pledges to cover the budgeted amount of \$65,000. So, if you have not yet made a pledge, please connect with a board member and do so --- remember that even a small amount makes a difference.

The board is still actively working through various health coverage options for and with the staff. As you might remember this was a significant expenditure for next year's budget. Changes in the law, due to the Affordable Care Act, are part of what is driving a change. More importantly, however, we as board have made a conscious and principled decision to make providing benefits, to our valued staff, a priority. Ensuring that our full-time staff does not have to worry about their medical coverage is an important 'peace-of-mind' which we want to provide them. Although we have not made a final determination of what this will look like, it appears as if we will be able to meet this goal. Either way, a change in benefits can be a hard thing for anyone to deal with, so we are very thankful for the good conversations that we could have with the staff as we search out a solution.

In May, all of you should have received a statement of accounts from the board. We intend to make this an annual practice in order to inform you of where you stand in regards to tuition, dues and pledges you've met. This method has proved of benefit already, as in some cases, members were unaware of missing payments or, accounting errors on our part were discovered and corrected. No major discrepancies were found through this exercise --- this is another testament to the great work done by our bookkeeper, Marcia Faber. Recording everything properly is quite a challenge when the income and expenses top \$600,000 and you only have a few hours a week to dedicate to it!

The Finance Committee continues to be active, although now most of our work is being done at the subcommittee level. The Golf Tournament is in the midst of collecting its corporate sponsors and getting everything organized for the event on September 21st. The Soccer Carnival committee has met and is working towards hosting our first ever event this fall. The Auction committee has also begun meeting and has made good progress towards its event planned for this winter. Once the new school year is in session, I'm confident that the various committees will begin sending out communications. Finally, the Ladies Aid representative on the Finance Committee reported some excellent success with some of its events. Not only were events like the Garage Sale and Plant Sale successful, they brought in considerably more revenue than past years. Excellent work Ladies! Although the Finance Committee only plays a 'supportive role' here we laud any efforts made that bring more outside money into the school thus reducing the burdens elsewhere.

Finally, it would be remiss of me not to use my column for an opportunity to thank Mr. Bouwman for all that he has done for our school also particularly pertaining to finances. I am confident that I can say not only for myself, but also for Treasurers gone by, that we have been blessed by how he administered the finances put into his trust. He was always very stewardly and judicious with the dollars he requested during budgeting, as well as when spending what was allocated. Although easily overlooked, this is also a critical part of how we've been able to meet and exceed our budget goals each year. Again, thank you Mr. Bouwman for all that you've done, in so many ways, to help keep the school running smoothly this past eleven years!

So the question you could ask yourself while working on a project is: "How is this helping me to be more Christ-like in my work for God?" A deep concept, but worth spending time thinking about. And worth praying about. Make all things know to God in prayer, and He will guard our hearts and minds. Made God bless and guide your steps as you live out your life in a Christ-like manner for His honor and glory.

Our Homes

Recently, someone encouraged me to read through some works published by Thomas Manton, who was a contemporary of Oliver Cromwell, and who made significant contributions to the Reformed faith in 17th century England. Fantastic material! He does an excellent job of pointing out the vital importance of the family unit. In his "Introduction to the Westminster Confession of Faith," he argues that "A family is the seminary of Church and State; and if children be not well principled there, all miscarrieth: a fault in the first concoction is not mended in the second; if youth be bred ill in the family, they prove ill in Church and Commonwealth; there is the first making or marring, and the presage of their future lives to be thence taken."

Since the family has such a critical role to play in both church and state, we do well to place a very high regard for the work that parents are to do in our families. Interestingly, it isn't just Christians who understand the centrality of family life. As Manton explains, even Satan understands the importance of the family: "Now, the devil knoweth that this is a blow at the root, and a ready way to prevent the succession of Churches: if he can subvert families, other societies and communities will not long flourish and subsist with any power and vigor; for there is the stock from whence they are supplied both for the present and future."

If indeed the family is the foundational building block of both church and state (and it is!!), then here in Lynden we need to do everything we possibly can to see to it that we fathers seriously fulfill our God-given responsibilities towards our children. We fathers also need to recognize the mothers: they are truly the unsung heroes who need our support and encouragement every step of the way. Education starts in the home, and needs to continue in the home. Please never expect a school – regardless how good it is – to fill in the holes created in a weak home. Parents, while enjoying the relationships God gives with your children, hold each of them to the high standard that God places on each of his covenant children. Expect and demand – while fully acknowledging that compliance is entirely God's grace – that your children profess and display love and respect for God as well as for their fellow man. As Manton wrote in another of his works: "If, therefore, there be any spark in you of love to God, be not content that any of yours should be ignorant of him whom you so much admire, or any haters of him whom you so much love. If there be any compassion to the souls of them who are under your care, if any regard of your being found faithful in the day of Christ, if any respect to future generations, labour to sow these seeds of knowledge, which may grow up in after-times."

May God help each of us to contribute positively to a godly atmosphere in our homes; it's in our homes that our children are primarily shaped.
