

The great reformer Jean Calvin had as motto "My heart I offer to you, O Lord, promptly and sincerely." The motto reflects the whole hearted devotion and service that our great God requires: "You shall love the Lord your God with all your heart...". It is the "other half "of that famous response of our Lord Jesus to the trap of the Pharisees regarding paying the Roman head tax (Mark 12), "(render) to God the things that are God's". Rev. W. Bredenhof writes, in a sermon about this text, "... What does God have a right to? The answer to that could be a sermon in itself! We could think of our worship. We could think of our trust. We could think of our love. God has a right to all these things. But here we should think especially in terms of image-bearing. The coin bears the image of Caesar, therefore it belongs to him. ... here in this passage, the focus is on image-bearing. What bears God's

image? God created people in his image. We are that which belongs to God. We are what should be offered back to God. He has a right to us and to our love and obedience." (www.theseed.info) How much more is this true for the children God has entrusted to us! When it comes down to it, the "option" of sending our children to the government schools, where the education fails to recognize God or acknowledge his works, is not much of an option at all. Render to God what is God's! What a privilege it is that we can be involved in this work of providing education for the covenant youth in a manner that is consistent with the Word and the confessions to which we hold that are rooted in the Great Reformation!

Looking ahead to November, please make note of the fall meeting Cornerstone Christian School Society will be held, D.V., on Tuesday, November 19, at 8:00 in the basement of the American Reformed Church building. Please mark the date on your calendar and plan to attend. The main purpose of the meeting will be to review finances for the prior year, and to elect two new board members (one for a new position). Short Reports of the Board..... Short Report from September 9, 2013

J. Bareman called the meeting to order, read from Psalm 17, and led in prayer. The minutes from the meeting of August 15, 2013 with the principal were approved after making two corrections. Matters from the previous meeting's minutes were looked over by the board, and action items were either marked as completed or forthcoming. A signed contract was noted as incoming mail, and the agenda was adopted after adding two items.

The principal shared highlights from his latest report, and noted that the beginning of the school year has been going smoothly. The new staff members are integrating well and adjusting.

D. Kleyn brought up an idea originating from the Ed Comm of having a parent information evening added on to the Society membership meeting. After some discussion, the board decided to reassess this idea as the meeting date approaches.

The board briefly touched on the upcoming school sleepover event for grades 1 - 8.

The board discussed the possibility of creating a facebook page for the school. Some concerns were shared that our website efforts could be diluted with a facebook account, and the importance of maintenance if it were implemented. The principal agreed to review the possibility further with the administrative staff.

- In B. Lodder's absence, D. Kleyn touched on Ed Comm developments. J. Bareman inquired about the results of the Saxon Math report from last year, and D. Kleyn reported that he has met with all math teachers and shared his methods on how best to work with the program, and that more meetings are forthcoming.
- T. Faber updated the board on items related to the building, including painting projects, the emergency contacts, a possible agreement with the church regarding the water tank and hydrant, and possible names to fill the CBM vacancy.
- T. Faber talked about IT developments, which included the installation of five new computers, and the replacement of a faulty iPad.

The board discussed the challenge of sustainable high school staffing, noting that only two teachers are currently bearing the load. This has been identified as an important challenge for the next school year. With the issue on everyone's minds, it was agreed to discuss it at the next Big Picture meeting scheduled for September 30, 2013.

The board discussed the possibility of expanding the size of the board, noting new responsibilities with HR matters, a concentration of committee duties, a growing society, and a larger staff than years prior. The board decided to expand its size by one, requiring the election of two people: one new member and a replacement for J. Bareman. The board encourages input from the membership on this matter. We welcome the suggestion of names of those suitable to serve the school in this capacity.

The board discussed the results of the URC information evening. As an outcome of the Finance Committee, several items were identified as ideas to attract more URC members. One such item, the possibility of adding Kindergarten as an official offering of Cornerstone, was briefly discussed. Further discussion was tabled for a future Big Picture Meeting.

The Big Picture Meeting was set for September 30, 2013 at 7:30 PM in the school building, and the next regular meeting was set for October 14, 2013 at 7:30 PM in the school building.

D. Kleyn was thanked for his time and left the meeting.

The minutes from the second half of the August 15, 2013 meeting were approved as written. All action items from the previous minutes were reviewed and noted as completed, and the agenda for the second half of the meeting was adopted as published.

The board reviewed several financial matters, including last year's final figures, the current tuition and dues report, and the status of the current land purchase payment. It was noted that the next payment is due in December, and that we have collected enough to make the payment. Also discussed were some highlights from the most recent Finance Committee meeting, including open house scheduling, fundraising, a new committee member, and the upcoming golf tournament and auction/dinner.

J. Doornbos led in prayer and the meeting was closed.

Short Report - Big Picture Meeting - September 30, 2013

J. Bareman called the meeting to order, read from Psalm 14, and led in prayer. The meeting's agenda was adopted.

The board discussed a proposed job description for the principal position. After some deliberation, the board decided to task a subcommittee to work harmonizing the job description with the duties of the principal outlined in the current handbook.

The board watched a brief video presentation on SWOT analysis (Strengths, Weaknesses, Opportunities, and Threats) to get a feel for how to use such an analysis to examine our high school efforts. After reviewing a sample SWOT analysis spreadsheet, the board looked worked on filling it out for the Cornerstone high school. The results of the SWOT exercise will continue to be items of attention for both the board and Ed Comm.

The board spent some time discussing possible space expansion options, as well as the current situation of having the library in the gym mezzanine. The principal and CBM liaison were tasked with assessing upcoming space needs based on enrollment projections and upcoming course offerings.

D. Kleyn led in prayer and the meeting was closed.







Short Report from October 14, 2013

Chairman J. Bareman called the meeting to order, read from Psalm 18, and then led the board in prayer. The minutes from the regular meeting of September 9, 2013 with the principal were approved. The minutes from the Big Picture Meeting of September 30, 2013 were approved after making two changes. Matters from the minutes were reviewed, and updates were given on past action items. As incoming mail, a request for a new teacher's college representative was received from the CCRTC. The proposed meeting agenda was adopted without changes.

The principal reviewed the major items from his report with the board. He very much enjoyed the principal's conference in Ontario, and gleaned valuable information there. As far as the student body, D. Kleyn reported that all is going well. He also shared some feedback regarding some of the school's recent special events, including the past sleepover, Rev. VanSpronsen's visit, and the planning for the upcoming Christmas program. He reported that teacher and staff development is going well, and shared some highlights from the recent professional development day held on October 10, 2013. The principal then touched on some updates regarding IT and facilities.

- B. Lodder gave an update on the latest Education Committee developments. The new typing program has been successfully deployed. Investigation of potential future online course use is something that is on the radar for the Ed Comm to tackle. D. Kleyn shared that the staff has been involved in some "Lean" exercises on a monthly basis, and that Brad Kuik has been sharing his expertise in this area with the school staff.
- T. Faber reviewed the latest CBM report with the board. Items of note were cost-sharing of the pump/tank with the church, and estimated property taxes for the new land.
- T. Faber then shared updates on recent IT-related matters, and brought the board up to speed on both new and relocated equipment.
- B. Lodder reported on his recent school visit with Ed Comm member Karla Leyenhorst. He reported that the visit went very well, that there were no areas of concern.

The board discussed the nomination of new directors. The board will select suitable persons for this purpose, but also encourages the membership to suggest names suitable to stand for election. Two positions will be filled: one to replace outgoing director J. Barman, and one to fill an added spot.

The board briefly discussed future high school staffing needs. Full-time vs. part-time teaching positions were weighed, and it was agreed that it would be advantageous to start to maintain a list of potential candidates, in order to start conversations with them as needed.

The next regular meeting was scheduled for November 4, 2013 at 7:30 PM in the school building, and the annual meeting with the Society was tentatively set for November 19th, 2013 at 8:00 PM in the American Reformed Church building.

D. Kleyn was thanked for his time and left the meeting at 10:08 PM

The minutes from the meeting without the principal of September 9, 2013 were approved as written, and the agenda for the second half of the meeting was adopted.

The board spent some time discussing financial matters including appointing auditors to review the books, and a preliminary look at last year's financials for the upcoming annual meeting.

The board discussed recent ideas regarding methods on expanding the membership base, and the responsibilities of doing so.

Items to be covered at the annual meeting were reviewed including financials, voting for new directors, and a Compensation Committee update.

Regarding the recent golf tournament, J. Doornbos shared that this year's event raised approximately \$40,000, which is \$6-\$7k more than last year. For the time and effort the junior and senior class donated to help with this event, the board approved payment of an amount recommended by the tournament committee to their trip fund.

- J. Doornbos shared with the rest of the board some recent work done by the Compensation Committee.
- T. Faber led in prayer and the meeting was closed.

From the Treasurer......Mr. John Doornbos

With the school year off to an excellent start we can once again reflect upon our many blessings. More details will be given at next month's membership meeting but, in sum, we can say that our financial situation continues to be very healthy. Generally speaking, tuition is being paid on time, pledges are being honored, and expenses are being managed stewardly.

One regrettable item is that our budget tuition numbers will likely be down from what we budgeted for the year. This is because a couple of families, whom we had expected to send children to CCS this year, did not follow through after all. However, we are confident that we can make this up with a growth in non-traditional income... fundraising.

The Finance Committee's Activities will take up the majority of this report as there is not much to report on from the Treasurer's desk and because the Finance Committee is in the midst of various activities that involve most of our time.

Two changes to the makeup of the committee should be brought to your attention. First we had to say a regretful 'goodbye' to two people, namely Brad Kuik and Lydia Faber. Brad left for a higher calling but even in his

short time on the committee we could definitely appreciate his presence and wisdom. Much to our chagrin, Lydia's term on the Ladies Aid has ended. We'll miss her enthusiasm for fundraising, her tireless work, and broad community connections. The good news is that Janice Demooy now brightens our evening meetings, filling Lydia's shoes. We're happy to have her can-do attitude as part of our team. To replace Brad the board has approved the appointment of Dave Hofford to the committee and he in turn has graciously accepted! A big welcome to both Dave and Janice!









This year, beyond what the CCS Ladies Aid will do, the Finance Committee is organizing/has organized four different revenue generating events. The first two have already been completed, namely the Soccer Carnival and the Golf Tournament. The Soccer Carnival was a big success in a number of ways. First and foremost we witnessed how splendidly the committee, led by Liana Faber, put together a wonderful array of different activities for the attendees to experience. From the bouncy castles, to various challenge games for varying ages, through to food and beverage offerings, everything was well organized and much appreciated. At the height of its activity it was very enjoyable to sit back and see how many people participated and how they were having a good time.

Another item of note was how well the committee had done in recruiting young people to help in managing the events. I dare say that never before have we seen such a large contribution of volunteer time and enthusiasm from our young people for the school's benefit. Thank you! Similar to the first time we had a Golf Tournament, the hope was that for the first year the event would be successful logistically speaking first and financially speaking second. In fact we were hoping that this event would be a break even event the first year so that we could build on it in year two and turn a profit. However, the final result showed a profit well beyond expectation! In conjunction with this event a big THANK YOU! also needs to go to the CCS Scrip committee which donated the seed money necessary to get this event off the ground. Ultimately the cooperation between these groups, their successful efforts in putting on a first class event, and the subsequent profit is much appreciated by the board and the school community! Word has it that the committee is keen to stick together to do a rerun on this next year...

The Golf Tournament was also another big success. Thank you to Ryan Vandelft and the rest of the committee who built upon prior years successes to increase this year's profits to a staggering \$40,000! This is an increase of about \$6000 on last year's results. Good weather, superior planning, and hard work by the committee, high school DC Trip Team, and volunteers were what facilitated this continued success. In spite of this continued growth the committee still identified several other simple ways in which they could improve future events and profits. Note that of this profit, \$4000 was shared with the DC Trip Team who did their part collecting prizes from the community, putting up signage, and various event-day activities.

Two additional events are being organized for later this school year. One smaller one that we're planning for in early December is a first annual CCS Invitational Basketball Tournament. Darryn, Bernice, and Janice are working to get an eight team tournament together for the first weekend in December. We expect most of the teams to come out of Canada. Planning for this event appears to be on schedule. The second event will be larger... perhaps as large as the golf tournament (no pressure ©)... this event will be a Dinner/Auction evening. It will have a theme, a first-class dinner hosted by the Ladies Aid, various forms of Live Entertainment and three variations of an Auction... online, silent, and live. The basic way it will work is that there will be seats for about 200 people but rather than sell individual tickets the plan is to having people purchase a table for a donation (amount TBD) and then invite three other couples to join them... ideally, couples not from CCS, so that many of the auction items can be purchased by people not part of CCS. Our hope is that we can have each CCS family submit at least one item with a minimum value of \$100 to the auction. Further details will follow as the event nears but it promises to be something not to be missed.

Another financial topic that has the board attention this year is staff compensation. This spring the board constituted a subcommittee of three parents and two board members to review the thorny issue of staff compensation. Being that we're an 'odd-ball' school means we have had at least some perceived challenges at

making sure we compensated our staff fairly. By 'odd-ball' I mean that we're not funded by a government in any way plus we're not geographically located in an area near other schools where a cooperative compensation plan makes sense. So, for the most part, the board has hiring and paying staff with one eye on the budget (what we can afford) and the other eye on how can we get a quality teacher for a fair wage. All in all that tends to be guite the juggling act and when teachers as a profession are used to some kind of a salary grid then it can be quite difficult at times to accept independently negotiated contracts. So, knowing how important our staff is and how critical it is to the success of the school that we hire and retain a high quality staff, the board put this group together with the hope that it could propose a solution that would accomplish the elusive goals of transparency, fairness, and affordability. Most of the first several months of subcommittee work was focused on researching all aspects of how other school systems manage all aspects of compensation; this included Lynden Christian, Lynden Public, Fraser Valley, Alberta, Ontario and Australian school systems. Most recently, once all the research was complete, one of the parents was charged with the task of composing the first draft of what could eventually be a salary grid for CCS. This has been reviewed, discussed and tweaked and preliminarily shared with the whole board. At the time of writing this report we still had work to do as we have scheduled time to get staff input via Mr. Kleyn, and based on his input put a final recommendation before the board. Our goal is to have the entire process complete in advance of the membership meeting so that we could present a final draft (Cliff Notes Version) to you all. Timing might not allow this to happen as hoped but if not, we intend to at least have it completed in advance of when we meet with staff to discuss their plans for next year.

My apologies for the lengthy report! See it as evidence of how much good activity is going on in CCS.

Since our last update our painting party has come and gone. I must say, the school looks brand new again! We can thankfully report that we had an excellent turnout and were able to completely finish painting & staining the exterior of the building. If we were to have had this done by a professional, we estimated the cost of this work would have been somewhere between \$8,000 and \$10,000. (Nearly equal to the amount of the entire CBM maintenance budget for the year!) By the many volunteer hours and one Saturday's worth of work this

amount of money was saved. We would like to thank everyone who participated in this event! From the organizers, the painters, and those who provided coffee and lunch, well done everyone!





















We recently had a bit of a surprise in the main bathrooms, as puddles began to form in the toilet rooms. It turns out the septic system was backing up. The septic tanks were promptly emptied and thankfully everything returned to normal. We will be updating our regular maintenance schedule to be cleaning septic system filters and monitoring septic tank levels more frequently, so this does not happen again.

Some of you have noticed that the gym rental rates have increased, i.e. for evening basketball, soccer and volleyball. When the rates were first set (for association members), we did not have ongoing maintenance costs and we basically set the fees at cost to pay for the utilities during the use. Now that the gym is 5 plus years old we are beginning to incur regular maintenance and upkeep costs associated with its use. In an effort to minimize our budget impacts for these costs, the CBM has proposed these rate increases. We did comparative investigation for evening gym rental in the community, and found that the new rates are still well below the cost of renting similar facilities in the community for these types of uses. A fee increase is not meant to discourage anyone from using the facility, it is our hope that you will continue to enjoy the use of the facility. If you have any questions or concerns please let us know.

I'd like to take a moment to thank Al Sytsma for his years of service on the CBM. Al has retired from the CBM and Ryan VanDelft has agreed to take his place on the committee. Welcome aboard Ryan! We must also take a moment to commend the cleaning crews... I mentioned earlier that the outside of the building now looks brand new, but thru your diligent efforts, you also keep the inside of the school looking as good as the day we moved in! Thank you all and keep up the good work!

Time Away

When you spend time away from home and community - you often get an opportunity to stand back and reflect on what you 'have' back home. It can be a good reality check or reminder of the blessings of the Lord, received in your own school and church community.

Recently I had the privilege of attending the International Conference of Reformed Education in Ontario, Canada. The keynote speeches and workshops were thought-provoking and the interaction with fellow brothers and sisters in different lands, contexts and communities was invaluable.

As teachers, we experience on a daily basis that we work alongside a community of believers (parents) who really do care about Reformed Education. Our children may come to a school where the Word of Christ is central in the curriculum, in classroom practice and in our daily walk of life. This is not to say that we have arrived, can rest on our laurels or be satisfied with our behaviors. However, working alongside you as parents and community, with such vibrant volunteer support, is exciting, invigorating and motivating for a Reformed teacher. We really do feel that our mission statement is alive in the school; we have the support "to assist parents in educating the children of the covenant as a part of their preparation for a life of Christ-centered service and stewardship in the kingdom and Church of God."

Please continue to support the work of the school, putting your shoulder to the wheel in whatever way you can, and remember that, as staff, we really do feel your support in so many tangible ways and we appreciate it! Continue to keep the communication pathways open between home and school!

Covenant Children

At the Reformed Education conference the focus was on the covenant child. Professor Van Vliet from the Canadian Reformed Theological Seminary presented a paper entitled: So, who's *really* sitting in front of you. In his presentation he reminded us that the identity of our children is God-given. Their identity doesn't come from their peers, from their community or from family but from God himself. Flowing from this God-given identity are four 'truths' which are worth remembering and thinking about. Firstly, in the ups and downs of life our children's identity is <u>stable</u>. God is steadfast, reliable and never changes. We can instruct our children in this truth - to give them comfort; God's children can rely totally on an all-faithful Father in Heaven who cares for us. Secondly, covenant children know that they <u>belong</u>. Students want to feel that they belong; the covenant shows them the way. In Jesus Christ, they "belong with body and soul, both in life and death, to their faithful Savior..." (Lords Day 1). Thirdly, in covenant, redemptive history supersedes chronology. Chronology is a way we can identify a child – through their past and present experiences and performance. However, our children have to be reminded that they are part of a much bigger plan; they too are part of the redemptive history brought about in Jesus Christ. Fourthly, within the covenant, our children have an obligation to be motivated. God zealously applies himself to us. He comes to us with glorious promises and our children are obligated to respond in thankfulness to this knowledge – also in their work.

I appreciated these reminders as this is also reflected in one of our school's Vision and Educational Goals. Our school seeks to:

Provide education that: recognizes the position of our children as members of the covenant and communion of saints; strives to make a place for all of those children; utilizes the community's talents and resources; and is in harmony with what is taught in the home and Church.

This goal is further explained in our Parent Handbook as follows:

A key motivator for establishing a school arises from the covenant God has established with us and our children. Parents have a responsibility to ensure that the education their children receive fully embraces the doctrinal instruction they are called to provide for their children. Our children are set apart by God to be His own possession in the world He created and upholds. The education our children receive should reflect this reality – and should provide the necessary skills for students to serve God in all areas of their lives.

Please use this as an opportunity to remind your children again – that being a part of God's covenant is a wonderful reality that gives them direction, focus and motivation for their work at school.

The high school students can expect their first quarter report cards this week. They have been busy writing tests and completing some final assignments to wrap up the first quarter.
